

Police Inspection.

The members of the Police Force, with the exception of Sergeant McGonnell, who is off duty owing to illness, were inspected by His Honor the Stipendiary Magistrate this forenoon. There were present in the Courtroom, where the inspection was held, Messrs. S. W. Crabbe, W. A. Weeks, Geo. E. Full and Donald Farquharson, (the Executive Committee of the Temperance Alliance) and representatives of THE EXAMINER and Patriot. After the men had been drawn up in line, and some information had been obtained as to the state of their winter wardrobes, His Honor proceeded with his charge, of which the following is a summary:—

Officers, I now propose addressing you more particularly in the matter of your duty in Scott Act prosecutions. I have been told that you are not doing your duty in these cases as well as you should or could. It is not for me just now to say how much truth there is in these statements. The fact, however, remains that there are still several unexecuted warrants against persons charged with violation of the Scott Act, which have been in your possession for some considerable time. I would like to know why such is the case. The fact of these warrants not being executed is not at all creditable to your intelligence. You are very prompt and careful about the executing of warrants against persons guilty of an infraction of any other criminal law; and I cannot understand why there should be any cause for complaint concerning your conduct in Scott Act cases. Another ground of complaint is that you do not lay information against violators of the Scott Act. But only some eight or nine informations have been laid by you since the year came in. Now we are to have the Scott Act for the next three years at least, and it must be enforced. I do not wish to be harsh with you, but I must let you know right here and now, in the presence of these gentlemen, that I will not keep any man on the force who will not do his very best to enforce every criminal law on the statutes. The Scott Act must be properly enforced by the police of this city. It is said you have a strong feeling in the matter of laying informations under the Scott Act. You do not care to do so. Why you should draw the line between prosecuting violators of the Scott Act and violators of any other criminal law I do not understand. We want trained men to enforce the Scott Act, and you men as a result of long service on the force and a consequent knowledge of places and men not possessed by others, should be just the men to enforce this law. I cannot expect that assistance from new men which you can give. I do not know whether Mr. Henderson gets any information from you or not; he tells me he gets some. I know it is now going to be more difficult to enforce the Scott Act in the future than in the past. Those who are now engaged in the illicit selling of liquors have been driven to the wall and will leave no stone unturned to evade and defy the law. Now I want you to use your knowledge of back doors, dens, etc., to the fullest extent, so that we may be enabled the better to enforce the Act. If you do not do this I must get some policemen who will do it. There is the case of the girl who lives opposite the police station, upon whom you cannot serve a summons. I cannot understand why men, who have been on the force so long as the most of you have, should not be possessed of sufficient detective ability to serve a summons upon a girl who lives at your very door. I expect, in fact, insist, upon your taking the Scott Act and attending to its enforcement with the same zeal you display in the matter of the infringement of other criminal laws. I, as head of the force, am held responsible for your actions, and am going to see that you do your work efficiently and well. Since the beginning of 1886 we have had great number of warrants out, and the police have done very well; but as I before remarked some few are still out which have not been served. The whole matter of it is the law becomes a farce if after final judgment the warrant is not executed. If, after conviction, warrants of arrest cannot be executed, your usefulness and mine also is gone. Now, you are on trial for the next three years, beginning work over again, so to speak. We shall see what you can do. With your past experience you should be able to do much. I have complained to the Marshal that he does not give me information about the police. His neglect in this matter will sooner or later lead to his dismissal. He will not let me know the goings on among the police. He will not tell me about the drunkenness among the members of the force. People outside inform me that the policemen go to places where liquor is illicitly sold, and are often, while on duty, under the influence of liquor. Now, to get at the bottom of this matter, I propose asking you individually if such is the case. I will commence with the Marshal.
