Elizabeth and Philip shook hands with the United States' first family.

Then cabinet members and their wives and British Commonwealth diplomats and their wives came up to be presented to the Princess.

The American women shook hands with her; the Commonwealth wives curtisied. Elizabeth and the President then went to a rostrum for the official welcome.

Princess Makes Speech

In a voice calm and firm, Elizabeth told the President and the millions more watching and listening by television and radio that Britain and Canada will "work with all our strength for freedom and for peace."

"Free men everywhere," she said, "look towards the United States with affection and with hope. The message that has gone out from this great capital city has brought help, and courage to a troubled world."

Elizabeth read her remarks. Truman had a speech all prepared, and then didn't use it. In general, he said about what he had written down, but he added the homey touch that to know Elizabeth was to love her.

Truman said he wished Elizabeth would tour clear across the U. S., as she did across Canada. "I am sure," he said, "that would make our good relations and our strong friendship with the British people even better than they are now."

The petite Princess in a dark red suit, black hat and black accessories, seemed to hit it off with the President immediately. They chatted cheerfully as they walked together reviewing the troops. Philip, in his naval uniform, tagged along behind.

And when they got into the open car to come into town, they continued their animated conversation. Philip rode in another car with Mrs. Truman and Margaret.

This was about the first chance the common people had to see the royal visitors. (The space at the airport had been almost entirely taken up by assorted dignitaries). The cheers rolled out as the Princess and the President rode by.

Many in the crowd were British and Canadian air force officers. They snapped to attention. Here and there in the crowd little Union Jacks were waved.

More Than Half-Million

The crowd estimate of 530,000 was made by Maj. Robert Barrett of the metropolitan police. Many in the crowd were women—they outnumbered the men three to one by this reporter's estimate.

In his official greeting to Elizabeth, Truman spoke not only as a President; he spoke also as the proud father of a girl about Elizabeth's age.

"When my daughter Margaret visited England last summer," he said, "she was greeted most hospitably by the Royal Family, and by the British people."

"She had a fine time. 'I hope you will have as nice a time here with us, and when you leave you will like us even better than when you came.'"

In her reply to Truman, the Princess said she realizes it is not possible to understand a country merely by visiting its capital. "But so much of the history of the United States has been enacted here," she said, "and so many memorials to your national

achievements stand here that I hope, before I leave, to see a little deeper into the sources of your enormous strength."

Refers To King George

Truman also had some cheering words for Elizabeth's father, the King, who is recovering from an operation.

"I am sure," the President said, "the whole American people join with me in wishing for him a complete and speedy recovery."

The Princess and the Duke will stay—with the Trumans—at Blair House during their 45-hour visit. Tonight's busy schedule included a meeting with the press at a special reception at the Hotel Statler, and a formal dinner with the Trumans.

Others at the dinner were the Canadian Ambassador and Mrs. Hume Wrong, the British Ambassador and Lady Franks, Chief Justice and Mrs. Fred M. Vinson, the acting secretary of state and Mrs. James E. Webb, and three senators and their wives, Senator and Mrs. Theodore Green (Dem., R. I.), Senator and Mrs. Brian McMahon (Dem. Conn.), and Senator and Mrs. H. Alexander Smith (Rep. N. J.).

There's a reason why the list was so small. That is about all the small Blair House dining room will hold.

At the reception given by the Washington press corps, the Princess said the Royal Family and all Britain were deeply moved by the sympathy and affection shown by the press and people of the United States during the King's illness.

The Princess expressed the hope that she and her husband would return "before too long" to make a tour of the United States.
