HOW THE CAMPAIGN GOES.

The candidature of our friends in the country has been distinctly promoted by the selection of Owen and Fitzgerald in the city. The vexation and dismay of the Government workers are finding expression in the use of such words as "liar," "slanderer," "hypocrite," "scoundrel."

Advices received from the most respectable sources are of the most cheerful nature. The Liberal-Conservatives are working together unitedly and harmoniously; while, in many cases, the grists are at sixes and sevens. In the First District of Prince County the disturbance is likely to result in an addition of two supporters to the Opposition.

In the Second District, the name of Mr. James Yeo has been confidently connected with the Opposition candidature. We hear that Mr. Yeo has been convinced that he can carry the district, and he is, it will be admitted, a good judge in the matter. But the Grists say that he will not run, that he has no following, and if he should run he will be easily defeated by "the Governor."

Mr. Yeo should be deterred by such talk, this district will, of course, go to the Grists, as heretofore. But we hear that the good old stand-bearers, Arsenault and McDonald, are assured of victory in the third district and that Bentley and McCabe have excellent reasons for believing that the people of the fourth district will elect them triumphantly.

In Summerside the weakness of the Government party was never more apparent, Mr. McNutt has been cheated out of the nomination in the third district, compelled to relinquish the office of Returning Officer, and finally rejected by the Grists of Summerside. It is now the grist candidate with Hon. Mr. McMillan. It is needless to say that this young man will add strength to the canvass of the Land Commissioner.

On the other hand, a number of the Government's former supporters, disgusted with the ineffectual logrolling in respect to Mr. McNutt, and the bootless attempts to put first Mr. McNutt and then Mr. John Gaffney—two strong partisans—in the position which rightfully belongs to High Sheriff Stroug, will vote for Rogers and DeRoche, whose former supporters are solid in their favor.

All over Queen's and King's Counties the fight for a change of the mortgage disfranchisement-gerrymander-daslawyer government goes bravely on. Our correspondents affirm that the Opposition candidates are gaining ground in spite of the effort which is being made by the Government to obtain the floating vote by means of money borrowed from the banks to be repaid out of the pockets of the taxpayers. Dr. Jenkins' candidature in the second district came as a surprise and a serious discomfiture to the Hon. Donald Farquharson who has now, like the Premier himself, to fight hard for his political life. Rumor says that the price of kittens has lately gone up in these districts. Messrs. Morsen and Kickham are making a splendid fight against booting in the first district of King's; Sullivan and Underlay in the second; McDonald and Shaw in the third; Clow and McLeod in the fourth; Hon. D. Gordon and A. J. McDonald in the fifth—all are working harmoniously and energetically. In spite of the gerrymander, the Liberal-Conservatives believe that the banner County of Kings will return as many representatives as ever to oppose the Organized Hypocrisy.

MR. DAVIES DID NOT DO IT. Mr. L. H. DAVIES had a golden opportunity on Tuesday evening, in the Market Hall, for he had before him a large audience composed of both Liberals and Conservatives—and no one to reply! Mr. Davies has been openly charged with being a party to the conspiracy to deprive 's Dominion officials of their franchise. He had the opportunity on Tuesday evening to deny the charge and repudiate the action of Mr. Antoczar Peters. But he did not do it. He found time to abuse Senator Ferguson and THE EXAMINER. He found time to add three years to the period the grists had been out of power. He found time to deny THE EXAMINER'S statement of opinion as to the rate per day he was paid in the political prosecution against Mr. A. C. Shaw, but he declined to state what he did receive, although the information was within his knowledge. He found time to attempt to deceive the public regarding the bank account, and time to relieve himself of many gross exaggerations. But he had not time to say one word in repudiation of the disfranchisement of the Dominion officials! He had the opportunity, and he intentionally missed it. There is but one inference to be drawn! The officials and their friends and sympathizers will remember it when the time comes.

A CHESTNUT. The large number of Conservative and independent electors who attended the grand Liberal rally Tuesday evening in response to Secretary Matthew Allen's advertisement to hear "the true version," and "some important statements interesting to all," were in common with the rank and file of the Grists very much disappointed. In the words of yesterday morning's Guardian "they came away disappointed." "The expected important statements were not made." Mr. L. E. Prowse, by way of introduction, told the old joke about the woman who had gone into the store to purchase brown velvet, and had been told by the clerk that he had none but he had some black velvet which she might imagine was brown. This chestnut was received by the "boys" with applause and cat cries. But it was only at the close of the meeting that the people "took in" the true inwardness of Mr. Prowse's joke and its application. "The people had come for important statements but Prowse and Rogers had none to give. Their supporters must imagine they had received them, as the woman was asked to imagine that black velvet was brown."

PRICE OF DEBENTURES.

We note that J. C. McIntosh, broker, of Halifax, quotes New Brunswick 4 per cent. debentures at 99 and P. E. Island debentures at 97. The latter are the debentures which Mr. Peters sold at 96!

WHO IS TRUTHFUL JAMES?

THE Patriot on Tuesday stated that the meeting at Mount Herbert was 5 to 1 in favor of the Government. Mr. William Welsh, M. P., was present at Mount Herbert, and Tuesday evening at the Market Hall stated that it was 2 to 1 in favor of the Government candidates which is telling the truth—the Patriot or Mr. Welsh? Mount Herbert is known as a grist place; but the truth is the meeting was about evenly divided.

MR. DAVIES OFF TO MORELL.

MR. L. H. DAVIES was last evening summoned to Morell to help the factory prospects of Mr. Arthur Peters. He does not agree with the Hon. Daniel Davies and all other right-thinking Liberals, that one Peters is quite enough to be in the councils of the country. Hence he must respond to Mr. Arthur Peters' call for relief, and start to his assistance. Our advice from the St. Peter's District are to the effect that the younger member of the Peters family is not in the fight, and that the people of St. Peter's do not desire his political services.

A CORRECTION.

WERE we disposed to use the rough language so freely employed by Mr. L. H. Davies on Tuesday, we should say that Mr. Rogers' "lied" when he stated that the late Government owed the banks at the time they left office \$171,000 and were paying interest thereon at the rate of 6 per cent. We prefer the remark that Mr. Rogers was under a misapprehension or that he spoke without knowledge. The amount owing to the banks when the McLeod Administration resigned—according to a statement of the signature of Mr. Arthur Newbery—was about \$55,000.

We readily excuse Mr. Rogers. All men are liable to make mistakes of this kind. We have corrected a good many such for Mr. L. H. Davies, and never called him a "liar" or said that he "deliberately lied."

UNITED STATES TARIFF.

THE tariff bill which has been reported to the House of Representatives, is calculated to lower prices, promote foreign commerce and add to the revenue. The bill puts wool, coal, lumber, salt and iron on the free list and reduces the tariff on sugar from one-half to one-quarter cent per pound. It also provides for the extermination of the bounty by degrees. As a rule the tariff has been made lower upon the cheaper goods of necessary use, and left highest upon the more expensive articles. The wool schedule will perhaps attract most attention. No higher duty is proposed than forty-five per cent. on manufactures of wool, and that only on ready-made garments, the average being less than 40 per cent. A cheap quality of blankets and flannels are only taxed 25 per cent, and lower grades of carpet only 20. There is to be also applied a gradual reduction of the woolen schedule, so that at the end of five years the highest duty will be 40 and the average nearly 30 per cent. Very a few articles have been made in the cotton schedule. Iron ore is on the free list. A large cut has been made all along the metal schedule, the duty on steel rails being reduced more than 50 per cent. Free lumber will be of great benefit to the people of the prairie states, and free salt will give to those who need salt for their cattle or for curing meat, the same advantage which has been secured heretofore by means of a rebate to those who cured fish. Agricultural implements have been placed on the free list in order to enable the farmers to better compete in foreign markets and because many of the agricultural implements are being sold abroad cheaper than at home.

In the House of Representatives the bill will pass without a doubt; but it has to run the gauntlet of the Senate.

POLITICAL MEETING AT SOURIS.

A large and representative meeting was held at Souris last night. The Grists took advantage of having their Returning Officer, D. McInnes, appointed to the office, and Mr. McPhee was made Secretary. The Conservatives had their own way with the meeting, and everything was in their favor. The meeting is considered to have been one of the strongest Conservative meetings ever held in the District. The great surprise of the meeting was when the Hon. J. R. McLean made an attempt to defend the acts of the Peters Government. He failed in every effort to uphold the actions of his Government, and his attempt to excuse his own department made the sensation of the hour. When charged with the Morell Bridge contract and many other such shady transactions he had nothing to say. Mr. Morsen distinguished himself by carrying everything before him. He showed himself to be an able and fluent speaker. He made it pretty plain to the electors that the Peters Government was the most extravagant, tyrannical and corrupt government that ever held power in this Province. He nailed his opponents on every point, and was loudly cheered. His election is more than assured. Mr. Robertson, who next spoke, was asked to give an account of the \$806 dollars that Peters and Kickham failed to give an account of in the statement for the sale of debentures. But on this point he had no answer to give, nor did he make any attempt to explain the matter. Mr. John Kickham made a very practical speech, and showed his opponents how strong he was on his points. He was able to make some telling shots and he received a grand welcome from the farmers of the district. Mr. Currie's nice little speech was most unexpectantly rubbed out by John McLean, M. P., who followed him. No comment is necessary. Mr. McLean was at his best. He exposed the feeble attempts made to defend the Peters Government, and left not a shred of Mr. Currie's speech to be remembered.

CARDIGAN BRIDGE MEETING

A Large Attendance—Good Debating.

Notwithstanding the very wet night, the new hall at Cardigan Bridge was filled with a highly intelligent audience on Tuesday night, to hear the political questions of the day discussed by the candidates for Cardigan District and others.

W. P. Lewis, Esq., was appointed chairman and the undersigned secretary. Hon. Mr. Gordon was called by the chairman to address the meeting, and delivered a polished and effective speech on the local political issues now before the people. He showed that during the last three years measures had been forced through the House of Assembly that the people did not ask for, and would condemn. Never in his long experience as a legislator had such scenes been enacted during the session of 1891, when the Government locked the doors of parliament, and by the aid of a majority of one vote, changed the constitution of the province. He also pointed out the gerrymandering of King's County, disfranchising an intelligent body of electors and taken from the young men of the province the privilege they enjoyed of polling two votes for the representatives that controlled the finances of the country. This he considered one of the gravest acts of tyranny ever perpetrated in the legislature of a British colony, and the men who were responsible for doing so should be met with severe condemnation from every elector who had the spirit of British fair play in him. Great as were the financial questions to be discussed at the present time, yet even more important was the question of preserving the rights and liberties of the people. The principle "once a voter always a voter" had been violated by the Peters Government, and he believed that the province would not approve of their acts.

Hon. Thomas Kickham spoke on behalf of the Government and apologized for his inability to discuss the questions of the day with Mr. Shaw, who he said was one of the ablest debaters in King's County, if not the best in the Island. He said that the decreasing revenue of the Province prevented the people having the same number of representatives as formerly, and contended that no injustice had been done to the young men. He referred to the actions of the late Government and thereby justified the actions of the present administration. He charged the late Government with making false promises to the people, and warned the electors against believing those who were trying to pull the wool over their eyes. The Government received no help, and drew from capital; but the roads and bridges were neglected. The present Government were condemned for spending money on public works, but the people got more benefit from this than from what they did from the consolidation of the laws that cost \$10,000 or \$12,000 under the late Government. He contended that the redistribution of King's County was supported by the Opposition, who admitted that Georgetown district had over representation. Referring to the \$806 unaccounted for in the sale of debentures, he said he never received one dollar on that account, but even if Mr. Peters and himself had been paid that sum, it would be no more than about 1 per cent. on the transaction. He thought they had as much right to get paid as Mr. Ferguson, who had been paid for delegations to England and Ottawa. He claimed credit for amalgamating the two branches of the Legislature, whereby \$6000 a year would be saved; and pointed out that he had secured the charge for the property-holders. He asked the electors to vote for his colleague and himself, because they supported the Government.

Mr. Shaw followed Mr. Kickham, and for about an hour and a half held the undivided attention of the audience in a vigorous attack on the Peters administration. As his principal points were similar to those made at the Dundas meeting, it is unnecessary to repeat them.

Mal. McDonald, Esq., spoke briefly in support of the Government, ending by saying that he would support no party that would legislate against the interests of the farmers.

James E. Macdonald, Esq., pointed out that the financial situation of the Province was one of grave importance, and that the Government should devise means to reduce revenue and expenditure, or as to put an end to the deficits that were adding to the debt of the country. From the reckless manner in which money was being spent, he thought it was necessary to elect a Government that would be the best men to do the job. He thought Messrs. Mal. Macdonald and Kickham would be the best men to elect. Mr. J. G. Scrimgeour was called on to speak, but declined to do so. Mr. Arold, J. Macdonald spoke in favor of the Opposition, and made an excellent address, showing how the Government had misgoverned the Province since their advent to power. Mr. Sigsworth, of Cardigan, spoke for the Government, and was followed by Mr. Geo. E. Goff, who delivered a carefully considered arraignment of the Peters Government, especially referring to the fact that the Sheriff had been bound to appoint only supporters of the Government to take the votes of electors. This, said Mr. Goff, shows that they can have little confidence in either the sheriff or the electors. He believed the majority of the people would vote against the Government. Mr. Elijah McKay defied the contract for the Morell floating bridge and made a very fair attempt to defend the Government.

Mr. Gordon and Macdonald both related some serious matters which Mr. Sigsworth, and showed that his statements were incorrect. On motion of Mr. Michael Flynn, of St. Peter's Road, Lot 53, second ward, by Mr. Alfred Gordon, of Roseneath, Cyrus Shaw, Esq., was proposed as Liberal-Conservative candidate for the Assembly.

On motion of Mr. Michael Bolden, of Glenfanning, seconded by Mr. Donald McLeod, of Lake Valley, James E. Macdonald, Esq., was proposed as a candidate for the property holders. Both nominations were enthusiastically supported. Mr. Jas. D. Dewar, seconded by Mr. Daniel Sigsworth, proposed Mr. Kickham and Mal. McDonald as candidates in the Government interest. This nomination was put to the meeting and supported by the Liberals present. A vote of thanks was given the chairman, and the largest meeting ever held in Cardigan dispersed. Geo. F. Ows, Secretary. RAILWAY ACCIDENT IN ITALY

Several Passengers Burned to Death. ROME, Nov. 30. News has reached here of a railroad accident at Melzo, Lombardy, twelve miles northeast of Milan. An express from Milan for Venice, and a train laden with inflammable material collided just outside Melzo. The wreckage was set on fire by lights on the train. One of the seven cars which caught fire was filled with emigrants from Venice, bound for America. Many of the emigrants were injured, and several burned to death. Throughout the night, men and women, half clothed, wandered in a dense fog and sought shelter near the scene of the collision. They were found at daylight lying exhausted and mangled in a pile of debris. Details as to the exact number killed and wounded are still lacking. It is thought that over 30 deaths will result.

SHATFORD DIVORCE CASE.

Another Sensation for St. John. ST. JOHN, Nov. 30. The Shatford divorce case bids fair to be a sensational one. Shatford is allowing himself to be interviewed freely, and his brother in Chicago is talking to papers there. A despatch from the west says that Shatford proposes to show that his wife is seeking divorce from him that she may marry a bank official here who was her lover before her marriage. Mrs. Shatford says nothing, but it is hinted that her advisers and disinterested have been pretty busy, and that matters will be offered in evidence touching Shatford's proceedings in other matters than domestic life.

NEWS NOTES.

The German government will establish an entrenched camp near Malmedy, which is held to be a menace to Belgium. The cholera in Russia is less violent. The official statistics show that from May to September, 1892, there were throughout the empire 433,643 cases of the disease and 215,157 deaths, and from January to November, 1893, 147,647 cases and 30,284 deaths. In a parliamentary debate on the speech from the throne, Premier Tricoupe said recently that Greece is no longer in a position to fulfill financial engagements with foreign powers. She is anxious to make an honorable compromise with her creditors, and would offer such terms as the state of the country would permit. In the Paris deputies a few days ago, ex-Minister Goblet began an onslaught on the government, hoping to oust Minister Dupuy in his own favor. Great disorder resulted, and after the sitting the ministry, with the exception of M. M. Peytral Viette and Terrier, resigned. The Piedmont Gazette, supposed to be Premier Giolitti's newspaper organ, says that Giolitti has recently returned to Monza because of a desire for a convention between Italy and Austria-Hungary to anticipate the exigency of the war between either country and Russia. In the event of such an outbreak, says the Gazette, Austria-Hungary will expect Italy to send at least one army corps to Galicia to help the Austrians beat back the Russian invaders. Sir C. H. Tupper is considering the report of the commissioners appointed to investigate the complaints touching the salmon fishery regulations of British Columbia. He expects in a few days to have the result of the enquiry put in the shape of draft regulations, which will be sent to the members for British Columbia and to the Board of Trade to ascertain the views of the parties interested before making the final recommendation to His Excellency's council.
