Makes Smart Little Car For His Son

—4-year-old Dale Cannon, Summerside, has a smart little electric-driven automobile made by his father, Mr. Edgar Cannon, master mechanic with Curran and Briggs, Ltd. He built the car during the winter evenings. It took about three months.

The car is extremely well built and is strong enough to carry a 600 pound load. It is electrical-ly driven from a storage battery. It has a modified Ford electric starter with reversing mechanism. The drive is to both rear wheels by means of a belt, sprockets and chain. The speed is about that of a brisk walk. It has electric lights, a foot brake, an adjustable seat, forward and reverse shift lever.

The car is built of 18 gauge steel body with double frame of one inch steel angle. It weighs about 175 pounds and has a total length of 48 inches with a wheel base of 31 inches.
