TRIED TO KILL HIMSELF.—Randolph Scholz, 25 years old, a homeless man, disgusted with an unpropitious world, tried to commit suicide by jumping into a strong eddy in the East River, at the foot of Eighty-ninth street, New York, shortly after midnight on Sunday. Whether it was the alcoholic gas that filled his body, or the antagonism of the river spirits, he couldn't sink, although he kicked and struggled to do so. Then he became disgusted with the river, pulled himself ashore, and rushed off to the Eighty-eighth police station where he complained against the unfair treatment he experienced on the land and in the water, and was locked up for trying to kill him self.

DESTROYED BY FIRE.—We regret to learn from the Summerside Journal that the dwelling house of Mr. Patrick Whelan, at Freetown, was destroyed by fire last Thursday morning. The house was burned to ashes, very little, if anything, being saved from it. In fact Mr. Whelan had a hard time to get his children out of the burning building. The neighbors gathered as soon as possible after the fire was discovered, and by their efforts saved the other buildings. The loss on Mr. Whelan's house is estimated at from \$600 to \$700, with, it is said, some insurance on the building. The accident is supposed to have originated from the kitchen stove, in which there was some fire when the family retired.

SPECIAL DESPATCHES TO THE EXAMINER. Ottawa Notes.

OTTAWA July 9. The revenue for the fiscal year just closed was \$38,843,000, expenditure \$30,939,000, surplus \$7,904,000. Further expenditures will reduce this surplus, but the amount at the disposal of the Government will be larger than the Budget estimated. It will probably reach \$3,500,000.

The Post Office department will hereafter pay depositors by cheque, payable at all the chartered banks in Canada.

Middleton has written his valedictory to the militiamen of Canada.

Col. Chater, of the Argyll Highlanders, who has just travelled over the Canadian Pacific, is in ecstasies about the route as a military highway.

Mr. Anderson, engineer of the Marine Department, left to-day to inspect the light houses in the Gulf and Belle Isle with Captain Smith.

The Disastrous Cyclone.

LEWISTON, July 9. Specials to the Lewiston Journal, from Somerset, Waldo, Oxford and Franklin Counties indicate that last evening's cyclone was one of the most disastrous that ever visited Maine. Sandy River Railroad Bridge, near Phillips', was blown from the abutments into the river. The bridge at North Anson was twisted so as to make it unsafe for trains. In various parts of Maine nearly 100 barns were blown down or unroofed.

Strike of Shoemakers.

BEVERLY, Mass., July 9. All lasters employed at Master's & Walker's shoe factory here quit work yesterday. The firm has been a third grade factory and the lasters claim that goods of the second grade were introduced with no advance in price. A new price list with an advance was declined by the firm. The men were ordered out by the Lasters Protective Union.

The Newfoundland Trouble.

LONDON, July 9. The delegates appointed by the government of Newfoundland in the fishery matter sailed from Liverpool for St. John's, Nfld., on the steamer Caspian to-day. In interviews the delegates expressed their conviction that the fishery dispute would be satisfactorily settled.

Halifax Notes.

HALIFAX, July 9. The Halifax and Bermuda cable will be open to receive business on Monday. The schooner Carmelite, which left North Sydney 206 days ago for Victoria, B. C., to engage in the Pacific seal fisheries, and which had been given up for lost, arrived at her destination to-day.

LONDON, July 9. The carriers attached to the eastern central postoffice struck this afternoon. There is much excitement about the head offices.
