made two very crude hatches, designed
from some good points of several I had
seen. I filled them with eggs and they
worked fairly well. I kept them going
from Dec. 1 to June 1, clearing from them
\$650 over and above everything, and that,
too, in spite of high price of feed and
the fact that my chickens were all market-
ed at low prices. The highest I got was
\$6 a dozen, and the lowest, \$3.75. Dur-
ing that time I attended to my regular
business. Believing this was a good return
for the amount of work, I began to look
around for a more perfect hatchery, and my
attention was directed to the Common
Sense. In June I got directions from J.
M. Bain, New Concord, O. He is Sec-
retary of the N. A. Poultry Association, and
will send directions for making this hatchery
to anyone sending three two-cent stamps,
to prepay postage. I had one made that
held 250 eggs. Cost about \$7. My success
with this hatchery was all I could wish for,
and I immediately had four more made;
from these five hatches I have just taken
1,030 fine chickens, out of a little less than
1,200 eggs. I believe I am placing it
modestly when I say that I hope to clear
\$2,500 by July next; and still pursue my
usual business. There is no business as pro-
fitable as this, if one gives it the attention
it deserves, and no business requires as
little capital to start on. There is no
necessity of men trying to hide this
business or monopolize it. The field is the
world, and the world, like Oliver Twist, is
crying out for more. There are thousands
of young men who are teachers and clerks,
who look forward to the time when they
can get a start in some lucky way. This
way is here open for them if they will only
improve by it. Thousands of young women,
too, who are dependent on some father or
