

Diplomats Move At Slow Pace In Preparing Space Age Laws

UNITED NATIONS (AP)—As the space age nears the end of its first decade, the world's diplomats are still moving at a slow pace in writing laws to cover the many problems of this new frontier.

There have been points of friction between the United States and the Soviet Union, but up to now space has not been plagued with the lawlessness which followed men's exploration of new frontiers on earth.

This is partly due, in the fact

that the big powers have agreed on a number of basic principles which serve as a sort of informal Magna Carta for space and which may eventually be expanded into a binding legal code. Most legal authorities believe there is still time to prevent a breakdown of order in space.

There are many legal questions which are becoming more pressing with each new space launching by the U.S. and the Soviet Union.

One of these is the regulation of traffic in the increasingly busy highways of space. This includes rules governing so-called space garbage that might eventually prove harmful to astronauts.

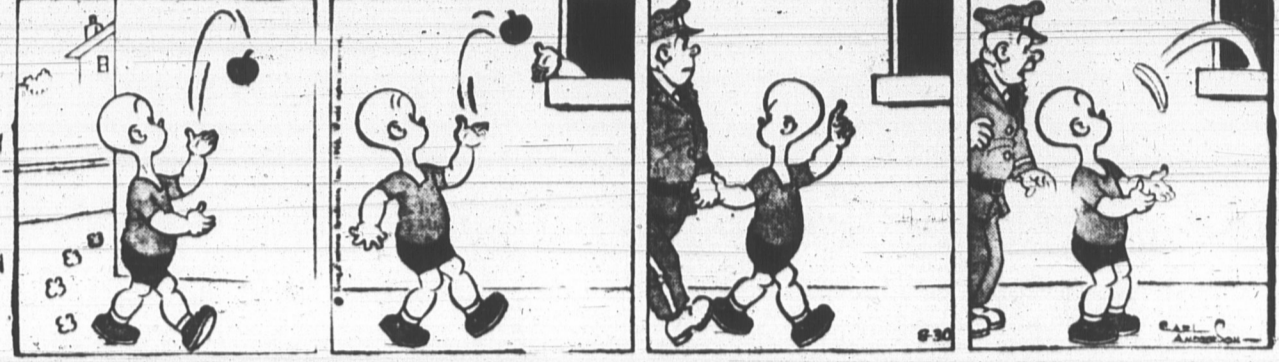
