THE ELECTIONS OF YESTERDAY.

ANTIGONISH, which was wrested from the Liberals by the ability and influence of Sir John Thompson, has returned Mr. McIsaac to represent it in the Parliament of Canada. Mr. McIsaac is a resident of the County and personally well known and popular. His opponent, Mr. Chisholm, is a resident of Halifax, and not so well known or popular. Under the circumstances the defeat of Mr. Chisholm is not wonderful. The wonder is that, with the Provincial Government at his back, Mr. McIsaac's majority is so small. Had Mr. Chisholm been victorious, even by the smallest majority, the victory of the Government party would have been remarkable. If we mistake not, Mr. McIsaac's majority at the Provincial election a year ago was about 400.

No change of party feeling is exhibited by the result in Vercheres. Opposition it has been; Opposition it remains. In Quebec West the contest was between two Conservatives and supporters of the National Policy, though both ran upon the Independent ticket. Consequently, the result there is not significant.

But Hon. Dr. Montague's great majority of 673, in one of the erstwhile closest constituencies of Canada may certainly be accepted as decisive of the question whether or not the Government have gained ground in Ontario. The victory of the Secretary of State is complete.

The point to be noted in each of the contests is that the Manitoba School Question, and the Gov't's action concerning it, have not apparently influenced the elector in the slightest degree. In the Roman Catholic Constituency of Vercheres, the Opposition majority is if we mistake not, rather larger than before; and the Roman Catholic Constituency of Antigonish has gone over to the Grits, even though the Minister of Justice made the remedial order in Council a special feature of his addresses to the electors. On the other hand, the Protestant constituency of Haldimand has rolled up a splendid majority for the Government, notwithstanding the fact that the most ingenious and persistent efforts of unscrupulous Opposition agents were made to rouse Protestant prejudices.

THE STOCK MARKET.

The report of the Commissioners sets forth that there are now on the Government Stock Farm—5 working horses and a year old colt; 19 short horn cows, 2 short horn bulls, 8 short horn one and two years old heifers,—total, 29; 19 Ayrshire cows, 2 Ayrshire bulls, 5 Ayrshire heifers,—total, 26; 2 boars, one York and one Berkshire, 2 breeding sows and eight young pigs,—total, 4.

The sales of surplus stock from the Farm during 1894 were as follows:—In Queen's County at the Exhibition Grounds: 5 calves and 5 young pigs, realizing \$138.65, commission, etc., \$8.18; at the Exhibition in King's County, 5 calves and 5 young pigs, realizing \$126.75, commission and expense, \$7.30; at the Exhibition in Prince County there were 5 calves and 6 young pigs, realizing \$102.00, commission and expense, \$25.52; sale on the Farm last June, 15 horn cattle, 28 sheep, and 9 pigs, total amount of sale \$650.00, commission and expenses, \$38.10.

The crop of last year comprised 90 acres of hay, 155 tons; 22 acres of oats, 45 bushels; 16 acres of corn, 165 tons; 4 acres of barley, 120 bushels; 4 acres of mixed feed, 147 bushels; 3 acres of turnips, 900 bushels; and 1 acre of mangles, 200 bushels. About 150 bushels of clean, sound Norway oats were for sale upon the farm at the time the report was printed.

Though the farm is now in debt to the extent of \$7,305.88 in cash, it is reported that "a quantity of fencing material will have to be purchased for building and repairing fences that are greatly broken down," besides a considerable outlay for the repair of buildings, gates, pump, etc.

Although the report may be taken as proof of the need of a radical change in respect to the Government Stock Farm.

PROVINCIAL LEGISLATURE.

WEDNESDAY, APRIL 17.

At the afternoon session committee was resumed on the bill amending the Medical Act, with Mr. Prowse in the chair. The section in the bill giving a person the privilege of employing any one he liked as medical attendant provoked considerable discussion, those taking part being Messrs. Faughnan, Rogers (Alberton), H. C. Macdonald, Sinclair, Laird, Gordon, W. C. and Warburton. The section was voted down, however, and the bill before the House the promoter declined to proceed further with the measure, and a motion that the Speaker take the chair carried.

ELECTIONS OF YESTERDAY. The Secretary of State Elected by 673.

Antigonish Goes Back to Its Old Love. Mr. Dobell has defeated Hon. Mr. McGreevy by 7 votes.

Vercheres April 18. Vercheres has remained faithful to the family and party traditions. C. A. Geoffrion, C. C. Grits, and J. P. McLean were elected by a majority of 156 over Bisailon, Government candidate.

ANTIGONISH, April 18. The Federal election yesterday resulted in the return of Mr. P. McLean over J. A. Chisholm, by a majority of 108.

TORONTO, April 18. The bright spot in Canada is Haldimand, where Hon. Dr. Montague has been re-elected by the splendid majority of 673.

OPENING OF PARLIAMENT. Full Text of the Governor-General's Speech.

OTTAWA, April 18. This afternoon at 3 o'clock His Excellency the Governor-General proceeded in state to the Chamber of the Senate in the Parliament Building and took his seat upon the throne.

The members of the Senate being assembled, His Excellency was pleased to command the attendance of the House of Commons, and that House being present, His Excellency was pleased to open the fifth session of the seventh Parliament of the Dominion of Canada with the following speech:—

Honorable Gentlemen of the Senate: Gentlemen of the House of Commons: It is with much satisfaction that I again have recourse to your advice and assistance in the administration of the affairs of the Dominion. By the sudden and lamentable death of the late Right Honorable Sir John S. D. Thompson, Canada has sustained a great loss.

The deep and heartfelt sympathy of Her Most Gracious Majesty the Queen, and the manifestations of grief with which such a distressing intelligence was read throughout the Empire, as well as the tokens of esteem and respect everywhere paid to the memory of the deceased statesman, have been gratefully appreciated by the people of Canada.

Satisfactory assurances having been received from Her Majesty's Government respecting the interpretation of certain clauses in the treaty of commerce with France, ratified in honor of the Governor-General in Council, Sir John S. D. Thompson, Canada has sustained a great loss.

The recent action of the Imperial Parliament enabling the various Australian governments to enter into preferential trade relations with other self-governing Colonies of the Empire affords gratifying proof that the suggestions of the Colonial Conference are being favorably entertained by Her Majesty's Government.

In conformity with a recent judgment of the Lords of the Judicial Committee of the Privy Council, to the effect that the dissenting minority of the people of Manx should have a constitutional right of appeal to the Governor-General in Council against certain acts passed by the Legislature of the Province of Manitoba in relation to the subject of education, I have been pleased to enter into an arrangement thereon has been communicated to the Legislature of the said Province. The papers on the subject will be laid before you.

The depression in the trade which has prevailed throughout the world the past few years has made itself felt in Canada, but fortunately to a less degree than in most other countries. Although that has not resulted in any volume of decrease of foreign trade, yet owing to low prices and recent reductions in and removal of taxation, it has been followed by a serious decrease in revenue derived from customs and excise. In order to produce an equilibrium between revenue and expenditure for the coming year, it will be necessary to observe the greatest possible economy in the appropriation for the various branches of public service.

During the period that has elapsed since the last session of Parliament I have had an opportunity of visiting many portions of the Dominion, including the Maritime Provinces, Manitoba, the Northwest Territories and British Columbia. Throughout the tours I have been impressed and gratified by the manifestation of an abounding loyalty and public spirit, and notwithstanding the phase of depression already referred to, I observed everywhere unmistakable signs of that confident hopefulness in the future based on a thorough belief in the greatness and resources of Canada which is one of the characteristics of her people, and which furnishes a good augury and pledge of further development and progress.

The Government of Newfoundland having intimated its desire to renew negotiations looking to the admission of that Colony into the Dominion, a sub-committee of my advisers have recently met in conference to deliberate on the subject, and to discuss with them the terms of union. It will be a subject of general congratulation in the negotiations now pending results in the incorporation of Her Majesty's oldest Colonial possessions into the Canadian Confederation.

Measures relating to bankruptcy and insolvency and to joint stock companies will be laid before you. You will also be asked to consent to amendments to the Insurance Act, to the act respecting Dominion notes, to the Dominion Act, to the Indian Act, to the Northwest Territories Representation Act, as also a bill respecting the land subsidy of the Canadian Pacific Railway Company.

Gentlemen of the House of Commons: I have directed that the accounts of the past year shall be laid before you. The estimates of the ensuing year will be also presented. They have been framed with every regard to economy compatible with the efficiency of the public service. Honorable Gentlemen of the Senate: Gentlemen of the House of Commons: now leave you to the discharge of your important duties devolving upon you with earnest prayer that being guided by the spirit of wisdom and patriotism, your deliberations may, under the Divine blessing, conduce to the unity and well-being of Canada.
