

MEETING AT YORK.

Mr. T. A. McLean Shows up the Summerside Breakwater Matter.

There was a large attendance at the meeting at York last evening.

The meeting was opened by the Opposition candidate, Mr. Martin, who spoke for almost an hour, dealing in an able manner with the questions of the day.

He was replied to in an incoherent way by Mr. D. A. McKinnon, the Government candidate, who spoke about the same length of time.

Dr. Martin, replied to Mr. McKinnon occupying the time of the meeting about twenty minutes. But whenever he made a point against the general policy of the Government a few in the audience became restless and cried time.

Mr. Arthur Peters followed, and in a pleading, plaintive manner drew upon his imagination to bolster up a tottering cause.

Mr. Thos. A. McLean was the next speaker, his remarks having a special bearing upon government contracts. In the matter of the contract for the Summerside breakwater Mr. McLean showed that previous to the election of Mr. McLellan this contract had been let to Holman and McLeod, but after the election it was thrown up and the check was returned. Previous to Mr. Bell's election the same contract was once more let to Holman and McLeod, but after the election it was again thrown up and his check returned. Now the contract has been let again at a much larger figure, and a similar course may be pursued. Mr. McLean is credited with making the speech of the evening.

Mr. H. J. Palmer, Stipendiary Magistrate, followed.

Mr. Martin was then given twenty minutes to reply, as he had opened the meeting, which he did in an able manner.

A party heeler named Hughes then took the platform and attempted to make charges on the school question, which he gave Laurier great credit for settling.

Dr. Macneill was called upon to reply. He said he was willing to give the Laurier Administration credit for settling the question, as claimed. But they had the best right to settle it as it was them who "let loose the dogs of war," they had simply called off the dogs and cried out that the question was settled.

At a late hour the meeting closed with cheers for Mr. Martin and Sir Charles Tupper, and a feeble attempt at cheering for Mr. McKinnon.

NOTICE TO ELECTORS.

QUALIFICATION OF VOTERS, AND HOW TO VOTE.

In electoral districts of this Province the voting takes place by ballot.

There is no registration of voters here.

Every male British subject of the age of 21 years and upwards who has for six months previous to the 9th day of October, A. D., 1900, been in the possession either as owner, tenant or occupant of a house or piece of land of the yearly value of six dollars shall be entitled to vote.

IN ADDITION TO ABOVE.

In country districts every male British subject of the age of 21 years who, being liable to perform Statute Labour, has performed such Statute Labour or paid his commutation money for the year 1900 shall be entitled to vote, provided he has resided for twelve months in the electoral Division.

IN THE CITY OF CHARLOTTETOWN.

If a person cannot qualify as a tenant or owner, he may vote on his poll tax,

IF

He has resided for twelve months previous to the 9th day of October, A. D., 1900 either east or west of Great George Street, and has paid his poll tax of 75cts of it for the year 1899. This tax may be paid at any time before the election, but not on election day.

Every resident voter must vote in the polling district where he is living on election day.

We warn poll tax electors to be prepared with their poll tax receipts, before they go into the polling booths. If you do not produce them, your votes will not be taken and you cannot again enter the booth. Tenants and owners do not require receipts.

Mark your Ballot as above indicated. Simply place a X in the space containing the name of William S. Stewart, the people's candidate for West Queen's. Place no other mark upon the ballot.

The election law of the Dominion provides for perfect secrecy of the ballot, except in case of a scrutiny before two judges of the Supreme Court. Before a scrutiny can be held, the person desiring one must deposit in Court one thousand dollars as security that he will be successful. No ballot can be examined until it has been first proved that the voter has no vote, and no vote under any circumstances can be examined unless it has been marked objected to before the vote was given. No vote can be marked objected to after the voter has received his ballot.

The ballots after being counted are sealed and sent to the Returning Officer who without opening the packets or breaking the seals transmits them to the Clerk of the Crown in Chancery, and whilst in the custody of the Clerk of the Crown Chancery no person is allowed to inspect them.

Besides the polling officers and the agents of the candidates, only one elector may enter the polling booth at a time; he MUST mark his ballot in secret, he MUST hand his ballot folded to the polling officer, who MUST place it in the box without opening, and there is a penalty for displaying the ballot in any way that would afford a clue as to how the elector is voting.

NOTES AND COMMENTS.

The Montreal Star remarks that "this is a critical time in the history of the Canadian nation. What will be the future character of the Canadian people? If the electorate condone insincerity and breach of faith in our public men, it cannot fail to have an effect upon the future morals of the people. It is the duty of each elector to seriously consider the importance of his vote, bearing in mind the fact that he is one of the founders of the Canadian nation."

A Calgary farmer explains why he will vote against the Laurier government in these words: "They have saved me 20 cents a year on my postage stamps, but my tobacco costs me \$2 a year more, my coal bill costs me \$12.60 more, my binder twine \$3 more, my barbed wire, several dollars more, my nails and other hardware likewise." Laurier gave him twenty cents and then proceeded to take \$20 or \$30 out of his pocket.

The St. John Globe takes note of the charges of corruption, bad faith, treachery and other crimes made by Mr. Cook against the Laurier government, and observes:

"Let us assume for the sake of argument that Mr. Cook is influenced by the best possible motives and that he says some things which are true. What is the remedy? It is surely not to return the Conservative party to power."

And the St. John Sun remarks that "That is where Senator Ellis differs from Mr. Cook. Mr. Cook thinks that a group of ministers guilty of a breach of trust should be removed from the position of trust. Senator Ellis thinks that if they are guilty they should be punished by a continuance of trust. Mr. Cook says that he could have had a senatorship for \$10,000. Senator Ellis appears to be settling the bill another way."

BAD STATE OF AFFAIRS.—A correspondent at Granville writes:—"Our roads and bridges are in a deplorable state this season. I would refer particularly to the bridge situated between North and South Granville, known as the 'High Bridge,' which is between twenty and thirty feet. To drive over this bridge, on a dark night, on a strip of plank eight feet wide and rattle on one side, is a feat that only a very hardened Liberal can do without wishing the time for a change of Government was at hand."
