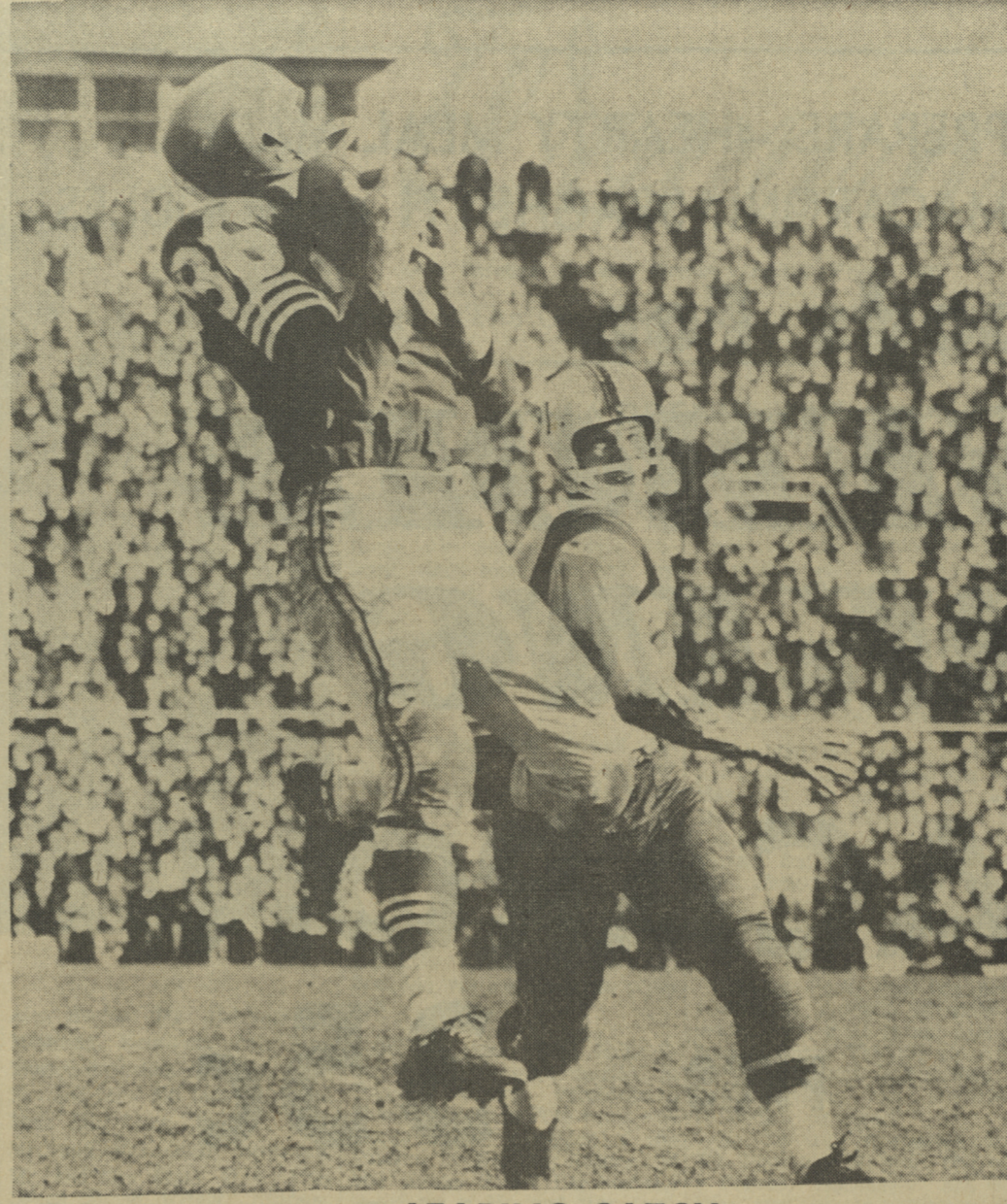

Saliva Test Discloses Drug, Three Suspended

NEW YORK (AP)—The New York state harness racing commission Wednesday ordered the suspension of the owner, groom and trainer-driver of the pacer Widower Creed after a saliva test of the horse disclosed the presence of a drug.

Statistics compiled by The Associated Press also show that Eddie Banks of Chicago Clubs produced the highest slugging average in the National League with .616.
