REV. FATHER BURKE, S. J., Montreal, arrived in this city on Friday evening last. He will remain until Monday next, and will, during the week preach a clerical retreat at St. Dunstan's College, to the priests of the diocese. Yesterday, at High Mass, Rev. Father Burke preached an earnest and impressive sermon to St. Dunstan's congregation.

AN extra British Columbia Gazette announces the appointments of Mr. John Rowland Hett, barrister at law, to be Attorney General. Hon. T. E. Humphreys to be Provincial Secretary and Minister of Mines, and Hon. Robert Beaven to be Chief Commissioner of the Lands and Works, and Minister of Finance and Agriculture, and President of the Executive Council of the Province of British Columbia.

AN attempt was made, on Saturday, to sell liquor at the tea party at Hunter River, but Rev. Mr. Collings was equal to the occasion, and nipped the business in the bud. When the liquor arrived at Hunter River Station, he enquired for its owner, but was unable to find him. Thinking it to be dangerous, just then, he promptly confiscated the greater portion of it, and sent the balance to the shippers in Charlottetown.

THE Supreme Court was engaged this morning trying the man Parsons for placing obstructions on the Prince Edward Island Railway in January last. The prisoner had no counsel, and the Court instructed the Sheriff to procure one from any of the young lawyers who usually throng the Court-room; but that dignitary returned the order "non est inventus;" consequently, the prisoner had to plead his own case. The evidence for the prosecution being concluded, the prisoner was asked for his defence. He had none, and the jury, after a very short absence, found him guilty. Parsons does not appear to be "all there"—in fact, he is a "crank." The trial of civil cases commenced this evening.

LONG BRANCH, N. J., June 29.—The express train, leaving Long Branch at 8.06 this morning, was thrown from the track while crossing a bridge near Little Silver station; caused probably by spreading of the rails. Four passenger cars and a smoker went into the water with a terrible crash. One passenger was taken out dead; another has since died, while nearly 100 are more or less hurt. John J. Raymond had his collar bone broken and otherwise injured; Prest. Gallaway, of the Elevated R. R., slightly injured; Wm. R. Garrison, son of Commodore Garrison, is suffering from concussion of the brain; Geo. R. Blanchard, Vice-Prest. of the N. Y., L. E. & W. Ry. Co.; Robt. M. Minturn, ex-President Grant, and Arthur L. Sewell, are among those only slightly cut and injured.

CONSTANTINOPLE, June 29.—The conference held another session to-day. It is generally admitted that the deliberations are not making any progress.

LONDON, June 30.—The News' Constantinople despatch hears that the conference regards speedy armed interference as necessary, and that it is improbable that any other of Turkey to send troops will be accepted.

ALEXANDRIA, June 30.—Recruits arrived on Thursday, and have reinforced the garrison here. The Nile is rising freely at Khartoum.

WINNIPEG, Man., June 29.—The regatta opened here yesterday. The weather was beautiful and large crowds were present. The water was considerably ruffled by a fresh breeze which sprang up shortly before the start. The first event was the exhibition race between Wallace Ross and Kennedy. Neither exerted himself to any great extent and they kept well together till near the finish, when Ross drew ahead and crossed the line a few seconds ahead of his opponent. They get between them a purse of \$1000. They leave for Boston to-day. The second event was for single irrigated skills, two miles with turn, for a cup worth \$100 to first; cup worth \$40 to second. There were four entries. Three local men were in the contest. Wall took the lead and won easily in 18 minutes. Foray was less than a minute behind, and three lengths ahead of Fisher.

LONDON, June 29.—Lord Clanycarder was murdered this morning on his way from Mass. 3 p. m.—Lord Clanycarder was not murdered as first reported, but his agents, Blake, and steward Keene were killed. No arrests have been made. The murder occurred half a mile from Lochrea. The shots were fired through loopholes in a wall. Blake was a cousin of Lord Clanycarder and over 70 years of age, he had refused police protection, although his life had been threatened several times.

GUITEAU EXECUTED.

HE ARRANGES THE SMALLEST DETAILS AND JUMPS INTO ETERNITY READING A POEM.

(By Telegraph to the Halifax Herald) WASHINGTON, July 30.

Guiteau was restless the most of the latter part of the night. He expressed anxiety less some accident should occur and insisted that Dr. Hicks should see that the scaffold was in proper condition. Guiteau then talked for some time about his future. He remarked that his heart was tender. "I don't think I can go through this ordeal without weeping, not because of any great weakness, for the principle in me is strong, but because I am nearer the other world. I hold to the idea that God inspired me. Guiteau subsequently asked that in his books all complimentary remarks about President Arthur and his administration be eliminated. Then he presented to Dr. Hicks his books. He told Hicks to want him to offer the first prayer on the scaffold, saying that he (Guiteau) would then read his favorite scriptural passage, 10th chapter of John, and offer prayer on his account; then he intended, he said, to read his poem "Simplicity." He desired to have the execution so arranged that just as he uttered the last word the drop should be spring.

LATER. WASHINGTON, June 30.

At five minutes past 12 General Crocker read the death warrant to the prisoner in his cell. The only persons present were General Crocker, Deputy Warden, Rush and Rev. Dr. Hicks.

12 20 p. m.—The death procession had just started for the gallows. 12 45—Guiteau's hands were bound. The crowd outside the jail have got the word that the prisoner has been hanged and is rending the air with shouts, so that it is impossible to hear a voice in the jail office. Guiteau's neck was broken by the fall and not a movement of the limbs or body was detected. Death was instantaneous.
