It was found, however, that the fire originated in the fusing of the electric light wires in the bathroom. A Royal Tiff.

Her Majesty's manner was imperious, while that of the Prince betrayed extreme irritation and he seemed to be defining himself from some imputation cast upon him by the Prince of Wales. The Queen's lips became flushed as she turned abruptly, and the witnesses of the singular scene were much relieved when the tiff was over. Of course no one ventured to intrude upon the parties to the dispute and all pretence of having observed it. The party of the Queen's side, however, put up some creditable amount of champagne on the part of the Prince, who is not so punctilious in these matters as he once was, while the Queen is more precise as she grows older.

Coal from England.
