Protect your Stock.

A healthy animal requires a certain amount of food in either cold or warm weather, but we find that in warm weather an animal kept in good condition on less food than in cold.

The temperature of the animal body is much higher than the surrounding atmosphere at all seasons of the year, with the exception of a very few hours in summer, and unless thus protected outwardly, artificially, a large amount of food is required to furnish the necessary elements of heat.

Where accurate experiments have been made to test the gain of animals with and without the protection of suitable shelter in cold and inclement weather, it has been found that those having adequate protection gained flesh on less food than would keep those unprotected from actually falling away.

In providing stables, which are found to be the best protection for stock, provision should be made for ventilation, as pure air is as important as good feed or warm stables.

Horses, neat cattle, and hogs, will do well in quite warm stables, if good ventilation is provided; on the contrary, sheep will not do well if kept very warm. A much freer ventilation is required to keep them in health.
