OTTAWA LETTER

An Interesting Budget of News.

IMPERIAL TRADE RELATIONS.

(Special correspondence of The Examiner.)

After a slumber of several weeks, the London election case was awakened by Mr. Lister, who moved that a copy of the petition complaining of Judge Elliot's conduct be furnished the Judge for his reply thereto, and that the petition and reply be then referred to a special committee to enquire into the truth of the charges, etc. Mr. Lister's speech was very bitter and partisan and his denunciations of Judge Elliot were sparring. Mr. Moncrieff replied exhaustively and ably. He criticized the allegations in the petition, which took care not to state that the Judge's decisions were wilfully erroneous, but merely that they conflicted. This was no ground for impeachment. As to the charge that the Judge had contributed articles to a newspaper, there was no affidavit to that effect, nor even responsibility assumed for the charge by Mr. Lister. It was not shown when or what dates these articles were published, nor were they specified, or read to the House, although the files of the newspaper could be had in the reading room. It was not stated, either, to whom Judge Elliot had communicated his decision before delivering it in court. If Judge Elliot were summoned to the bar of the House, he would have a right to demand of what he was accused, for they were dragging him to trial without according him rights that were freely given to the lowest criminal in the land. Mr. M. Urieff also quoted from the Hansard of 1885, during the debate on the franchise bill, to show that Mr. Elgar and Mr. Davies had strongly insisted upon reasons being given in the notice served on a voter whose right to be on the list was challenged, while Mr. Edgar and his friends of the Opposition now attacked Judge Elliot for doing the very thing which, in 1885, they insisted upon as being necessary. Mr. M. Urieff then proceeded to dissect the petitioners themselves. Who was Thomas S. Hobbs but the moving spirit of the "lager beer and pigs' feet" meetings which were held to assist in Mr. Hyman's election? George M. R. id was the treasurer of the election fund, and had charge of the books which, when the trial came on, had all mysteriously disappeared. There were four other names to the petition—William McPherson, Ferguson and Sabine—all clerks in Mr. Pavey's store. Mr. Pavey had declined to sign the petition himself, but had told those who had hawked it around, "there are plenty of clerks up stairs; go up and get them to sign it." Mr. Strubbers had also declined to sign it, but six of his clerks were signed to it.

When Mr. Moncrieff had concluded it was six o'clock, and the Speaker left the chair. Further consideration of the question was accordingly postponed till next private members day—to-day possibly.

After recess the Caron charges were brought up, and Sir Richard Cartwright delivered himself of a most violent speech, which was answered by Mr. Dickey in a moderate and judicious tone. He took the ground that the charges were so general that to entertain them would be a rank injustice; that the Opposition were indulging in a fishing expedition into the elections in twenty-two Quebec counties. Concluding, he challenged the Opposition to make specific charges, within the lines of Parliamentary procedure, when they would be promptly investigated.

After one o'clock on Thursday morning the House adjourned with the understanding that the debate would be resumed the first thing next Wednesday. Mr. Dickey is regarded, and rightly so, as a man of great independence and not at all a servile supporter of the administration; his views, therefore, upon so serious a matter as the Caron charges cannot fail of having very considerable weight in the country.

On Thursday, upon motion to go into committee of supply, Mr. Lurier moved in amendment "that it is a necessary constitutional rule on the subject of all communications between the representatives of this Government and the representatives of other governments upon matters of public concern that they should be committed to writing and laid before Parliament as soon as completed, and any attempt on the part of ministers of the Crown to discuss such matters before laying them before Parliament is a dangerous infringement upon the rights of the people.

The debate occupied the whole afternoon, and when 6 o'clock arrived Sir Richard Cartwright had the floor. After dinner, Sir Richard not being on hand, Mr. Charlton talked for a while, when a division was taken, resulting in the amendment being voted down by 98 to 57, a majority of 41.

Then the House went into supply on the vote for immigration, and at midnight had passed one item when the House adjourned. During the evening Mr. McMillen spoke 16 times; Mr. S. Marville 29 times; Mr. Watson 18 times; Paterson, of Brant, 11 times; Gibson 7 times, and Casey and Perry the Noble 5 times each.

On Friday Sir John Thompson introduced the long expected Redistribution Bill. The Grits are already making a great cry about it, but nothing, probably, to what they will make when they have fully grasped its details. Meanwhile the Globe casts upon the Opposition "to prevent a dollar being voted on a bill advanced a single stage until this infamous measure is modified."

Under the new bill the House of Commons will consist of 213 members instead of 215, Quebec having 65, Ontario 92 (same as before), Nova Scotia 20 (one less), New Brunswick 14 (two less), P. E. Island 5 (one less), Manitoba 7 (two more), British Columbia 6 (same as before), and N. W. Territories 4, as before. Of course a very considerable rearrangement of the provinces has taken place. Four constituencies are blotted out in Quebec, being amalgamated with others, while Montreal gets two extra members, Hochelaga one more, and Ottawa County is divided and given an extra member. In Ontario an additional member is given to the city of Toronto, and another to the district of Algona. Very considerable cutting and carving has been done with some of the other counties, to allow of these two additional members without increasing the total representation of the Province; and it is this cutting and carving—or gerrymandering, as they call it—that the Grits are howling about. In New Brunswick, the counties of Sunbury and Queen's are united, and one member taken from the representation of St. John city and county. The Grits could not complain of this, for thereby the Conservatives lose two members. In Nova Scotia, the counties of Queens and Shelburne are united. On the Island, a general cut up has been made, so as to have five electoral divisions of nearly equal population. This has been secured by forming the district of W. St. Prince, which will include Lots 1 to 14 inclusive, and Lot 16, with a population of 20,987. East Prince will include Summerside and Lots 15, 17, 18, 19, 25, 26, 27, 28, 29, 30, 37, with 20,723 of a population. West Queen's will include Charlottetown and R. York, with Lots 20, 21, 22, 23, 31, 32 and 65, having a population of 22,209. East Queen's will include Lots 24, 33, 34, 35, 36, 37, 48, 49, 50, 57, 58, 60, 61, 62, 63 and 64, having a population of 23,466. King's will include Lots 48, 39, 40, 41, 42, 43, 44, 45, 46, 47, 51, 52, 53, 54, 55, 56, 59, 66 and Georgetown, having a population of 21,684.

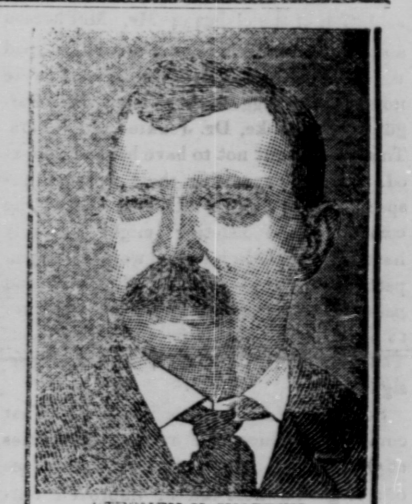
After dinner the House went into Committee of Supply on the vote for Immigration, and when two o'clock, a. m., arrived the House adjourned, the committee being just as far ahead as when they started. During the evening Mr. Lister spoke 28 times; Mr. Mills (the newly elected member) 18 times; McDonald, of Haron, 15 times; Cartwright, 14 times; Bob Watson, 10 times; Paterson, of Brant, 9 times; Campbell, 8 times, while Somerville was heard from only 4 times.

Mr. La Riviere, M. P., has received a letter from Mr. Ernest de Reynal, of the Island Martinique, West Indies, in which the writer says that since the adoption of universal suffrage in that colony the black people have assumed control of the public institutions, legislative as well as municipal. They are now passing such laws that the white people, to escape the heavy taxation on their estates, are almost driven to sell their property. The writer himself, whose ancestors settled on the island 200 years ago, is now seeking to change his place of abode, and is unable to know the prospects of settlement in Manitoba, and he feels satisfied that if he comes to this country many of his friends will follow him. Mr. La Riviere is sending to Mr. Reynal pamphlets and other information concerning Canada.

Col. Amyot's bill to make voting at election compulsory, has been pretty well cut and carried by the Special Committee which has had it under consideration. So far as agreed to by the committee it requires every registered voter, unless he has a reasonable excuse, to appear at his proper polling station, and exercise his franchise, under penalty of \$10. Reasonable excuse under this clause to be a matter of pleading, and the burden of proof to be upon the defendant.

What is the adage about one man being able to take a horse to water, but a hundred not being able to make him drink. The Parliament of Canada may compel, under penalty, the whole electorate to appear at the polling booth, announce their names and receive their ballot papers, retire to mark them and finally deposit them in the ballot box, yet the Parliament of Canada, backed by the Nova Scotia House of Assembly, to say nothing of the new Peter MacLean combination cannot force them to make a pencil mark on the ballot paper, or deposit anything better than a blank ballot perfectly worthless.

Against the enactment of any bill which a compulsory character a petition has been received from the congregation of covenanters, of Almonte, Ont. They say "your petitioners have conscientious scruples in regard to this matter, and more especially as they are under solemn covenant engagements to Almighty God to stand aloof from all participation in political contests." The residence of the late W. G. Parley, M. P., was sold last week at private sale for \$7,000. This is considered a wonderful bargain, as the residence is one of the largest and finest in the city and cost, some 20 years ago, about \$25,000. One would naturally suppose that this immense depreciation in value would be a plum for the Grits, and possibly the Patriot or the Guardian (which I observe has recently thrown its "weight" with the Grits) has already plucked it. But there is an easy explanation. The drop in price is not due to the depreciation of city property, but to change of fashion. To be fashionable now, you must live in the south end; even Sand's Hill, which used to be the aristocratic quarter in the city and cost, some 20 years ago, about \$25,000, is now a "bean family" live in centre town, south. Another reason for the drop is the encroachment of the business portion of the city. Mr. Parley's residence was on Wellington Street, and now the lumber piles have made their way up to the outbuildings.

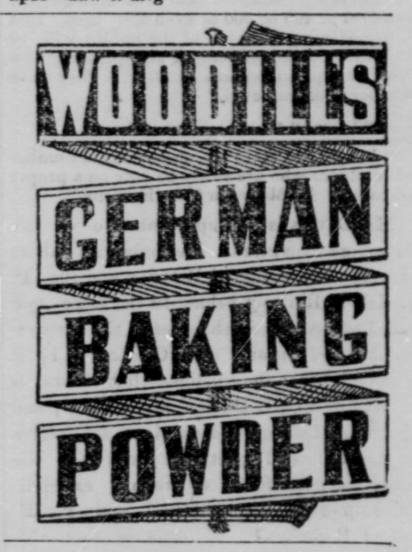
