COMMERCIAL.—The revival of trade is the theme of general congratulation. Every branch of business feels its nourishing glow. In the manufacturing districts all is bustle and activity. The demand, too, is principally confined to the home market. Orders for the East, more particularly for China, have come pouring in of late. But the other great foreign markets, the United States and Brazil—are in a state of comparative, if not actual, stagnation. The cotton market, that unerring barometer of the commercial temperature, continues active, sometimes buoyant. The sales for the week, ending the 30th Sept., (Saturday), have not been quite so great as previously, but the demand has been well sustained, and holders are firm. Speculation has subsided a little, but the present feeling is at once healthy and encouraging. The same remark applies to the markets for Colonial produce. Sugar has improved, especially the better qualities.

REV. MR. SIBTHORP.—This Rev. Gentleman is now regularly attending his parish church of St. Helen's, in the Isle of Wight, and we question much whether he will act again as a Popish priest. His present position is best explained by his own words, which are to this effect, I am not suspended, but I am offended.

At the Privy Council held yesterday at Windsor Castle, a proclamation was issued against the deficient gold coin still in circulation, and by which it is commanded that all loving subjects, particularly all the officers, collectors, and receivers of revenue, from and after the 1st of January next, do cut, break and deface such pieces of the said gold coin as shall be found deficient in weight.

During the firing of the royal salute off Ostend the roar of the guns was heard distinctly at Aklborough in Suffolk.

The Rev. Father Mathew arrived in Dublin on Saturday, after the completion of his first mission to England.

A Havre journal states, that on Saturday an innkeeper of Caen set out in pursuit of an English family who quitted his house without paying their bill, amounting to 800f. He found his debtors on the quay, at Havre, and at once demanded his money. Some discussion arose, and continued for a few minutes, when all at once the unfortunate man, who had been much excited, was struck with apoplexy, and died in less than a minute.

The four Irish representative prelates for the session of 1844, are, the Archbishop of Dublin, the Bishops of Meath, Kildare, and Cashel.

A Copenhagen paper states that the home consumption of spirits in Denmark amounts to four million gallons, which, with a population of 350,000 adult males, as according to the last census, would give an average of fifty-seven quarts per head, or about four times as much as the average consumption in Great Britain and Ireland.

Father Mathew should discharge a national obligation by invading the territory of the Danes. A phenomenon, as strange as it was frightful, is now the subject of conversation at St. Pierre, in the Oise. Two children have been carried off by a whirlwind in the presence of their parents.

The whole country, within the circumference of two leagues, has been visited, without any news being heard of them. It is feared they were carried into the river Oise.

A correspondent of the Societe Belge de Librairie has written word that the atrocious practice, which has lately prevailed at Naples, of throwing inflammable matter on ladies' dresses in public walks, has caused several dreadful calamities.

His own daughter, a fine young woman of eighteen, was burnt alive in the open day, in the middle of the Strada di Toledo.

A society has been established lately in Brighton for the suppression of Sunday trading. Many tradesmen now pay the men in their employment on Fridays instead of Saturdays, to enable them to go to market in time on the latter day.

Patrick McGrath, confined in Waterford Gaol under a decree of the Court of Conscience, for a debt of twenty shillings, died on Monday in the prison, of consumption, accelerated by confinement.

At a meeting of the Nenagh poor-law guardians last week, the collector of rates handed in a list of defaulters, when, amongst the number, the Right Hon. General Lord Bloomfield figured to the heavy amount of twopence half-penny.

We are fully aware that the Central Academy has not hitherto given that satisfaction to the public generally which was desirable, and which the inhabitants of this Island have a right to expect from an Institution of this description. We have, however, never heard this defect attributed to any want of ability or zeal on the part of either of the Masters of that Institution. On the contrary, they have ever, as far as we can learn, exerted themselves to the utmost to render it popular and effective.

Not being so fully conversant with the management of the Central Academy, since your connexion with that Institution, as would be desirable, we shall feel thankful if you will furnish us, in reply, with a succinct account of all such matters, relative thereto, as you may deem it necessary to communicate, for public information.

Understanding that you, Rev. Sir, are shortly about to leave this Island, we cannot suffer you to depart without expressing our warmest sympathy with you, under the painful circumstances which render this step necessary; and we beg to assure you, that wherever your lot may be cast, you carry with you the esteem of a large portion of the members of this community, who will cordially rejoice to hear of your future prosperity and welfare.

(MR. WADDELL'S REPLY.) To the Gentlemen composing the Deputation appointed to present the Address passed at a public meeting held in Charlottetown, Oct. 16th, 1843.

Gentlemen: Appointed to a situation under a permanent Legislative enactment, and summarily dismissed, by persons whose duty it was thoroughly to inform themselves of the merits of the question upon which they were called to adjudicate, and whose character and standing should naturally be accounted ample guarantee for candour and uprightness in the discharge of their trust, your kind address, thus unexpectedly presented, cannot but be to me, in these circumstances, peculiarly gratifying.

That my "duties, as one of the Masters of the Central Academy in this town," were "responsible and onerous," you correctly suppose; and I have long seriously felt that you were not sufficiently "conversant with the management" of that institution to enable you correctly to judge of the reasons, why it "has not hitherto given that satisfaction to the public which the inhabitants of this Island had a right to expect."

It is, perhaps, to be regretted that information was not earlier sought; but since you now require it, I shall endeavour to comply with your request as "succinctly" as I consistently can. I do not know how I can do this more satisfactorily than by putting you in possession of the accompanying official correspondence which has transpired from time to time, between several parties interested in Academy affairs. It contains a better history of "the management of the Central Academy, since my connexion with that institution," and a better exposition of my exertions in its behalf, than I can by any other means supply. It will prove, that whatever may be said of their "want of ability," which has never yet been called in question, there has been no "want of zeal on the part of either of the Masters of that Institution." If opportunity be afforded me, I shall be able to furnish you with additional details, which may be "necessary for public information," and some suggestions, arising from past experience, which might be of use in promoting its future prosperity.

The handsome and generous testimony which you bear to the propriety of my past conduct, commands my most grateful acknowledgments. The assurance which you afford me, that on leaving, I will "carry with me the esteem of a large portion of the members of this community," will make my removal less a subject of regret. The intimation which you give me, that they "will rejoice to hear of my prosperity and welfare," adds to my obligation to endeavour to retain the good opinion which you have been pleased to convey.

Submitting without repining to the dispensations of that Great Being who has the hearts of men in his hands, and believing that he will mark out "my lot," I beg leave to bid you for the present, a cordial farewell.

In letters involving more than ordinary responsibility, I assumed it all, that Mr. Brown might not be entangled in it, and for none of it that bears my signature only, I lie in the least degree accountable. The paper marked No. 5, I have a draft reply to previous letters, because, though it was written at date, it was not forwarded, for obvious reasons, when I abandoned my purpose of leaving the Academy in disgust. Papers Nos. 11 and 13, will show that inquiry into the state and circumstances of the Academy, under the management of the Masters, was courted up to the very close of their connexion with it.
