# U.S. Lumberman Supports Tariffs To Slash Imports

 WASHINGTON (CP)—The co-chairman of a U.S. lumbermen's survival committee said he has been "partially massacred" by imports from Canada and predicted that without restrictions on Canadian lumber, one-half the American lumber market will be taken over.  
 Supporting a proposed massive tariff-and-quota program to restrict imports, Robert Thompson, Portland, Ore., lumber dealer, argued before the tariff commission that the U.S. industry is rearing an economic

grave due by Canadian imports. "We must pay our workers roughly 30 cents more an hour, including fringe benefits, than the Canadians pay their workers," he said. "We must pay our government more than twice the stumpage costs of our American counterparts. We must operate with a full-value American dollar in paying out bills to the Canadian government. In surmounting this lumber industry has created a 32-cent deficit which it must pay its workers and pay its bills."

Proposed restrictions are being applied in purchases by government agencies. Herbert Fierst, Washington lawyer appearing for the B.C. lumber industry, suggested that the U.S. government be permitted to call all the witnesses they want and to ask any or all of them to give evidence. Otherwise, he said, the defence was in an impossible position, and under the greatest difficulty.  
 Maj. Harrison argued that Mr. Laishley's contention that Maj. Platt had been deprived of 15 points of law in the defence's statement of appeal. Maj. Harrison said the six points related to administrative decisions and government action.  
 Mr. Laishley was convicted of a breach of arms regulations while serving last year with the international trade supervisory commission in Indochina. He was fined \$500 and given a seven-year suspension on probation.

# Court Martial Appeal Court Probes Officer Conviction

 OTTAWA (CP)—The three-member court martial appeal court has conducted a searching examination of the court martial of Maj. William Allan Platt convicted in connection with gun smuggling in Indochina.  
 The questioning—most of it by Justice T. G. MacRae—was related mainly to a charge by R. K. Laishley, civilian counsel for Maj. Platt, that his 48-year-old client was deprived of a fair trial.  
 Mr. Laishley's main protest was against the decision of the office of the judge-advocate general relating Maj. Platt's permission to call in his witnesses or to appoint a commission to collect their sworn evidence.  
 Maj. D. H. Harrison, representing the judge-advocate general, said Mr. Laishley wrongly made his request after the prosecution had closed its case against Maj. Platt. He also said that no time did Mr. Laishley move a motion that the court martial be transferred to Indochina.

# CONTRACT BRIDGE

 The bidding:

 Cards fell a story. The trick to read the story and then take proper measures to capitalize on what is learned.  
 Look at this hand, for example. North responded to the opening bid with a jump to a bit irregular, perhaps, with a three-card suit, but North didn't push the idea of a partnership with a notrump or two clubs. South by-passed the opportunity to show his hearts, jumping to two notrump instead. North raised to three.  
 East was thus able to conclude that West had four diamonds, since nine of West's cards in three suits were accounted for. This, in turn, meant that South had only one diamond. East played the king to guard against the possibility that South might have two queens.
