Important Trans-Canada Highway Link Completed

Close co-operation on the part of all concerned brought to a successful termination, yesterday afternoon, an outstanding link in the Trans-Canada Highway project, when the final hopper of concrete mix in the five-mile stretch eastward from Cross Roads was laid by County Construction Co. Ltd. The work was done under the supervision of F.W. Curtis, president and general manager. (See pictures on page 11.)

Premier A. W. Matheson and Hon. J. George MacKay, Minister of Highways, accompanied by Hon. Donald McEwen, Minister of Resources and Fisheries and a number of Department of Highways officials witnessed the dumping and spreading of the final batch of mix.

"The completion of this project, making possible the recovery of prior costs from Ottawa amounting to \$100,000, is a matter of great satisfaction to us," Hon. Mr. MacKay said yesterday. "Had the work not been completed this year, we would have no recovery of prior costs as they terminate with 1956."

An all-out effort has been made by our Department for this purpose. Fine co-operation by all our men-engineers, contractors and all concerned, plus ideal weather conditions has attained the objective, and I am very pleased to see the work completed," Hon. Mr. MacKay said.

The three contracts for subgrading was successfully carried out by County Construction Co. Ltd., 45 miles, Matheson and MacMillan Ltd., 3.0 miles, and Poole and Beer Co., 4.0 miles. Asphalt total miles 17 1/2 was laid by Island Construction Ltd., George A. Hawkins, manager.

The concrete work was started by County Construction Co., Ltd. on August 13 under the supervision of Harry Whitehead, general superintendent of the company. Provincial Government engineers closely allied with the work were Messrs T.A. White and John Gilmore.

Steel guard rail is in the final stages of being placed along all deep fills and guide posts on all curves.

Committee Named To Report U. N. Request For Ceasefire

UNITED NATIONS, N.Y. (CP) Secretary-General Dag Hammarskjöld Friday appointed a committee to report on compliance with the United Nations ceasefire appeal as Britain, France and Israel continued military action against Egypt.

Hammarskjöld acted a few hours after the General Assembly approved the ceasefire by the largest number of votes ever registered in the UN—64 to 5.

The assembly also called for a halt in the movement of military forces into the area, withdrawal of Israeli forces behind the armistice lines and re-opening of the Suez Canal.

The secretary-general named to this watch-dog group Undersecretary Ralph J. Bunche, an American who won the Nobel Peace Prize for negotiating the Israeli-Arab armistices in 1949; Undersecretary Ilya Tchernychev, highest Soviet citizen in the UN; and Constantine A. Stravropolous, UN legal counsel and a Greek national.

SUGGESTS POLICE FORCE
L. B. Pearson, Canadian external affairs minister, suggested early Friday the creation of an adequate police force. State Secretary Dules of the U.S. expressed interest and Pearson was believed to have enlarged on the idea during luncheon with Hammarskjöld. Sources in Ottawa said Canada is thinking of a force of 10,000 men recruited from various countries.

ernment officials concurred in the decision to seal off the fire.

The upper part of No. 4 mine, one of the deepest in the country, was completely blocked by the first explosion. Rescue teams entered the lower workings by a connecting passage from neighboring No. 2 colliery.

Meanwhile offers of help came from all over Canada and the United States. Premier Henry Hicks and Premier-elect Robert Stanfield both were at the scene.

Navy helicopters flew two of the seriously injured to a Halifax hospital.

Rumors Wild

Rumors spread by the dozens through the dazed town. Most could not be confirmed. Coal chief Gordon said he had no time to talk about rumors, the rescue work took all his attention.

One story told of tapping heard on an air pipe into the mine's lower depths. Mr. Gordon said he'd heard nothing about it. A rescue worker said the noise could have been caused by falling rock.

Draegerman Ed McCormick, one of the first to enter the pit after the first blast, told of the deaths of two rescue workers overcome by gas.

"Bill Ferguson a man in my crew, was only under 130 feet when he dropped," he said.

"Then we found Benny Roy and Alex Spence, other draegermen. Alex didn't seem to have any pulse. He died later. Benny is injured."

Springhill Is Shocked Town As Rescue Proceeds

SPRINGHILL, N.S. (CP)—Gloomy skies overhung this death-ridden northern Nova Scotia town Friday as cores of wives and sweethearts waited to learn the fate of their 113 loved ones trapped a mile underground.

A light rain, sometimes turning to snow, mixed with a chilling wind to spell the mood of the 8,000 residents, all of whom had at least one friend or relative among the trapped.

People talked willingly of what could become the Maritimes' greatest mine disaster. They showed no hostility but rather a numbness as though they were about to awake from a dream.

WAIT FOR INJURED
Hundreds of cars lined makeshift parking lots around the mine which is about a mile from the end of the town's main street. Vigilant nurses and doctors waited for the injured and dead in the 20-bed All Saint's Hospital.

Bottles of pure oxygen lined the hospital porch and jammed corridors and passageways.

Army cadets, high school students, and militia, bracing themselves against the freezing rain in army greatcoats, kept the main street clear for ambulances, official cars and hearses.

Most stores were closed. Restaurants remained open. The relatives of the imprisoned miners sat staring blankly into space.

On the main street, clusters of miners—some of whom escaped death or serious injury by only a few hours—stood trying unsuccessfully to divert their hearts from the tragic scene being enacted a few hundred yards away.

"How long the wait will be, only God knows," said one miner. His face still carried indelible traces of coal dust.

TAGS SPELL TRAGEDY
As the mine itself, workers lined up early in the afternoon to pick up their weekly pay envelope. There, 113 numbers spelled the tragedy which remained after a Thursday explosion rocked the mine workings.

At one end of the cabin the Salvation Army doggedly served coffee and sandwiches, knowing their job had only begun.

The desire to help became almost bitterness in the minds of those refused permission to risk their lives in trying to help friends lying dead or injured beneath their feet.

"I offered my services and they didn't want them," the miners told this reporter bitterly.

He was one of the many ordered from the No. 2 shaft when an explosion of undetermined origin racked the adjoining shaft.

NUMB FROM HEAVY
Mrs. Joan McKay, whose husband had been a miner now for 30 years and who was working in No. 4 colliery, the shaft immediately preceding the blast, said "it affects almost every home in town."

Mrs. McKay said the miners are numb from shock. Rejecting food and "just hoping."

"If something happened to one, it happens to all."

Mrs. McKay's nephew, the father of three children, is among the trapped. Perhaps the most inspiring sight of all was given by the draegermen as they bitterly walked into the jaws of death to speed the rescue of the miners and—or recover the bodies.

BRING IN SUPPLIES
The emergency services provided voluntarily are almost beyond belief. The clatter of naval helicopters broke the silent after-noon several times, bringing in emergency supplies and removing some of the injured.

The Red Cross and the Saint John Ambulance services are standing by. Ambulances are lined up side by side at the entrance to the pit head. The hope they give is marred by the presence of several hearses.

Dozens of RCMP officers remained at the mine to prevent emotional outbreaks. The local hospital auxiliary was doing every possible job from serving food to preparing bandages.

The armed services have moved in at least 25 doctors.
