Supreme Court.

GEORGETOWN, Feb. 24. Martha Martin, respondent, vs. Nathan Hill, appellant. Action for breach of the Canada Temperance Act. Owing to the relationship of the magistrate to the prosecutor, the Attorney General allows the appeal, but moves that no costs be allowed.

Francis D. McCormack, respondent, vs. Charles W. Poole, appellant. Action for breach of the Canada Temperance Act. On motion of the Attorney General, the court dismissed the appeal and confirms the judgment of the magistrate, amending the conviction by striking out the cost of commitment.

In the case of Euphemia Forbes and Andrew O'Connor, the witness produced a bottle of liquor that had been purchased from the defendant, and this was ordered by the court to be destroyed, which was accordingly done by the officers of the court.

Dominion Parliament.

Opened To-day.

Summary of the Governor-General's Speech.

Some Important Measures Announced.

OTTAWA, Feb. 26. Parliament opened this afternoon with the usual ceremonies.

The Governor-General in the speech from the Throne, referred to the Behring Sea question and the probability of an early settlement of this long pending difficulty.

Referring to the Washington conference he said that an amicable arrangement had been arrived at respecting the delimitation of the Alaska boundary; an arrangement for reciprocity in wrecking and incidental towing and salvage; also for an international commission to report on regulations to prevent destructive methods of fishing and the pollution of international waters.

Among the measures promised are bills respecting the redistribution of seats, the codification of criminal laws, the establishment of the boundaries of territories and the amalgamation of the departments of Marine and Fisheries.

Measures will also be submitted respecting real property in the territories, the civil service and an amendment to the Fisheries Act, and other minor subjects.

LATER. THE SPEECH IN FULL. OTTAWA, Feb. 25.

At three o'clock this afternoon His Excellency the Governor-General proceeded in state to the Parliament buildings, and the members of the House of Commons having been summoned to the chamber of the Senate, His Excellency was pleased to open the second session of the seventh Parliament of the Dominion of Canada with the following speech:—

It affords me much gratification to meet you at the commencement of the parliament session, and to be able to congratulate you upon the general prosperity of the Dominion, and upon the abundant harvest with which Providence has blessed all parts of the country.

The lamented and untimely death of His Royal Highness the Duke of Clarence and Avondale has aroused a feeling of profound sorrow. The sympathy with Her Majesty and their Royal Highnesses the Prince and Princess of Wales in their bereavement, which has prevailed in the Dominion on this melancholy occasion, found expression in respectful messages of condolence from my Ministers, from the Provincial Governments, and from many other representative bodies.

The negotiations with respect to seal fishing in Behring Sea have been continued with a view to the adjustment by arbitration of the difficulties which have arisen between Her Majesty's Government and that of the United States on that subject. Commissioners have been appointed by both governments to investigate the circumstances of seal fishing in Behring Sea, to report thereon, and to suggest the measures, if any, which they may deem necessary for its proper protection and preservation.

The meeting which had been arranged with the United States Government for a day in October last for an informal discussion on the extension of trade between the two countries and on other international matters requiring adjustment was postponed at their request, but in compliance with a more recent intimation from that Government three of my Ministers proceeded to Washington and conferred with representatives of the administration of the United States on those subjects.

An amicable understanding was arrived at respecting the steps to be taken for the establishment of the boundary of Alaska, and for reciprocity of services in case of wrecks and salvage. Arrangements were also reached for the appointment of an international commission to report on the regulations which may be adopted by the United States and Canada for the prevention of destructive methods of fishing and the pollution of streams, and establishing uniformity of close season and other measures for the preservation and increase of a valuable fisheries.

A friendly interchange of views respecting other important matters also took place. In accordance with a promise given at the close of the last session a Commission has been issued to investigate the working of the civil service generally. The report of the commission will be laid before you.

During the present session the conclusions of the Commissioners on the manufacture of beet root sugar will also be laid before you. It is desirable that the fishery regulations in British Columbia should be examined and revised, so as to adapt them to the requirements of the fisheries of that province. A commission has been issued with that object.

An important measure respecting the criminal law, which was laid before you last session, has been revised and improved as a result of the expression of views elicited by its representation to Parliament, and will be submitted to you.

Your attention will also be directed to measures for the redistribution of seats consequent upon the census returns, the establishment of the boundaries of the territories, and the amalgamation of the department of Marine and Fisheries. Bills will also be presented to you for the amendment of the Civil Service Act, in relation to real property in the Territories and of those respecting the fisheries. The accounts for the past year will be laid before you, as well as the estimates for the ensuing year. These estimates have been prepared with a due regard to economy and the requirements of the public service.
