THE Drummond Colliery strike is ended amicably, and work was resumed at the mines on the 27th ult.

It is reported that Mr. S. M. Brookfield has obtained the contract to build the Sugar Refinery Building at Halifax, at \$83,072.

JOHN WOLLEGE, a negro barber, fatally shot his wife and slightly wounded his son, aged 15, at Mount Joy, Penn., on Feb. 25th. Jealousy was the cause. Wollege has been arrested.

ONTARIO COMMUNISM.—Five men have been arrested in Wright township, sixty miles from Ottawa, for belonging to a Communistic league that has been burning the houses of wealthy people. The insurance companies, having lost heavily, made enquiry that led to their arrest.

THE reported rupture between Peru and Bolivia, if it has really occurred, will doubtless be the end of the South American war. The point of interest is to learn at whose instance the alliance has been broken. If at Bolivia's, it probably has been accompanied by secret terms of peace with Chili. In that case the diplomatic humiliation of Peru at having been made a cat's paw will supplement the military humiliation inflicted on her land and sea forces.

LEADVILLE is a place of strong contrasts. The characteristics of a new mining town are seen there yet; gambling halls and barrooms are more numerous than any other places of business, the pistol and the knife are in common use; highwaymen rob the stages close by, and desperate adventures abound; but opposed to these things is a strong desire for law and order. Schools and churches are being established, and it is thought the civilization of Leadville will soon be accomplished.

THE German Crown Prince has abandoned his proposed visit to Rome and will return to Berlin in time to be present at the celebration of the Emperor's birthday, which occurs on the 22nd of this month. It is rumored in official circles that the German Government have determined not to resume its negotiations with the Vatican, but it is remembered similar declarations on former occasions have almost invariably preceded the vigorous pursuit of her purpose on the part of Germany, and it is not doubted in well-informed quarters that negotiations will go on till a perfect understanding for future peace shall be attained.

A SOMEWHAT novel way of raising money for the relief of the Irish distress was attempted in New York on Tuesday, but the result did not realize the anticipations formed. It was that of selling at auction nine hens devoted for the purpose of assisting the fund. There were congregated at the sale some five thousand people, a large number of whom were brokers, real estate agents and merchants, and the sale was ushered in with a cornet solo by the famous Levy and a serio-comic speech by the auctioneer. The prices realized were low, considering the object and the gathering, the three Brahma fowls bringing \$35, three Plymouth Rocks \$10, and the three game fowls \$15. There were, however, handed in to the auctioneer subscriptions to the amount of \$1,250.

A Horrible Crime.

The trial of Lewis Payne, for the murder of Miss McLean by administering large quantities of spirits, which took place in London, at the Central Criminal Court, concluded with a verdict of guilty of manslaughter. Payne had seduced Miss McLean and for some time had lived with her as her paramour, but either becoming infatuated with a woman named Fannie Mathews, who is under indictment as an accessory to the crime, or wishing to possess himself of some property belonging to his mistress, he concocted a plan with the woman Mathews to murder Miss McLean by inducing her to begin a debauch which they kept up without intermission, continually forcing the unfortunate woman to swallow large quantities of brandy, until she died of alcoholization. The case for the Crown was conducted by the Attorney-General, and Payne was defended by Mr. Edward Clark. Owing to certain mitigating circumstances, Payne was saved from the scaffold, but sentenced to penal servitude for life. Before sentence he made a long and rambling statement, protesting his innocence. The trial of Miss Mathews will immediately follow.

The Gatineau Outrages.

The Gatineau incendiary case, which has been brought to light, continues to create the greatest excitement in the vicinity of the scene of the outrage. The particulars reveal one of the deepest and darkest plots ever conceived in this district, and partake much of the character of the reign of terror in Lucan in its incipient stage. For many months back dwelling houses, barns, sheds and other property have been destroyed by fire, the origin in every case being shrouded in mystery. There appeared to be no distinction as to religion, for Catholics and Protestants alike suffered. Jeanne Bertie, Charles Richards, Onesime Chambrault and Auguste Martin were arrested. Bertie has made a full confession, showing that he had set fire to several places on promise of payment to him by Dr. Langlois and one Doyle.

Entertainment at Lunatic Asylum.

On Saturday evening last a musical Entertainment was given at Falconwood to the inmates of the Asylum. The performers were the Quintette Club and Messrs. Caven, Vinnicombe F. H. Beer, B. Bromner and L. W. Watson. The programme consisted of eight pieces all of which were well performed, and the audience seemed highly pleased with the Entertainment. Dr. Blanchard kindly invited all the Editors of the Local Press, the members of the Government, the Trustees of the Asylum and a few other prominent citizens. Among those present we noticed the Hon. Com. of Public Works, Mr. W. D. Stewart, Geo. R. Baer, Esq., one of the trustees, and representatives of the *Herald Argus, Patriot and New Era*. There was also a fair sprinkling of ladies. The patients who attended the performance numbered about forty, and not only, with one exception, behaved in a most quiet manner, but appeared to thoroughly enjoy the music. That such entertainments are calculated to do much good cannot be doubted, and it is the intention of Dr. Blanchard to have them frequently. Before God Save the Queen was sung, Dr. Blanchard and the Com. of Public Works thanked the performers of behalf of both guests and inmates. When the performance was ended Dr. Blanchard entertained his male guests, and after the inner man was refreshed, an impromptu meeting was held, Professor Caven in the Chair. There was a unanimity among the speakers that such entertainments were eminently desirable, not so much that they afforded pleasure to the audience, as that they introduced a new element into the lives of those whose existence is, from the nature of things, painfully monotonous. After some remarks in this strain, it was suggested by one present that "it was all very well to talk about a repetition of such entertainments, but it was not fair or just that Dr. Blanchard should bear the expenses that must necessarily be incurred." The result of this suggestion was that a subscription list was opened and seventy dollars subscribed, J. F. Montgomery, Esq., heading the list with ten dollars, and Hon. D. Ferguson followed with an equal amount. It was agreed that these sums, together with others that may be given, should be paid to F. Mitchell, Esq., at the Merchants' Bank of Halifax, to be used by Dr. Blanchard to provide musical and other entertainments for the inmates of the Asylum. We did not intend criticising the performance, but while listening to it we were struck with the peculiar fitness of the words of a beautiful poem, written in 1815 by Leigh Hunt, entitled "A Thought on Music," and as it is not generally known, we will conclude with an extract from it:—

"To sit with downward listening and cross knee,
Half conscious, half unconscious, of the throng
Of fellow sars, and hear the well-met skill
Of fine musicians—the glib ivory
Twinkling with numerous prevalence—the
snatch
Of brief and birdy flute, that leaps apart—
Giddy violins, that do what'er they please—
And, sobering all with circling malignness,
The bass, uprolling deep and voluble;—
Well may the sickliest thought, that keeps its
home
In a sad heart, give gentle way for once,
And, quitting its pain-anchor'd hold, put
forth
On that sweet sea of many-bellied sound,
Floating and floating in a dreamy lapse,
Like a half-sleeper in a summer boat,
Till heaven comes near and angels travelling
by.

The Famine in Ireland.

The latest despatches show that the famine is very severe in Galway; that in many other districts distress prevails and that in some it is spreading. The New York *Herald's* despatches give important details. We have only room for a short statement: "A correspondent on Her Majesty's gunboat Goshawk, which is distributing meal among the western islands, writes from Innishark, off Galway: It is a terrible state of affairs. Fifty families here eke out a miserable existence. Their houses are small heaps of dirty stones. Their land is rock and soft bog. Hunger and want are everywhere visible. The people go naked and without food. Many are slowly starving to death. Such scenes of appalling destitution I never before witnessed. Every step we took brought before our view new and more fearful pictures of destitution and suffering. The more we saw the more certain did death from starvation appear the inevitable fate of nearly every man, woman and child on the island. Gaunt, thin and pale were the faces of men who were naturally of herculean build. The features of the women and children were overspread by the ghastly pallor of hunger. In many cabins children crouched, shivering and almost naked, around the fire. When I entered they sprang behind their mother, whose single garment—a thin dress—was but the slightest protection against the wind which blew through the broken roof. On the fire was the dinner—a pot of brown green seaweed. It is certain that, unless they are well cared for, dozens will die of starvation. The same correspondent writes from Innishoffin concerning the shocking maladministration on the part of the officials there. The Government dispensary officer had no drugs, the relieving officer no food. One woman, at least, had died in consequence. The poor-law inspector had not visited the Island for three years. The Mansion House Committee, on Feb. 26, distributed £40,000. If the distress lasts till August, a distribution at the same rate would require £184,000."
