In October and November, in spite of their making every effort to do so.

He said that the head salesman in the Maritimes for the Dominion Coal Company had visited the Island dealers around the middle of November and informed them that as soon as the shipping season on the St. Lawrence ended on November 23rd they would be able to get all the coal they wanted. In fact this salesman is reported to have assured Island dealers that they would be swamped with coal after November 23rd.

Despite the Sydney story and the assurance of the agent, a large coal company representative in this Province said that shipments to the Island were only a drop in the bucket when compared to the demand. However, in view of yesterday's assurance from Mr. Howe, it is hoped, he said, that the situation created by the shortage will be alleviated in the immediate future.

the royal country estate have surpassed anything previously heard. The Earl-Johnny to the Princess and their friends will one day be the Duke of Buccleuch, owner of more than 500,000 acres, six stately homes and a fortune in art treasures.

He isn't exactly handsome, but his red hair, his big six-foot frame make him a fine outdoor-type man. He is a solid country squire of 28 who never comes to London if he can help it.

The Earl has been a suitor for Margaret ever since she was 17 but he has never seen too much of her.

People recall that up until the King was ready to announce Princess Elizabeth's engagement to the Duke of Edinburgh, they did not see much of each other either.

Second, Elizabeth's engagement was announced just before her parents took her and Margaret on a tour of South Africa in 1947.

Now Margaret is about to accompany her parents on a similar tour of Australia and New Zealand.

There were even rumors that the current Earl will be a guest on the tour.

He has closer connections with the royal family than most competitors. His family amalgamation—three ducal lines and Buccleuch title—started 1662 when the Countess Buccleuch married Duke Monmouth—illegitimate son of Charles II, the merry monarch.

His aunt, the Duchess of Gloucester, is the King's sister-in-law. His godmother is Queen Mary, Margaret's grandmother.

Successful Financial Year For Montague

At the Montague Town Council meeting last night Councillor S. S. Hession presented the financial statement for the past year showing assets of \$47,314.35, and liabilities of \$6,207.48. Receipts of \$12,767.88, and disbursements of \$6,951.00, with a bank balance of \$4,516.67 and cash \$17.77. Tax arrears of past years left outstanding total \$2,354.97, and current tax arrears total \$2,301.23.

The building account showed receipts of \$2,960.00, and disbursements of \$1,622.80.

Councillor Hession concluded that the year had been a successful one, and that the new year would be one of great advancement for the community.

Monthly bills totalling \$150.00 were ordered paid, and it was moved that Mrs. J. W. Carruthers be paid \$189.00 on compassionate grounds to compensate for glass breakage before the Wood Island Hill had been paved.

It was moved that Mr. Claude Nicholson be appointed to represent the town of Montague on the Town Planning Board.

Mr. Arnold Wightman was appointed as Town Clerk at a salary of \$400.00 per annum, plus a bonus to be determined by the council at the end of the year.

It was moved that the town policeman be instructed to notify all car owners to remove their cars off the streets of Montague as far as to allow the snow plow free operation at all times.

The street committee was instructed to look after the procuring of a bulldozer to clear side streets where it is impossible for the plow to operate.

Mr. Alfred Sorrey presented a favourable report on the condition of the town dump.

At another meeting the matter of setting up an additional fire alarm system will be discussed.

Before the meeting concluded Mr. S. S. Hession moved a vote of thanks to Mr. Neil Hooley for his services as Town Clerk for several years. Mr. Hooley responded, stating that it was a pleasure to work with the council, but that pressing business matters had forced him to forego the office.

way as to lose its identity." Then he asserted: "We stand with the U.S. shoulder to shoulder with the European army and its German elements, under the supreme N.A.T.O. commander to face whatever aggression may fall upon us."

Did Not Mention Russia

Nowhere in his prepared speech did Mr. Churchill mention the Soviet Union by name.

He referred briefly to Britain's economic troubles and warned that her ordeal "will be hard and will not be short."

Stressing the "gravity" of the economic position, he promised that the United Kingdom will not shrink from any measures necessary to restore confidence and maintain solvency, however unpopular these measures may be.

He recalled that it is almost 10 years to the week since he last was in Ottawa—in wartime December, 1941—and said that at least this time he had "no secrets to guard about the future."

"When I came last time I could not tell," he quipped. "Now I do not know. No one can predict with certainty what will happen."

Canadian Army Casualty List

OTTAWA, Jan. 14 — (CP) — The army today issued its 89th casualty list of the Korean war, reporting one man killed in action, one dead of wounds, and six men wounded in action. The last previous list was issued Jan. 9.

This brought to 661 the number of casualties so far suffered by Canadian troops in Korean action, including 127 dead, 482 wounded, 57 injured, four missing and one captured. One of the men listed in today's list was wounded for the second time.
