

S'side Preparing For Mail Service

SUMMERSIDE — Summerside households are co-operating with postal authorities in preparing for the inauguration of letter carrier service in the town by purchasing and installing mail receiving facilities. Postmaster Charles Peters stated yesterday. Although it is not known how many homes have these facilities installed, this information will be learned shortly through questionnaire cards that will be sent to each household. These cards will be filled in and returned to the postal department and in this way officials will be able to ascertain when the required 80 percent of homes have the mail receptacles.

Several dealers in town are selling mail boxes as a few individuals who are taking advantage of this opportunity to supply an item much in demand. Mr. Peters said yesterday he hoped all citizens are conscious of the fact that eighty percent of the homes must have boxes or slots for mail receipt before the service will be commenced and urged those who have not already purchased or built their own facilities to take action as soon as possible. He stated there is no special requirement insofar as these receptacles are concerned and they can be constructed by the homeowner, if he so wishes, and attached to the door or front of the house.

On inspection, the service will cover a wide area, ranging from St. Eleanor's, if they decide to accept it and it felt they will, to as far as Gillespie's corner, Summerside east and later to be extended to Read's Corner, it's understood.

Hillcrest and MacEwen road are also included in the six carrier routes.

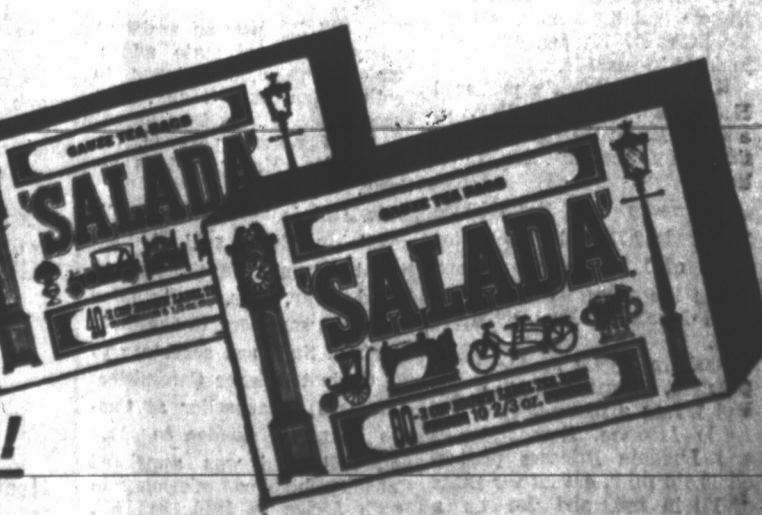
