Twenty-Ninth Annual Report OF THE CHARLOTTETOWN YOUNG MEN'S CHRISTIAN ASSOCIATION.

We are assembled here this evening to receive our Annual Report and review the work of the twenty ninth year of our life and history. The first Y. M. C. A. in the world was founded in London in the year 1844. One thousand eight hundred and forty-nine witnessed the birth of the first Association on this side of the Atlantic at Cincinnati, the place of residence of our well-known respected brother Mr. Thane Miller, followed in 1851 by the first Canadian Branch at Montreal, which is now in a most flourishing condition. In 1856 we, in Charlottetown, added to the noble band then existing, amounting in all at that time to 169, of which 86 were in America, 79 in England and 6 in Australia. We love to look back on the origin in England of the first Y. M. C. A. It was this Seven young men of whom one was the well-known Christian Philanthropist George Williams, who is still living, met in a room in a Merchantile House in London and formed an Association for mutual spiritual improvement, a worthy object, but one found too narrow for those seven warm-hearted Christian young men when they realised the loving Spirit of the Gospel. Therefore they resolved not only to endeavor to improve themselves, but to be aggressive and seek the spiritual good and improvement of others also. The little seed thus sown has now grown into a large tree whose branches have spread into all parts of the world. It has been received into good ground and borne fruit abundantly, so that now we have 2361 Associations in existence in the world, of which 503 are in Great Britain and Ireland, 934 in North America, and the remainder in other parts of the world, including three in Madagascar and one in the Sandwich Islands. As the sun never sets upon the flag of Old England, so now with the Y. M. C. A.'s, one of their number always has its glorious light shining upon it. Our Gospel Army is a large, and we trust a well organized one, with one Captain only leading us, the great Captain of our Salvation "made perfect through sufferings"—and we march under his banner. Our rank and file number 113,741; owning property in buildings, lands, libraries and in various parts of the world of the value of \$4,353,000. Such is the brotherhood to which we now belong and of which we are proud to form a part. Now, everywhere the Y. M. C. A. is acknowledged as an institution of great value to the young, to which Christian men give their hearty support, and we see business and representative men of the country from year to year lending their aid, both financial and personal, to the good work. If we here in Charlottetown only realized as we ought to do the great beneficial results which might be attained by the operations of our Association if it received our really hearty support and encouragement, we would do more for it a great deal than we are now doing.

A noble Christian, the friend and President for 40 years, of the London Y. M. C. A. The Earl of Shaftesbury has gone to his rest since our last Annual Meeting. A few days ago the wealthiest man in America, perhaps in the world, William H. Vanderbilt, also suddenly passed away. He left a legacy of \$100,000 to the New York Y. M. C. A. A very large part of his property now vests in his son, Cornelius Vanderbilt, who is not ashamed to be a member of the Y. M. C. A., and is, in fact, one of the Committee and a Manager of the New York Central Branch. Alongside the grave rank and wealth count but little, for they cannot be carried out of the world. Yet this we know, that those who die in the Lord are blessed; they rest from their labors and their works do follow them. Although Charlottetown has been visited by sickness and pestilence, which has removed many of our citizens, our Y. M. C. A. Roll remains intact. For this we are thankful and now also desire solemnly to record our gratitude to Almighty God, in having blessed the means taken and having stayed the pestilence.

When our Association was formed, in 1853, a Constitution was framed and the objects of the Association were defined, and although I cannot report any great advance in its life or progress during the last year, yet still it appears to me that these efforts as has been put forth have been strictly within the lines of those objects.

First Object—Devotional Meetings.—The Sunday afternoon Gospel Devotional Meeting was well attended during the whole of last Winter, by an average of about 200. On several occasions a Service of Song was substituted, which seemed to be pleasing to, and appreciated by, the large numbers who always attended there. As the Summer advanced, the number attending the meetings so much decreased that it was deemed advisable to discontinue holding them after the 1st of July, and they so remained until September, when they recommenced with a small attendance, and in November were altogether suspended on account of the outbreak of smallpox. They were again commenced on Sunday, 6th December, and we trust will be sustained with increasing interest in the future. I am deeply impressed with the conviction that these Sunday afternoon meetings do not meet with the support and encouragement in this Christian city of which they are worthy.

Intended as they are to benefit and draw together for good the young on Sabbath afternoons, it is not too much, surely, to expect and ask the members of our Association and of our community, more generally, to identify themselves with them and give support and encouragement by their presence and efforts. It is not right to leave such work in the hands of a few, (as is now the case), and I put it to our Christian friends to consider whether they are not incurring a serious responsibility as well as depriving themselves of

much spiritual good by failing to participate in and uphold the means of grace thus afforded to all who elect to gather together on such occasions.

Special prayer meetings were held by the Association in the early part of last November, commencing on Sunday, the eighth day of that month. It was intended that these should have been continued during the ensuing week, but on Thursday, the 13th November, the first note of warning, in connection with the disease which has lately been raging in Charlottetown was sounded, and all meetings ceased. At the same time we gratefully acknowledge the special sermons to young which, through the kind co-operation of the city pastors, were preached in our Protestant churches.

Some outside work has been done by some of members, in the distribution of tracts and holding devotional services at the hospital and poor house.

Second Object—Classes for Biblical instruction.—A weekly Bible class, open to all, was held and well attended regularly throughout the winter. It has continued all along through the summer with diminished attendance, until stayed in November for causes to which I have already referred under No. 1. It will be resumed and continued.

Third Object—The Delivery of Lectures. They were delivered by the following during the last winter's term:—Rev. Benjamin Chappell, Rev. Professor Burwash and Mr. Leigh Gregor.

Sergeant Allan, late H. M. 20th Regiment, also on two occasions gave an account of his reminiscences of active service in the Crimea. On the first occasion the Hall was crowded to excess. The committee, as a testimony to Sergt. Allan for his kindness, constituted him an honorary member of the Association.

Last summer our Hall was occupied for two nights by the celebrated Pisk Jubilee Singers, whose efforts were much appreciated by our people. We hope to be successful in making arrangements to have them amongst us again in the summer of 1886.

Some arrangements have been made for Lectures during the ensuing session, which will be referred to in the Report of the Lecture Committee.

Fourth Object—The establishment of a Library and Reading Room: The Reading Room is well sustained, and being very fully supplied with newspapers and magazines, is much resorted to.

The Library is an important part of our work, too, but it has not yet received that attention which its importance demands. Hitherto the raising of the amount required for our building and furniture had taxed the means of our friends so much that the Library has only had a small share of the bounty bestowed. Other things have taken the precedence of it.

Fifth Object—Meetings for Discussion. A Young Men's Union, in connection with the Association, was formed last winter, to meet in this Room for the purpose of discussion, on each Tuesday evening during the season, and the attendance, as I am informed, generally averaged about fifteen. The proceedings open with Prayer. The Chairman then speaks on the appointed subject, and the other members follow in the discussion. I, in company with Mr. James, was present on invitation at one of the meetings last year. It was a very interesting one—subject "Books to be Read." The speaking, in my opinion, was good and to the point. I recommend this Union, and its mode of passing an evening sensibly and profitably, to the support and consideration of our members, especially the younger ones.

The Convention of the Y. M. C. A. of the Maritime Provinces, met in St. John in August last. It was a very pleasant and profitable meeting and will be long remembered with satisfaction by those who attended it. Seven delegates represented this Association on the occasion, as follows: The President, Joseph Knight, J. D. Seaman, G. F. Beer, A. A. Shepherd, A. E. Crosby, H. Smith, the Secretary.

We cannot quit this subject without expressing pleasure at the prominent part taken by the younger members of our delegation, who, we doubt not, will carry with them the zeal and energy they brought into prominence at St. John, into the work of our local Association during the coming year. It was particularly refreshing to meet there with that earnest veteran in the work, Mr. Cephas Brainard, of the New York Committee, who incurred all the fatigue and expense of travelling from New York to St. John, especially to promote the interests of our work, which he loves so well. Nor can we fail to record with pleasure that the Summerside Branch of the Y. M. C. A. has been revived and sent two most efficient delegates to St. John. We were glad to meet them there, and their society made our return home journey very pleasant. We understand that the latter Association is now in good working order. Would it not be desirable to arrange for an interchange of visits between this and the Summerside Branch sometime during the coming winter?

The financial affairs of the Association will be set forth in the accounts submitted. Whilst, as already reported, our efforts have been put forth within all the lines of our Constitution, yet a great deal more might and ought to be done, and I cannot close this Report without an earnest appeal to our Christian friends and the citizens of Charlottetown generally for increased support, personally and pecuniarily. Let each one bear in mind that the member's annual subscription is only \$2 (for young members only \$1.50 and \$1), out of which our excellent Reading Room is sustained and furnished, then leaving little if anything over for the proper work of benefiting our young men, which, let us never fail to remember, is the principal end which this Association should have in view; besides which, we require and wish to be in a position to offer more inducements than at present we are able to do to the young men of Charlottetown, to join and identify them-

selves personally with the movement, and actively engage in forwarding its objects.

NOTICE IS HEREBY GIVEN, that the Minister of Marine and Fisheries has this day paid into the Supreme Court of Prince Edward Island the sum of Two Hundred and Forty-seven Dollars, with six months' interest thereon, being a sum, in his opinion, a sufficient compensation for all that piece of land and premises, situate at Souris, in King's County, in said Island, which said land and premises are described as follows, that is to say: Commencing at a post set on Bar's Point; five chains and twenty-five links south, five degrees east from the centre of the road at the head of Souris Breakwater, and fifty-one links north, eighty-two degrees east from the top edge of the bank, and running thence north eighty-two degrees, east eighty-five feet, thence at right angles south eight degrees, east forty-five feet, thence south eighty-two degrees, west eighty-five feet, thence north eight degrees, west forty-five feet to the place of commencement. Also, a right of way from the road leading from the Breakwater Road to the residence of Frederick Morrow, to the said piece of land, bounded and described as follows, that is to say: Commencing at the north-east angle of said plot of land, and running thence north eighty-two degrees, east four chains and six links to the aforesaid road leading to Frederick Morrow, thence along said road southwardly until it gives a breadth at right angles of fifteen feet, and thence south eighty-two degrees, west parallel with the said last-mentioned line to the eastern boundary of the said first-described piece of land, and thence north eight degrees, west along said boundary fifteen feet to the place of commencement, which said land and premises have been taken by the Minister of Marine and Fisheries for the site of a Light-house at Souris aforesaid, and all persons entitled to the said lands and premises, or to any part thereof, or representing or being the husbands of any persons so entitled, or claiming to hold or represent incumbencies therein, or interests therein, are required to file their claims to the said compensation or consideration for the said lands and premises with the Prothonotary of the said Supreme Court, on or before the twenty-third day of January, A. D. 1886, and let this notice be published in the DAILY EXAMINER, for the space of two months, twice in each week upon motion of Mr. Hodgson, Q. C., of counsel for the Minister of Marine and Fisheries.
