Civic Elections.

The men are in the field. In Wards one and five, Messrs. Morris and Horne have been elected by acclamation.

In Ward two, there is to be a contest between Councillor Murphy and Mr. H. C. Douse. Mr. Murphy is a City Councillor of large experience and excellent ability.

In Ward 3, Councillor Davy, and Mr. S. W. Crabbe seek election. Both have sat several years at the Council Board.

In Ward four, the candidates come direct from private life, where they are favorably known.

The honorable position of Mayor is sought by W. E. Dawson, Esq., and by D. R. M. Hooper, Esq. Mayor Dawson has occupied the position four years; and, though his record is a good one, that fact is against him.

Winter Communication.

While crossing may be done at the Capes, in fine weather, two or three times a day, it is too bad that we should be obliged, in the finest weather, to put up with an every-other-day arrangement, notwithstanding the following stipulation in the Terms of Union:

SECTION 7.—That the Dominion Government shall assume and defray all the charges for the following services, viz: SUB-SECTION J.—Efficient steam service for the conveyance of mails and passengers to be established and maintained between the Island and the mainland of the Dominion, winter and summer, thus placing the Island in continuous communication with the Intercolonial Railway, and the Railway system of the Dominion.

We protest against this every-other-day arrangement, by which we receive mails, carrying Halifax and St. John dates, three or four days old.

Plain Words About Guiteau.

A correspondent of the Washington Star gives expressions to opinions which are generally held by The People everywhere.

"The trial of the wretch, Guiteau, is now drawing to a close, and the time has about come for a few plain words to him and to his attorneys. Let him bear in mind that for some days after the shooting of President Garfield it was a very doubtful question whether his case would be left for a jury to determine. For a week or ten days after his infamous act ten thousand men could have been got together in this city in thirty minutes to put him out of the reach of judge or jury. But, while the President lingered in pain and suffering, the law abiding public had time for second thoughts, and the almost irresistible impulse to tear his assassin limb from limb, gave way to the calmer and better determination to leave him to be punished by the deliberate and regular processes of the law. This change was not because the people ceased to desire him to be punished by the death penalty, which he deserved, but because they wished that punishment to be the result of judicial action. In this determination the people of this city and of the whole country have won for themselves honor and glory, for if ever in the history of crime an infamous death at the hands of an outraged people was justified by circumstances, his crime offered such justification. He has so far failed to appreciate this leniency that he has during the whole progress of his trial been insolent and insulting in the highest degree to judge, jury, counsel and to the public. His misapprehensions have shocked the feelings of all who have heard him, and it has been a subject of wondering comment all over the world that Judge Cox has submitted to it day after day without gagging him into silence. From time to time he has insinuated and asserted that the people at large were in sympathy with him, and would not let him be punished. Let him now understand that the patience and forbearance of the people of a country are utterly exhausted, and can not, and will not, bear anything more of insolence from him. He has had a long, a tedious and an exhaustive trial at the hands of the lawful authorities, and the people have borne his taunts and his actions as quietly and with as

much of patience as was possible, in order that the world might see that the American people can give even a Guiteau a fair trial. But if the jury should be weak enough to fail to convict him, let him rest assured that the army and navy of the United States, if they were so disposed, could not carry him alive from the court house to Pennsylvania avenue. He had better never have been born than to fall into the hands of this indignant people.

To his counsel let it be said that a certain amount of kindly feeling on the part of some of the people has been entertained towards Mr. Scoville, on account of the position he holds towards the criminal. A proper respect for the feelings of his wife made it necessary and right for him to defend, in all proper and lawful ways, even such a hardened wretch as his miserable brother-in-law. But let it be kindly said to him, that when this present trial shall have been ended, and the jury have rendered their verdict that should be the end of it. Forbearance ceases then to be a virtue, and there should be no talk about new trial, appeal, or any other effort to delay or impede justice. The people have shown him much charity and good will - let him show a proper appreciation by sparing us any further trial of outrage. He will then have fully discharged all obligation to his wife and her family. Let him consider what he owes to his country.

To the lawyer from Chicago, Reed, let it be said that no such sympathy or charity bears in his behalf. He was under no obligation of condescension or morality nor of his profession to take any part in the case after leaving the witness box. To the people it looks as though he was anxious for notoriety, and sought to use this trial as a gratuitous advertisement. He has won the notoriety, but it has cost him the scorn and contempt of all good citizens - and perhaps of the world. If that is a cheap advertisement, he has done well."

Firemen's Turn Out.

A TORCHLIGHT PROCESSION AND DINNER AT THE RANKS.

The dinner to the Fire Brigade of this City was given at the Rankin House last night. It was one of the most successful affairs of the kind ever held in the City. The arrangements were complete, and Chief Engineer Large and the Committee who worked with him, deserve the greatest credit for the handsome manner in which they entertained the fine body of men who compose the Charlottetown Fire Brigade, and their guests.

At 8 o'clock, the members of Sibley Engine Co., under Capt. Hickey; "Kollo," under Capt. Wonnacott, "Tremont," under Capt. Beer, and the Hook-and-Ladder Co., under Captain White, formed in procession at the Engine House, Grafton Street. All - save the Tremont Co. - were in uniform. They carried large torches and, headed by the Band of the 82nd Battalion, marched across Grafton, to Prince Street, up Prince to Kent Street, down Queen to Richmond Street, across Richmond to Great George Street, down Great George to Water Street, and thence to the Hotel. The weather, unfortunately, spoiled the best features of the procession - the music and the display of uniform. However, it was quite interesting. On arrival at the Hotel they proceeded immediately to partake of the excellent repast provided. The dining room, though small for such a number - over one hundred - was well laid off. At the east side sat the Chief Engineer, Fire Wardens and guests, while at tables branching off from the Chief's sat the members of the different Companies, above mentioned, presided over by their Captains. The Band of the 82nd Battalion also occupied a table, which was presided over by the bandmaster, Mr. Galbraith. When "ample justice" was done to "the good things provided" the brigade, instead of the usual toasts, listened to a number of selections by the band, and songs cleverly rendered by Warden Hermons, Firemen Heartz, Bell, Wakeland and others. Votes of thanks were tendered to the following gentlemen, for the manner in which they have performed their duty in the past:

Chief Engineer Large. Capt. Beer of Tremont. Capt. White of Hook and Ladder Co. Capt. Hickey of Sibley. Capt. Wonnacott of Rollo.

A vote of thanks was also tendered to the Band of the 82nd Battalion for its attendance, after which the Brigade dispersed from one of the most orderly and well conducted entertainments ever given in the city.

Citizens' Meeting.

A Meeting of the Citizens was held in Scott's Hall, last evening, to take into consideration the various subjects now agitating the mind of the citizens, and particularly to obtain an expression from the various Candidates for Civic honors, as to their views on the water works and other subjects.

Mr. Lawson, retiring candidate for Ward No. 4, was called to the chair, and the undersigned Secretary.

The meeting was addressed by Councillors Chappelle and Morris, also by Messrs. McDougall, Lea, Douse and D. R. M. Hooper, being candidates for civic honors.

Remarks in reference to city matters were also made by Messrs. Bowers, Tanton, McLaren, Rackem, Knight, and D. Farquharson, M. P.

The meeting appeared to be enthusiastic in the support of D. R. M. Hooper, Esq., and the anti-water work candidates.

The action of the Council during the last year seemed to be almost unanimously condemned by the electors present, who were determined, if possible, to aid their candidates to effect a reduction in the city expenditure; after which the meeting adjourned.

BANK OF P. E. ISLAND.

Adjourned Special Meeting of Shareholders.

The Prospect no Brighter - All Agreed as to the necessity of Resumption - The Question of Ways and Means.

At the special general meeting of the Bank of P. E. Island, held to-day, the report of the Committee appointed at the last meeting was received.

The Committee report that, - Their investigation has been more particularly directed. 1st - To estimating the value of the Assets of the Bank; 2nd - To the feasibility of its resuming business.

The Assets at the time of suspension were nominally \$1,233,848. Consisting as they do in many cases of Mortgages, upon ships, lands, houses, lobster and starch factories, and securities of various kinds, their value depending, to a very large extent, upon the prosperity of the country, and of trade and commerce generally, and upon circumstances which can neither be foreseen nor controlled - any valuation must of necessity be only an approximation.

As a starting point, the Committee accepted the other hand, and detailed statements as prepared by the acting Cashier, Mr. Jack, up to the time of Suspension, 28th Nov. last. Each item was carefully considered and valued, and it is believed that should no unforeseen calamity occur, the estimate will be found fairly correct for its intended purpose.

They estimate the total loss on the Bank's Assets at \$389,500. There is, however, a very large amount - comparatively speaking - at present in suspense and difficult of valuation. Should it be paid in full the above estimate would not be materially altered; whilst on the other hand, adverse circumstances might so affect it as to increase the estimated loss very considerably.

Deducting the estimated loss as above, from the nominal Assets, there are left what may be termed true Assets, \$844,348.

The Liabilities, excluding the Capital Stock, amount to \$1,069,728.

Deficiency, excluding Capital Stock, \$216,380. Or a Deficiency, including Capital Stock of \$340,380.

From which may be deducted the amount derived from the late Cashier's securities, \$26,000.

Leaving \$314,380 being the amount required to be raised so as to leave the Bank a Capital intact.

As to the effects of resumption and liquidation the Committee held very decided views. In liquidation they see ruin to some, heavy loss to all Stockholders and Depositors, great derangement in business, and depression in trade generally, with little corresponding benefit. In resumption, on a sound basis, though it cannot be accomplished without some hardship and loss to the Stockholders, many serious complications would be avoided, and there is the satisfaction that the Bank would rise from "disaster and defeat the stronger." At the same time, in view of the above facts, and particularly of the unsettled state of the account especially referred to, the Committee are not prepared at present to recommend either resumption or liquidation, but must leave that for the determination of the Stockholders at a future meeting, when the state of the Bank may be perhaps, more accurately defined; and when both Directors and Stockholders having given the matter full consideration, will be able to give their well matured opinions, and suggest by what means the deficiency in the Assets may be supplied.

The opinion generally expressed by the meeting was, in effect, that the Bank should resume business. The same Committee were accordingly directed to prepare a scheme - with reference to ways and means, and to report to an adjourned meeting to be held on Wednesday first February next.
