HALIFAX (CP) - The weather office says a narrow band of snow was moving across the Atlantic coast of Nova Scotia late Tuesday evening amounts of from one to two inches as it passed. This will be east of Cape Breton by morning and all three Maritimes provinces will be expected receive a flow of cold air. Snowflurries will be frequent where the wind blows off the water.

Somewhat milder air is forecast to reach the Maritimes Thursday and under a mostly sunny skies temperatures will be generally higher than Wednesday.

FUNERAL HELD HERE MONDAY FOR NOTED DR. JOSEPH DALY

The funeral of a native of Iona, Dr. Joseph Daly, who died Saturday in Toronto, was held Monday from the Hennessey Funeral Home to St. Michael's Church, Iona.

Dr. Daly was born in Iona in 1868, the son of James Daly and Mary Ann Hughes. He attended school at Iona and Eldon, and entered St. Dunstan's University in 1890. He graduated with a bachelor of arts degree "cum laude" from the University of Laval, Quebec City. He was chosen Rhodes Scholar for P.E.I. in 1892.

Before obtaining his degree he also taught school at Albert's Plains and Orwell Cove. After receiving an arts degree in physiology from Oxford University in 1892, he returned to Canada and entered the University of Toronto Medical School, from where he graduated in 1915.

He spent the next several years doing post-graduate work in various fields of medicine, with two years of general practice in Hamilton, Ontario.

In 1922 he went to the Mayor Clinic in Rochester, Minn., first as a fellow in medicine, then as a staff member. He furthered his studies in internal medicine at Guy's Hospital, London, England. In 1929 he received an appointment to the University of Detroit, where he remained for three years, before returning to Toronto.

His medical life in Toronto centred around St. Michael's Hospital, where he had received his medical degree. His health forced his retirement in 1938.

Dr. Daly was active in library work. He was a member of the library board of the Academy of Medicine for many years. He wrote a number of articles - non-medical as well as medical - for lectures and publication.

In 1920 he married Alberta McNab, a graduate of the University of Toronto and the College of Education, who survives him. A sister, Mrs. John Conolly, lives in Iona.

precise reason why it should not be kept on now that the Commission has approved a red-and-white maple leaf flag for Canada.

The Union Jack also had the advantage of being the royal flag. The Commonwealth association was based on the concept of independence under the Crown as defined at the 1949 Commonwealth conference which allowed for the membership of India as a republic.

Opposition Leader Dielenbaker wanted to know whether there had been any consultation with the Queen on making the Union Jack a symbol for the Commonwealth.

Mr. Pearson repeated earlier statements that he had not been informed but not consulted. He said Dielenbaker knew full well it would be unconstitutional to ask the Queen to change the flag.

Mr. Dielenbaker would be accusing us of dragging the Crown into politics," said Mr. Pearson.

ORIGINED

Both Mr. Dielenbaker and Gilles Gr. Inc. deputy leader of the Creditors, objected to the prime minister saying the Union Jack is the Queen's flag.

Mr. Dielenbaker protested heatedly that the Union Jack is the royal flag and the flag of the United Kingdom.

"It was always of the impression that the Queen was royally," Mr. Pearson replied. The Union Jack had been the flag of the monarchy since 1707.

There was a series of exchanges between Mr. Pearson and Mr. Dielenbaker with the opposition leader rising repeatedly to ask questions.

When Mr. Pearson refused to be interrupted until the end of his speech and was supported by Speaker Alan Macnaughton.

Mr. Dielenbaker accused the Speaker of applying the rules of the House of Commons in favour of the prime minister. He had when the leader of the opposition spoke week.

"ING CHARGE

Mr. Pearson said Mr. Dielenbaker had spoken for 1 1/2 hours and he was trying to "browbeat the chair."

"All I have to say is that statement is as false as the allegation he (Mr. Pearson) has made that the Union Jack is the Queen's flag," said Mr. Dielenbaker.

Health Minister (PC - Questel) said he favors the amendment but it would "wage a rear action on behalf of the Red Ensign." The whole idea of a Commonwealth flag was "a ludicrous exercise in dual flagging."

If a second flag was needed it should be the Red Ensign. Among other things it would give "official standing" to the
