elector desires to vote.

On the voter entering the polling place,  
the presiding officer asks him his name,  
occupation, residence, etc., and his answers  
are entered by the clerk. If no objection  
is offered, the voter is given a ballot of  
which the above is a fac-simile, except that  
the cross will not be on it. The presiding  
officer has previously initialed the ballot  
and numbered the counterfoil attached, the  
voter is then directed to enter a compart-  
ment provided, where he will find a pencil.  
If he desires to vote for the Liberal-  
Conservative candidates he will make a  
cross X to the right of the name as we  
have marked above. After marking it he  
will fold it up and return it to the presiding  
officer, who will look at the counterfoil to  
identify the ballot by it. After tearing  
off the counterfoil and destroying it, the  
presiding officer puts the ballot paper in  
the box. Should the voter be unable to  
read, he must take an oath to that effect.  
Then he will be accompanied by the pre-  
siding officer to the compartment, and in  
the presence of the candidates' repre-  
sentatives (who are sworn to secrecy) the  
officer makes the cross alongside the  
names of the candidates for whom the  
elector desires to vote.

The Crapaud Meeting.

To the Editor of the Examiner.

Pursuant to notice, a meeting was held  
in Crapaud Hall, on Thursday, the 8th inst.,  
to discuss Dominion politics.

D. W. Palmer, Esq., was appointed  
chairman, and the undersigned secretary.

Mr. LAIRD was the first speaker. Said  
he was thankful to the Liberal party for  
nominating him; boasted about his Gov-  
ernment of the North-West; charged  
the Government with extravagance, and  
tried to show that the policy of the Govern-  
ment was not a fair one; but did not attempt  
to produce figures to show any extrava-  
gance. Mr. Laird did not even promise,  
if elected, that he would not again forsake  
his constituents for some well-paying office  
without consulting them.

DR. JENKINS then came forward, and  
was enthusiastically received. He justified  
the Pacific Railway contract; dwelt at  
length on the trade question, on which he  
made some good points, and put forward  
convincing facts and figures; referred to  
the attempt to disfranchise the young men  
of this country, in which Mr. Laird took  
part; denounced Mr. McKenzie's opposi-  
tion to the Cape Traverse Railway, and  
other Government measures as unfair, and  
unjust to the people of this Island.

MR. DAVIES was the next speaker. He  
dwelt at some length on that second  
Syndicate, and laboured hard to prove that  
it was a genuine one; said the Moncton  
Sugar Refinery was paying forty per cent.  
of the capital invested, and concluded by  
finding fault with the Government policy.

MR. BRECKEN then took the platform  
amid great applause, and while delivering  
an eloquent and pointed speech held  
hearers spell bound. He said the terms of  
Union had not been carried out; ably  
defended the Government which he sup-  
ported; referred to the deficits of seven  
and a half million dollars under Cart-  
wright's financing, and contrasted it with  
the now existing surplus; made an able  
denunciation of the National Policy, and  
concluded amid loud applause.

MR. WADMAN then took the platform and  
put the following resolution:

Whereas, The late Government have faith-  
fully redeemed the pledges made to the electors  
in 1878; and

Whereas, The measures passed by the  
Government have encouraged the agricultural,  
manufacturing, and commercial interests of  
Dominion; and

Whereas, We desire to express our confi-  
dence in the Government and to put on record  
our approval of their policy, which, in our  
judgment, is calculated to foster the indus-  
tries of Canada; and we also approve of the  
action of the Government in connection with  
the Pacific Railway contract; and

Whereas, Our late representatives have  
carried out their pledges to us in 1878, and  
have since that time looked closely after our  
interests, and take this opportunity of ex-  
pressing our thanks for their many valuable  
services to this country; and hope ere long he  
may be again restored to health;

Resolved, That we pledge our-  
selves to support Messrs. Brecken and Jenkins,  
the Government candidates, at the approach-  
ing election.

The resolution was seconded by Mr. A.  
Shaw.

Mr. Moore offered some opposition to this  
resolution, and after some noisy words be-  
tween him and the chairman, the resolution  
was put and carried by two thirds of a  
majority.

Three cheers were given Messrs. Brecken  
and Jenkins outside the building after  
which the crowd left for their respective  
homes.
