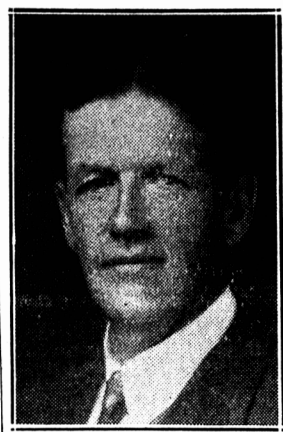

DR. ROBERTSON GIVES EVIDENCE

Fails To Shed Further Light On Mine Tragedy.

HALIFAX, June 25.—Evidence being taken by a government commission investigating the Moose River gold mine collapse Easter Sunday was completed today with the submission of Dr. D. E. Robertson's testimony, taken in Toronto by special commissioner Donald G. Ross.

The commissioners sat for two days in Moose River May 22 and 23 and heard masses of evidence from the manager, F. D. Henderson, other men connected with the mine and gold-mining experts.

Commissioner Norman McKenzie, deputy minister of mines, Mr. Justice W. F. Carroll of the Supreme Court of Nova Scotia and J. H. Cunningham, mining engineer, moved to Halifax and visited the bodies of Alfred Scadding of Toronto—the second man rescued after 10 days' entombment. He described events leading up to the death of Herman Magill of Toronto the seventh day they were underground.

Dr. Robertson's sworn statement taken in Toronto was introduced before the commissioners as the best part of evidence to be heard, but the famous physician was unable to shed any new light on the cause of the mine collapse.

The Prime Minister charged that responsibility for the present situation rested with Japanese manufacturers. He said "their price-cutting aims at a monopoly of the textile market in Australia."

Japanese Consul-General Kuramatsu Mural at Sydney issued a statement in connection with the trade dispute. It said that Japan did not want to dictate Australian policy and that she was prepared to rescind the retaliatory measures as soon as "fair treatment" was given Japan.

Most Australian newspapers characterized the Japanese restrictions as "unwarranted." Even the Sydney Herald, which hitherto urged sympathy with the Japanese case, supports Dr. Lyons' assertion that the Japanese "demands" constitute a challenge which Australia cannot ignore.

When the new Australian tariff policy was announced on May 22 at Canberra, Sir Henry Gullett, assistant minister for trade, said it was designed to divert imports to the Commonwealth valued at more than \$2,000,000 from "indifferent" customers of Australian goods to British and other customers.

Death Of Former Islander In Lowell, Mass.

Many Island friends will regret to learn of the sudden death of Mr. Ambrose M. Creamer of Lowell, Mass. Mr. Jack Murray of Summerside, a niece, received the sad news last week.

The late Ambrose Creamer was born near Kelly's Cross. His father was Bernard Creamer of Kelly's Cross. His mother Margaret Malone, was born in Ireland and came to the Island as a young girl.

Mr. Creamer was an official of the Police Department of Lowell for the past thirty five years. He was also a prominent contractor. He was 68 years of age and had resided in Lowell for about 50 years, but frequently visited his home land. He leaves to mourn his widow, Annie Keeler, a native of Ireland, and one son Joseph of Lowell, two brothers, one Timothy in Lowell and John at the Brae, P. E. I. Mr. William E. Noonan of Summerside is a brother-in-law.

The funeral took place at Lowell on June 17th. The following account of the funeral was clipped from a Lowell paper.

St. Michael's church was filled nearly to capacity yesterday when the funeral of Ambrose M. Creamer, a well known police officer and a resident of this city for the past half century, took place. The funeral left the family home, 79 Merrill avenue, at 9:15 o'clock and was attended by relatives and friends, including many from out of town.

At 10 o'clock at the church a solemn high funeral mass was celebrated by Rev. Thomas J. Heagerty, assisted by Rev. Patrick J. Dawson as deacon and Rev. John P. Peeney as sub-deacon. Seated within the sanctuary was Rev. John J. Shaw, the pastor, Rev. Arthur P. Connors, O. M. I. of the Immaculate Conception Church, Rev. James Mitchell, O. P., and Rev. Paul Bagley, O. P. of Cleveland. The choir, under the direction of Miss Margaret Griffin, sang Terry's mass. At the offertory Daniel Sullivan sang "Miserere Mei", and after the elevation Miss Griffin sang "O Salutaris." The solos of the mass were sung by Mrs. Joseph H. Maguire, Miss Catherine Gallagher, Mrs. John Coughlin and Miss Helen Chadwick. At the conclusion of the mass Mrs. Ella Reilly Toye, the organist, played "Nearer My God, To Thee" on the organ chimes, and after the hymn played "Lead, Kindly Light." As the body was taken from the church the "De Profundis" was sung by the choir.

INCIDENTS PROTESTED TO JAPANESE

United States and French Diplomatic Representatives Allege Rude Treatment of Nationals.

(A. P. By Guardian's Special Wire) PEIPING, June 25.—United States and French diplomatic representatives protested to the Japanese embassy tonight the alleged rude treatment of their nationals by Japanese soldiers.

The incidents, one of which involved Captain Henry Jernigan of the United States army, occurred during a rousing display of Japanese military force in the streets of this ancient city Tuesday.

United States Ambassador Nelson Johnson made representations in two cases to the Japanese Embassy and was informed the Japanese commandant for a later reply.

The American Embassy declined to discuss the cases by name, but one was presumed to deal with Captain Jernigan, who was pushed from the roadway at Bayonet Point. The other, it was believed, concerned a woman reported compelled to retreat from the pavement

of a legation street during the marching by a Japanese officer armed with a sword.

Officials at the French Embassy also called Japanese attention to reports that the wife and child of a French officer had been unceremoniously pushed about.

Other foreigners were said to have been treated roughly by the Japanese soldiers.

Final Appeal

NANKING, China, June 24.—The Nanking (Central) Government made tonight what was interpreted as a final appeal for peace with the bellicose Southwest Canton regime.

Generalissimo Chiang Kai-shek, virtual dictator of the Central Government, reiterated appeal for peaceful settlement of the dispute.

Forces of the National Government, he asserted, would not cross the frontiers of Kwangtung and Kwangsi provinces (which make up the Canton Government) but he added significantly:

"Military discipline must be maintained."

Nanking has large troop concentrations in Hunan Province, bordering upon Kwangtung. Nanking military officials denied reports of a clash in Hunan but said Kwangsi soldiers were entrenched in the vicinity of Lingling, Hunan Province.

N.S. Premier And Attorney-General Created K.C.s

HALIFAX, June 25.—Premier Angus L. Macdonald and Attorney-General J. H. MacQuarrie were named King's Counsel today.

The announcement read in part: "The Governor-in-Council is pleased to appoint to be His Majesty's Counsel, learned in the law in the Province of Nova Scotia, Angus Lewis Macdonald and Josiah H. MacQuarrie, both of Halifax, taking precedence as regards themselves in the order of their calls to the Bar respectively."

Premier Macdonald was a professor at Dalhousie Law School before he became Leader of the Liberal party in Nova Scotia in 1931.
