A BIG FIGHT INTENDED.

The Landing of Turkish Troops.

Special Despatch to the Examiner.

ALEXANDRIA, Aug. 28.

The Egyptians are busily engaged at earthworks, etc., at the east side of Zogazig, where they intend to engage in a great contest with the British forces. Zogazig is the junction between Ismailia, Danietta and Cairo. The fight here will, no doubt, be decisive, and if won by the British forces, will complete the engagements between the two armies, until an advance is made upon Cairo by General Wolseley.

Lord Dufferin says that Turkish troops have been permitted to land at Rosetta, Danetta, or Aboukir. Their landing at Alexandria, Port Said, or Suez, has been refused.

The British forces under Sir Garnet Wolseley, after short engagements on Friday, occupied Ramlah and Birkelchmsa-Whi. The losses were very small. The enemy retreated to Lake Mexina.

Arabi Pasha is now constructing earth works in the direction of Port Said, and the Egyptians are being strongly reinforced at Ghemlich. Several locomotives have arrived from Bombay to-day for the use of the British.

The British forces this afternoon stelled the Egyptian trenches at Mahmoudies with good effect.

An Important Telegraph Decision.

Everybody who has ever written a telegraph message is familiar with the stipulation made upon the blank, which reads as follows:—"It is agreed between the sender of the following message and this company that said company shall not be liable for mistakes or delays in the transmission or delivery, or for non-delivery, of any unrepeatable message, whether happening by the negligence of its servants or otherwise, beyond the amount received for sending the same." The question of the company's liability has never until lately been disputed, and in a suit recently tried in Leavenworth, Kansas, the United States Court has decided that the company can make no such arbitrary stipulation. The Court holds "that any rule or regulation of the company which seems to relieve it from performing its duty, 'belonging to the employment, with integrity, skill and diligence, contravenes public policy as well as the law, and under it the party at fault cannot seek refuge. If it becomes necessary for the transmitting of messages with integrity, skill and diligence, to secure accuracy, to have said messages repeated, then the law devolves upon them the duty."
