

# CIVIC ELECTION!

In pursuance of An Act of the Legislature of the Province of Prince Edward Island made and passed in the Twelfth year of the reign of His Majesty King George VI, Chapter 43, entitled "An Act to consolidate and amend the several Acts incorporating the City of Charlottetown, and all Acts in amendment thereof or in addition thereto.

PUBLIC NOTICE is hereby given that an Election of a Mayor for the said City and one person to serve as a Councillor in the City Council for each of the Wards, Number One, Two and Three of the said City and of two persons to serve as Councillors in said Council for Ward Number Four of the said City, and of Three Persons to serve as Councillors in said Council for Ward Five in the said City, and of two persons to serve as Councillors in said Council for Ward Number Six in the said City; being in all a Mayor and Ten Councillors representing the City as follows:

Ward 1 West, at or near the Labourers Protective Union Hall, being Number 48 Water Street.  
Ward 1 East, at or near the City Garage, being Number 211 Water Street.  
Ward 2 West, at or near the Halifax Seed Co., being number 72 Queen Street.  
Ward 2 East, at or near the residence of Wm. Chipman, being Number 178 Sydney Street.  
Ward 3, at or near Beaton's Auctioneering Rooms, being Number 78 Grafton Street.  
Ward 4 West, at or near the City Building, being on the northwest corner of Queen and Kent Streets.  
Ward 4 Central, at or near Vall's Radio Shop, being Number 206 Kent Street.  
Ward 4 East, at or near the residence of Mr. George Cobb, being Number 228 Fitzroy Street.

Ward 5 West B, at or near the Queen Charlotte High School, being on North River Road, (3 booths) A to K, L to Z.  
Ward 5 West-A, at or near the Euston Street Service Station, being on the northwest corner of Upper Queen and Euston Streets.  
Ward 5 West Central, at or near the property of Percy Moreside, being Number 219 Great George Street.  
Ward 5 East Central, at or near the residence of Mr. Stanley Bowles, being Number 123 Fitzroy Street.  
Ward 5 East, at or near the Birchwood High School, being on Longworth Avenue, (two booths), A to H, I to Z.  
Ward 6, at or near the Little Theatre Hall on Willow Street.

AND at the said Election, the Polls will be opened at Nine O'clock in the forenoon and continue open until Six o'clock in the afternoon of the same day.

## DESCRIPTION OF POLLING DISTRICTS

### WARD ONE

**EAST OF GREAT GEORGE STREET** — The First Polling Division shall comprise all that portion of Ward Number One, in the City of Charlottetown, situate East of Great George Street, and the Poll shall be held at or near the City Garage, being Number 211 Water Street.

**WEST OF GREAT GEORGE STREET** — The Second Polling Division shall comprise all that portion of Ward Number One, in the City of Charlottetown, situate West of Great George Street, and the Poll shall be held at or near Labourers' Protective Union Hall, being Number 48 Water Street.

### WARD TWO

**EAST OF GREAT GEORGE STREET** — The Third Polling Division shall comprise all that portion of Ward Number Two, in the City of Charlottetown, situate East of Great George Street, and the Poll shall be held at or near the residence of Mr. Wm. Chipman, being Number 178 Sydney Street.

**WEST OF GREAT GEORGE STREET** — The Fourth Polling Division shall comprise all that portion of Ward Number Two, in the City of Charlottetown, situate West of Great George Street, and the Poll shall be held at or near the Halifax Seed Co. being Number 72 Queen Street.

### WARD THREE

The Fifth Polling Division shall comprise Ward Number Three, in the City of Charlottetown, and the Poll shall be held at or near Beaton's Auctioneering Rooms, being Number 78 Grafton Street.

### WARD FOUR EAST

**EAST OF HILLSBOROUGH STREET** — The Sixth Polling Division shall comprise all that portion of Ward Number Four in the City of Charlottetown, situate East of Hillsborough Street, and the Poll shall be held at or near the residence of Mr. George Cobb, being No. 228 Fitzroy Street.

### WARD FOUR CENTRAL

The Seventh Polling Division shall comprise all that portion of Ward Number Four, situate West of Hillsborough Street and East of Great George Street, and the Poll shall be held at or near Vall's Radio Shop, being Number 206 Kent Street.

### WARD FOUR WEST

**WEST OF GREAT GEORGE STREET** — The Eighth Polling Division shall comprise all that portion of Ward Number Four, in the said City, situate West of Great George Street, and the Poll shall be held at or near the City Building, being on the northwest corner of Queen and Kent Streets.

### WARD FIVE EAST

**EAST OF HILLSBOROUGH STREET** — The Ninth Polling Division shall comprise all that portion of Ward Number Five, in Charlottetown, West of Hillsborough Street, and a line in continuation thereof to the division line between Charlottetown Common and Royalty, and the Polls (A to H) (I to Z) shall be held at or near the Birchwood High School, being on Longworth Avenue.

### WARD FIVE EAST CENTRAL

The Tenth Polling Division shall comprise all that portion of Ward Five, in Charlottetown, East of Great George Street and the Malpeque Road and West of Hillsborough Street and a line in continuation thereof to the division line between Charlottetown Common and Royalty, and the Poll shall be held at or near the residence of Mr. Stanley Bowles, being Number 123 Fitzroy St.

### WARD FIVE WEST CENTRAL

**WEST OF GREAT GEORGE STREET AND EAST OF QUEEN STREET** — The Eleventh Polling Division shall comprise all that portion of Ward Five in Charlottetown, West of Great George Street and Malpeque Road and East of Queen Street, and the Poll shall be held at or near the property of Percy Moreside, being Number 219 Great George Street.

### WARD FIVE WEST A

The Twelfth Polling Division shall comprise all that portion of Ward Five, Northside of Fitzroy Street from Queen to the East side of Government Pond, thence northwardly to include South side of Euston Street, East side of Spring Street, South side of Victoria Street and East side of Spring Park Road to the former City Limits, thence the Western side of Upper Queen Street and Queen Street to point of commencement at Fitzroy Street, and the poll shall be at or near the Euston Street Service Station, being on the northwest corner of Upper Queen and Euston Streets.

### WARD FIVE WEST B

The Thirteenth Polling Division shall comprise all that portion of Ward Five, West side of West Street, including Government House and Land at Victoria Park, and that portion which shall include Brighton Road, Euston Street to the West side of Spring Street, North side of Victoria Street and West side of Spring Park Road to the former City Limits and the Polls (A to K) (L to Z) shall be held at or near the Queen Charlotte High School, being on North River Road.

### WARD SIX

The Fourteenth Polling Division shall comprise all that portion of the City north of Ward Five, and formerly known as the Village of Spring Park, and the Poll shall be held at or near the Little Theatre Hall on Willow Street.
