Abolition of the Legislative Council.

MR. CHAPLEAU'S SCHEME.

To the Editor of the Examiner.

SIR,—As the members of the different branches of our legislature will now be preparing for active service during the coming session, I consider it proper that electors should make whatever suggestions they think important through the medium of the press, in order to give their representatives time to consider the advisability of taking action on the same during the session. Now, as it is more than probable that the representatives of the people will another effort to abolish the Legislative Council, and that their action will be undertaken by the action of the upper branch, I think it would serve the Government's purpose to adopt the plan of Mr. Chapleau, the leader of the Quebec Government, in reference to this vexed question. On account of the heterogeneous nature of the population of the Province of Quebec, the Premier does not favor the abolition of the Legislative Council, but will introduce a measure during the coming session (should his Government be returned to power) making the position of Legislative Councillors honorary and without salary or allowance. Now I think this would work well on the Island also. We don't object to the "old ladies" recounting their many exploits of valor or the traditions of their families in the Upper Chamber; but we do object to paying them for so doing, and if we can get out of paying these gentlemen, the Legislative Council will soon become a thing of the past. I do not see how the honorable gentlemen who compose that august body can refuse to allow the taking away of their allowances, as they have time and again given as the reasons for holding on to the Council,—the love of constitutional Government and a desire to prevent hasty legislation. Now, as neither the one or the other is connected with the salary matter, they can see both properly carried out without costing the country one cent; and I hope the Government will take this means of abolishing this useless appendage.

Montague Bridge Notes.

Saturday night the largest proportion of the men leaving the Bridge were drunk, and the night air was full of sounds hideous and profane. Five or six Temples of Bacchus—rather rum holes—are in full blast here, and our Magistrates are too busy picking over rotten potatoes, which the honest farmer brings in bags at dusk, to pay any attention to such a minor matter as the Sunday Act.
On Tuesday morning a boy about twelve years of age, son of Mr. Alexander Campbell, blacksmith, Lower Montague, while drawing water for the horses accidentally fell into the well. His brother saw him fall, and gave the alarm. Mr. Campbell rushed from his bed, without waiting to dress, descended by the chain and rescued his boy. Mr. Duncan Campbell promptly conveyed Dr. Robertson to the house, and the injured boy was soon restored to consciousness, and there arose now hopes of his recovery, though his head and shoulders are badly bruised.
Potatoes are 40 to 45 cents according to quality.
Mr. George Whiteman is loading a brig, as is Mr. Kelly. There are a few schooners still at the Bridge, all hope to clear before ten days.
During a great part of the past summer the volcano of Mayon, in the Philippine Islands, has been in an active state of eruption. The phenomenon began by a rumbling sound, which ultimately became a perceptible trembling of the ground adjacent. On the 28th of June the rain fell in torrents, and this continued until the 6th of July, and the mountain at the same time giving forth sulphurous exhalations. On the evening of the latter day there was a regular crash, and during the following night there were three successive eruptions, the air terranous rumbling continuing all the time. The rain then began to fall in torrents as before. Some of the roads were completely swept out of existence, and all travel was in consequence interrupted.
The Dublin Gazette containing a list of the agrarian outrages in Ireland reported during the month of October makes the grand total 490, distributed as follows:—Ulster, 32; Leinster, 192; Connaught, 133; Munster, 223. The nature of the crimes is as follows:—Murder, 2; firing at the person, 7; assault on the police, 1; aggravated assault, 6; assault on a bailiff, 1; cutting and maiming of a bailiff, 1; arson, 52; burglary, 7; taking forcible possession of property, 5; maiming cattle, 17; levying contributions, 1; demanding arms, 4; riots, 2; administering unlawful oaths, 4; intimidation, 306; attacking houses, 8; resistance to legal process, 1; injury to property, 43; firing into dwellings, 14; obstructing the highway, 2.

BETTING MEN IN COURT.—The trial of one of a series of actions against the stakeholder, to recover money placed in his hands as a bet in the athletic club at the Garrison Institute, in which John Healy (of Portland, St. John) and Hinch took part, was commenced in the Supreme Court at Halifax on Friday. The plaintiff, Archibald Renno, was examined and said he bet \$670 that Healy would win two out of three in the contests with Hinch, Burns and Cunningham. D. Schoff, the defendant, was stakeholder. Healy lost, and it is claimed there was fraud and collusion on the part of the stakeholder.

Eight Million Dollars Stolen.

BY MEN WHO STOOD "HIGH IN THE COMMUNITY."

The New York Commercial Advertiser sheds a tear over the fact that of the many famous or infamous defaulters which this country has produced, nearly every one "stood high in the community." Look at a partial list: Carleton, of the Union Trust Company, stole \$400,000; Phelps, of the Treasury Department at Albany, \$800,000; J. C. Duncan, of San Francisco, bank president, \$750,000; E. D. Winslow, Boston preacher, lecturer, treasurer and Christian financier, \$600,000; David Gage, treasurer, Chicago, \$500,000; Wardwell, bank cashier, Providence, \$200,000; Abram Jackson, lawyer, trustee, etc., Boston, \$800,000; John C. Tracy, bank president, Hartford, 600,000; John R. Morton, Philadelphia, \$1,000,000; Henry Nicell, lawyer, New York, \$200,000; G. Van Hollen, collector taxes, Chicago, \$130,000. Here are 12 men whose aggregate stealings foot up \$8,300,000. In every case the thief was a man who "stood high in the community," and in most of them was a conspicuous figure in church affairs. One might go back beyond the seven or eight years covered by the above list, and find a sickening addition to it. There were very many defaulters within that period that have been omitted, but those mentioned were the largest. It is a terrible picture to contemplate, that of men carefully educated, surrounded by true and noble friends, and yet rushing on to ruin, disgrace, and a felon's cell. What is the remedy?

A Queer Maori Marriage.

A New Zealand letter to the London News says: A good clergyman who was working amongst the native population was anxious to establish the sanctity of marriage amongst them. Among others who were candidates for the rite was a much-married aboriginal named Ngata-parapara. On arriving at the clause of the formula where candidates are directed to join hands, a strange scene occurred. No sooner had the direction been given than a whole heavy of memoratis sprang forward, two or three hanging on by the hands and arms of the would be Benedict, with an equal number hanging to his legs. He was completely beelieged, pinned hand and foot, and confusion was made worse confounded by a hugging and tugging by which the unfortunate fellow was in imminent danger of dismemberment. Seeing the turn things had taken the priest naturally enough paused and looked in dismay. "Go on," cried the helpless bridegroom, "or can't ye see for yourself these abominable wretches will have me dragged limb from limb!" Still the reverend gentleman hesitated, seemingly at a loss what to do under such circumstances. "If you don't get along," cried the man, "and bring this kind of a thing to a finish, there'll be another dozen of them here in less than a no time, and when they find I haven't got a fopper left to hang on by they'll drag off the last shred of my blanketing I have over me."

The situation was now perplexing in the extreme, and there was nothing for it but to hurry over the service, and bring the comedy to an end. The sequel to this story is worth adding. In course of time this much married man died, as did the seven-times married woman of the Gospel. The question then arose who was lawfully married before the judge of the native law courts, and the question to be determined was—had the woman who got hold of the deceased's hand precedence over her who merely tugged at his legs. As there was considerable property left, the respective claimants, and it is said that their learned disputations on the respective importance of arms and legs left the unfortunate judge in the dilemma of the man without a leg to stand upon.

AN ALLEGED PUGNACIOUS GOAT.—At Birmingham England, the other day, Mr. Wm. Higgs brought an action against Mr. W. H. Dunkley to recover £2 1s. for damages inflicted by defendant's goat. Plaintiff was walking along Bull Street, when defendant's goat, which was drawing a new-fashioned perambulator, attacked him from behind, and tore his trousers. It was contended that the damage was too trifling to be complained of, and the judge said he did not think from a legal point of view that he was entitled to anything. Plaintiff happened to have a long patriarchal beard—and the goat must have thought that he was infringing on his prerogative. (Laughter.) He could not agree that the goat was naturally a ferocious animal, and he non-suited the plaintiff.
