THE EVIDENCE.

We are charged by the Patriot with striving "to make political capital" out of the asylum matter. Strangely enough this charge is based upon the fact that we rebuked Premier Farquharson for his active interference with the Commission and indicated the effect such officious and unnecessary meddling must of necessity have upon the public mind! Premier Farquharson and his political colleagues, evidently, have regarded the asylum matter as one out of which political capital might be made (or lost). If not, they would have acted as the editor of THE EXAMINER: they would have waited until asked by the Commission to give evidence and then they would have promptly and frankly answered the Commissioner's questions and retired from the investigation without attempting to suggest or dictate to the Commissioners. There can be no doubt that the facts revealed before the commission, upon oath, will operate to the destruction of the incapable and careless government under which the insane wards of the Province have suffered. But God forbid that THE EXAMINER, or any one, should use the facts as means of making political capital without reference to the reform that is, in the name of humanity, demanded. We deny and repudiate the Patriot's ridiculous charge.

But we are in duty bound to deal with the facts of the matter. What are the facts? In June last, a letter signed "A Witness" appeared in THE EXAMINER in which certain definite charges were made concerning the institution, and the care of those in it. A short time afterwards, the Grand Jury found a state of facts which corroborated, in part, the statements of "A Witness." Instantly there was a demand for an investigation. But three long months passed away before the investigation was held. In the meantime several of those who were known to possess information about the matter and to be in a position to speak out plainly and independently, left the province. Whether they received inducements which caused them to depart, or whether, tired of waiting for the investigation, they left merely to secure positions abroad before the winter set in, we cannot say. The fact remains that the Commission did not meet until after a quarter of a year had elapsed and until only officials and attendants holding positions at the disposal of the Government were available to give evidence. Let it be remembered that Premier Farquharson, the master of the administration, was in attendance, interfering between the commission and the witnesses, and exerting all his influence as Premier and Chairman of the Board of Trustees,—while we refer to some of the points in the evidence.

It has been proved, beyond a doubt, that at times there was "mice dirt in the porridge," that at times there were "dirty grounds in the milk"—those who knew anything about the care of cows in winter will know what that means,—at times the meat was "strong," "looked black," "was very tough" and "very lean," at times the flour was "not good," at times the turnips were "hard," at times the house was cold, bitterly cold,—so cold that the attendant "had to wear an overcoat," and "the pipes have frozen at night on the north side," and "the patients were seen shivering" and "the taps had to be covered," and "the water let run to keep it from freezing in the pipes,"—and during all these times the sick and dying breathed the same freezing air. Think of it ye dwellers in warm and comfortable homes! The statements contained in the letter of "A Witness" have been signally confirmed, in their essence, by the evidence given before

the commission. If "things are better now," the fact is due, largely, there can be no doubt, to the revelations of "A Witness." As to the improvement in the meat,—that is probably due, in part, to the fact that the price paid the contractor has been raised, according to a private agreement, from \$4.65 to \$6 per hundred pounds.

Premier Farquharson and other trustees affect surprise that they were never informed concerning certain matters of which they say they were in ignorance. But in view of what happened to Mary Jane McInnis when she complained to the Public Works office concerning the dirt in the oatmeal, their ignorance is not wonderful. Miss McInnis was immediately discharged by order of Premier Farquharson. With such an example before the attendants and officials, is it wonderful that the Trustees were kept in ignorance as to the cold, etc., which they and the patients suffered? But there are facts in the evidence which go to show that the disgraceful conditions at the Asylum are largely due to the apathy and neglect of the Trustees, rather than to the officials and attendants. Only "fourteen visits" were made by the Trustees in the course of a whole year, though the law (38th Victoria Cap 4) explicitly requires that "ONE OF THEM SHALL VISIT THE HOSPITAL ONCE A WEEK." Is it at all surprising that officials and attendants may have slackened their efforts and their vigilance in the face of such scandalous dereliction of duty on the part of the Trustees set over them? This fact, taken in connection with the close relationship (political, commercial, and otherwise), existing between the trustees of the Hospital and the contractors for supplies, must weigh in the public mind in favor of the officials and against the Trustees.

C. O. F. RECEPTION.

The reception given High Chief Ranger Elliot, of the C. O. F., in Mechanics Hall last night, was a most hearty and enjoyable affair. An address of welcome was read by Rev G. P. Raymond, to which Mr. Elliot responded pleasingly. Speech-making was the order of the evening, and it was amply complied with. The principal address was delivered by Mr. Elliot, in which he reviewed the history of the order from its inception to the present, describing its progress financially and socially. Its compulsory insurance feature and the optional benefit were spoken of.

Mr. Stewart, the organizer of the Order in the Island, spoke, and described his success since coming to the Island about seven weeks ago. A court had been started in Kensington, and others at Montague, Souris and Hunter River. He has also organized Court Abegweit, Charlottetown. He expected within a week to be able to organize another within twenty miles of Charlottetown.

Addresses by Messrs J. E. B. McCready, and Revs. Whiston and Raymond were also given.
