ELECTION DAY.

The official announcement has not yet been made. But it is understood that Wednesday, the 20th day of December next, will be election day in this Province.

THE ISSUE.

The Patriot has opened the campaign with an article in which an attempt is made to divert attention from the question in the issue. This is not, we submit, a contest between the "Leaders of the respective parties." It is, we submit, a struggle of the people to obtain the restoration of political rights which have been invaded and a financial balance which has been disturbed. This is The People's Battle. The people have now to drive from office the authors of the crookedest gerrymander ever perpetrated, the authors of one of the most outrageous acts of political spoliation ever accomplished, the authors of the scheme by which the Land Office has been wrecked and ruined, the authors of the "plan of campaign" by which doubtful and shady voters are being brought over by means of jobs upon roads and bridges, the authors of a debt and a bank debt, to meet which they have not attempted to make any provision, the burden necessarily and inevitably falling upon the shoulders of the taxpayers. These men will never repeat their own measures. They will, rather, if permitted to retain power, conspire to entrap still more the rights and liberties of the people. The first and most important thing to do is to get rid of them at once and forever. Till this be done, the people will never be secure against disfranchisement, two-thirds votes, gerrymanders, and other evil contrivances invented for the purpose of prolonging the existence of a tyrannical combination. To this great task the people of Prince Edward Island must now address themselves. Nor must they be influenced by the Patriot's attempt to divert their attention to "the leaders of the respective parties." It may be admitted that much depends upon the leaders. But the experience of all ages has taught that a people who "know their rights, and knowing, dare maintain," will never want for a leader. The leader will come to them. Premier Peters has never been called to the leadership by the voice of the people. He was made leader by the Lieutenant-Governor, and his finance has been shown in his ability to lead a weak and dependent party by the nose, constraining them while parading as Liberals to pass illiberal measures and carry out old Tory notions. The Patriot carries about "capacity," "experience" and "antecedents." We contend that Mr. Bentley has a claim upon the people superior to that of Mr. Peters in respect to all of these points. Mr. Bentley has had much larger experience as a public man. He has had much more of that kind of experience which teaches about the conditions and aspirations of the people of Prince Edward Island. As to his antecedents in respect to the Leadership of a free people, he has also a claim superior to that of Mr. Peters. Mr. Peters' antecedents in respect to a law office or judgeship are, admittedly, good. But as a politician entrusted with the care and conduct of the public affairs of men who have fought their way out of the bondage of the landlords, his "antecedents" will not count with those of Mr. Bentley. Then, as to "capacity," Mr. Bentley was for many years Commissioner of Public Works in the Sullivan Administration, and his "capacity" was, year after year, exhibited in making a small amount of money go a great way. Whether as Commissioner of Public Works or as Commissioner of Public Lands, Mr. Bentley has proved his "capacity." His "capacity" as the leader of a party has yet to be "proved." But we contend that there are in his "antecedents," his "experience" and his proved "capacity," sufficient guarantees to a reasonable people that he will, as Leader of the Government, be careful, economical and honest in the expenditure of public money, and that he will never rob the electors of their votes, or take an unfair advantage of his opponents. We are not disposed to deny the capacity of Mr. Peters. Though he has made some egregious blunders in legislation—witness his awkward attempts upon the County Court at Dunstons—(he is admittedly an able lawyer. For that which he can do well we give him full credit. He is able to humbug and cajole his followers by means of his arts as a special pleader and his skill in the use of "human devices." But we contend that as "capacity" is not such "capacity" as is needed in a Leader of the Government of this Province.

The question of leaders is, however, at this juncture, a matter of secondary importance to electors and taxpayers. What they have to do, forthwith, is to overcome the evil influence which has carried them to the brink of taxation and robbed them of the franchise of their freedom and its fairness.

LITERARY AND SCIENTIFIC SOCIETY.

The Properties of Matter.

The Literary and Scientific Society was well attended last evening. Prof. Hazcourt's address, aided by the blackboard, was clear and instructive. The properties of matter were described as indistinctly, conservation of energy, definite proportion and multiple proportions. The last, multiple proportions, formed the basis of his remarks. The atomic and molecular theories as at present accepted by scientists were clearly explained and illustrated. An interesting discussion followed, both of Prof. Hazcourt's address and of Dr. Leeming's lecture of the previous week, in which Messrs. John Newson, S. G. Lawson, A. E. Morrison, Prof. Shaw, Dr. Leeming, W. P. Duell, F. W. L. Moore and others took part. Specific gravity, transmission of thermal and other rays, the inter-stellar ether, and a number of other subjects came in for a part of the discussion; while on one occasion the president found it necessary to call the soaring orator back to earth, so to speak, from the infinite to the material, from metaphysics to physics. Altogether, the meeting was instructive and thoroughly enjoyable.

Prohibition Meeting Under the Auspices of the Society.

A Strong Resolution Passed Last Night.

A MEETING to discuss the great question of Prohibition was held in the Athenaeum last evening. There was a fair attendance, though but few of our politicians were present. His Worship the Mayor occupied the chair, and delivered a short opening address, in the course of which he spoke strongly in favor of prohibition, and quoted from the writings of the famous Presbyterian clergyman, Dr. Norman McLeod. He expressed the opinion that drunkenness was on the increase in Charlottetown, and said that he would prefer the Scott Act to the present law. The influence of the Church should, he thought, be brought to bear upon the temperance question, and temperance should be instilled into the minds of the young. He feared that our public schools were not fulfilling their mission in this regard.

Rev. Mr. Hamlyn read from the Book of Isaiah concerning the sin of drunkenness, and the curse which rests upon them who promote drunkenness.

Rev. Mr. Turner spoke at some length in respect to the indifference of voters and politicians, and declared that temperance reformers must "agitiate." He contended that the most ought to be made of the opportunity to vote upon the prohibition question.

Rev. Mr. Corney, the new and popular pastor of the Baptist Church, argued against license and in favor of the total prohibition of the liquor traffic. While it is true that men have free will, it is also true that they need the bracing, staying and propping of law.

Rev. Mr. Sutherland submitted and commented upon the following resolution:—"Whereas, This meeting is strongly of opinion that the liquor traffic is the prolific source of crime, poverty and woe, the foe of humanity, a menace to our civilization and a great obstacle to the progress of Christianity; and whereas, This meeting holds that no inherent right to sell liquor is vested either in any individual or in any province or state;

"Resolved, That this meeting desires to express its conviction that a Prohibitory Act is the only intelligent, sure and effectual remedy for the evils arising from the drink traffic, and we regard it as the duty of every good citizen, every lover of his country, to do all that in his power lies, by practice, precept and votes, to hasten the reign of Legal Prohibition."

One of the stories told by the rev. gentleman while enforcing this resolution was somewhat as follows: A poor drinking Scotchman dreamed that he saw four rats in procession. The first was a large fat rat; then followed two lean rats; and last of all came a blind rat. As Scotchmen count it unlucky to dream about rats, the poor man was much concerned, and next morning asked his wife's opinion. But she was not able to offer an explanation of the matter. The son, who was listening, was, however, equal to the occasion. He said, "I'll tell ye, father. The fat rat is the saloon-keeper round the corner, who give ye your earnings; the two lean rats are mother and me; and the blind rat is yerself."

THE MARKETS.

The market is weakening in respect to oats, and the Charlottetown quotations now are 30 cents to 32 cents per bushel. Statutes still sell here at 18 to 20 cents per bushel, or 7 to 8 cents per lb., and hay at 65 to 70 cents per ton.

THE HAWAIIAN AFFAIR.

WASHINGTON, Nov. 14.—Minister Thurston of Hawaii called on Secretary of State Gresham this morning and this afternoon twice in his second visit. They held long conferences, but neither one would give any information as to what occurred at the interviews. Of course it was known that the Hawaiian affair had been discussed, and that a strong protest had been made by Mr. Thurston against the action of the United States Government regarding the instructions supposed to have been given to Minister Willis. The general protest which has gone up by the people has aroused the administration to a conception of its position, and as a result the table in the Cabinet room was today surrounded by everyone of Mr. Cleveland's official advisers. It was concluded, it is said, not to give out the Blount report or the dispatches from Minister Willis until the whole correspondence can be submitted to Congress. It is claimed by those who have been permitted to see the report that it justifies the action taken by the administration in the matter. Of course nothing will be known of what has taken place until Thursday next, when the steamer from Australia arrives at San Francisco, calling by way of Honolulu. She will not arrive until Thursday next, and the report which she will bear from the island is awaited with a great deal of anxiety. Public interest in the restoration of Queen Liliuokalani is not subsided, and the thought is now that it is within the probabilities that England, and perhaps Germany, may take a hand in the affair. The fact that an English warship has been ordered to Hawaii waters lends some probability to the idea. The fact that Secretary Gresham still declines to discuss the action which he has taken arouses indignation which cannot help but be antagonistic to the administration. He is awaiting but a diplomat, and has, besides, to remember the fact that he was a convert to the Democratic party. It may be because of this that the railers have so denounced him that he has been accused of unparliamentary conduct and a desire to see the American flag trampled in the dust.

Personal.

Rev. K. C. Hind, M. A., has entered upon his duties as Rector of Wolfville parish.

The Halifax Herald, commenting upon the P. E. Island elections, says: "Mr. Bentley may be relied upon to make a good fight. Jacob Astor has given his sister, Mrs. Coleman Drayton, \$1,000,000 and a house on Fifth Avenue. There is talk that she will soon, as an offset, wed a French count."

OUR MILITIA GRIEVANCES.

A Second Memorial to the Minister of Militia.

The Officers Discouraged and the Men Ready to Disband.

FOLLOWING is a copy of the memorial forwarded to the Minister of Militia a few days ago, and to the Hon. the Attorney-General, in connection with the memorial presented to the Hon. the Minister of Militia, on the subject of the grievances of the P. E. Island militia, on behalf of the officers and men of the 1st, 2nd and 3rd battalions.

CHARLOTTETOWN, Nov. 9, 1893.

DEAR MR. PATTERSON:—Your letter of the 12th ult., replying to Mr. Davies', enclosing a memorial signed by the majority of the Island representatives in Parliament, on the subject of the grievances of the P. E. Island militia, was duly received and submitted to the militia officers.

They desire to thank you for your prompt reply and for the kindness and courtesy which mark it.

Your letter was read at a large meeting of the militia assembled for the purpose, and we have been requested to furnish you with the result of the meeting.

At the outset, we desire to repeat that the Island militiamen are a noble and patriotic body, and that their feeling as to the injurious effects which the present condition of affairs will have in the future. While the men hitherto have, as you acknowledge, been most efficient, the recent orders, abolishing the P. E. Island as a separate district, and taking away their resident staff officers, have, already, shown their effects in the great dissatisfaction prevailing all ranks of the force. The officers are discouraged and the men ready to disband.

They cannot understand the meaning of the statement contained in your letter that "you had made a change involving the absorption of the P. E. Island district in that of New Brunswick. They call your special attention to the order-council published in the Gazette of May 1, A. D. 1892, specifically putting an end to the P. E. Island as a separate district, and merging it in New Brunswick. This order-council may have been passed by your predecessor, but it exists all the same, and today the Island is situated as a separate military district, and that a Brigade-Major and store-keeper may be re-appointed here.

We beg to assure you that the feeling on these points is so strong as to be quite uncontrollable, and the justice of the claim itself and the evil consequences which will almost surely follow in case the Department determines not to accede to it, are such that we feel we cannot urge you so strongly to give them your sympathetic consideration, and at the earliest possible moment to restore the military status of the district and the officials which are absolutely necessary to retain efficiency in the force.

LONDON, Nov. 15.—The engagement is announced of Hon. Nellie Lisa Bass, the only child and heiress of \$750,000 worth of the brewing company of Bass & Co., of Burton-on-Trent, to Brice Baillie, a Scotch landowner. The prospective bridegroom is a cousin of the Earl of Elgin.

CHICAGO, Nov. 14.—Andrew Warren, 50 years of age, and owner of \$750,000 worth of real estate in Cook county, besides large holdings in Ohio, Wisconsin and other states, has filed a bill for divorce. He was married in 1876 and his wife is now about thirty-six years of age. He alleges that she has always been cruel, that she is subject to most violent outbreaks of passion and that she has repeatedly threatened to kill him. Warren also alleges that his wife has an uncontrollable passion for speculation, and that she stole money from him, sold his clothes, hay from his barns, trees from his yard; in fact, everything she could find to secure money for speculation. He also says she has lost \$50,000 on the board of trade.

HOUSE OF COMMONS.

The Government Defeated in Committee.

EDWARD BLAKE IS AMONG THE KICKERS.

LONDON, Nov. 17.

The debate on the Local Government Bill occupied all the time of the House of Commons last evening. Walter McLaren, Radical, moved that the committee be instructed to insert in the bill a provision enfranchising women. Henry Fowler, President of the Local Government Board, opposed the motion for ministry. But McLaren's motion was carried by a vote of 17 to 126. The announcement that the Government was defeated by a majority of 21 was greeted with ironical cheers from the Unionists and shouts of "Resign." Among those voting against the Government was Edward Blake, from Canada.

An International Case.

NEW HAVEN, Conn., Nov. 17.

Bryan E. Lynn, Captain in the Hibernian Rifles, is likely to become a subject of international correspondence between Great Britain and the United States. Lynn was formerly in the British army, and was sentenced to imprisonment for refusing to obey orders to evict tenants in Ireland. He has always boasted that he escaped from the military prison and would be subjected to punishment if he should be captured anywhere in British possessions. He leaves in a few days for England. It is supposed that he will rely on the States to protect him.

Train Wrecking.

QUEBEC, Nov. 17.

Another attempt was made at Lorette to wreck the C. P. R. train from Montreal. Ten dead, laden with stones, were placed across the track in the night. The section man saw the obstruction, and told his father and the latter notified the Superintendent at Quebec, who despatched an engine with men to clear the track, just as the train passed. This is the fifth attempt to wreck trains at that place.

Hallow'en Shooting Case.

MONTROSE, Nov. 4.

The preliminary investigation of the Hallow'en shooting case is concluded. Theodore Gogan and his two sons are accused for trial at the next session of the Kent County court.

Mill Burned.

MONTROSE, Nov. 17.

Humphrey & Trites' Mill, at Petticoat, has been destroyed by fire. Loss, \$1,500.

Obituary.

NEW YORK, Nov. 17.

William H. Beers, ex-President of the New York Life Insurance Company, is dead.

ST. JOHN'S, Nov. 17.

Chief Justice Allan is improving. GENERAL TELEGRAPHIC NEWS.

LONDON, Nov. 15.—The scarcity of coal caused by the miners' strike has made it impossible for the town of Clitheroe, county of Lancaster, to get the necessary supply for the gas houses and all the streets are in darkness. The mills, shops and public buildings were closed at nightfall.

LIVERPOOL, Nov. 15.—Mail advices from Anglo, west coast of Africa, say: The Liberians have taken the town of Cavally from the hostile natives and burned most of it as a result of Cheeseman's bombardment. Cheeseman was still holding the Englishmen whom he arrested for non-payment of duties.

ROME, Nov. 15.—The Pope has completed his encyclical on biblical study, mention of which was made in these despatches some months ago. His Holiness in the encyclical, gives rules for the interpretation and the methods of solution of biblical difficulties.

OTTAWA, Nov. 15.—Hon. Messrs. Foster and Angers returned from the Northwest today. In an interview the Finance Minister said: "Naturally every person wishes to pay as light a burden of taxation as possible, and I found the people of the Northwest no exception to this rule. Most are of the opinion that from their peculiar position they get fewer benefits from the general development of manufactures than do other provinces, and whilst perfectly willing to pay their fair share of this country's burdens, they are desirous of having easements in certain directions. These they have fully talked over with Hon. Mr. Angers and myself and they are hopefully awaiting the action of the government in the matter."

LONDON, Nov. 14.—In the House of Commons today, Sir Charles Russell, the attorney-general, stated in reply to a question of the Duke of Edinburgh, now the reigning duke of Saxe-Coburg and Gotha, and who, prior to his accession, was an admiral of the fleet of the British navy, is not now entitled to perform active service in the British navy. Therefore, he received no pay, and has made no claim for compensation. Mr. Gladstone added that the duke would be allowed to retain his place on the navy list, without pay, as a mark of honor for his long and distinguished services. His heart, Mr. Gladstone further said, had always been in his profession, and it would be a matter of great pain if any change should occur that would in any wise weaken his relations with great Britain.
