Continued from page 6 the charge against the accused. He said the cigarettes were the property of H. C. Fortier Co., Montreal, and asked the jury to put them on their minds all the evidence they had heard last week. First Witness The first witness called by the Crown was Mr. Joseph Legace, secretary treasurer of H. C. Fortier Co., who stated his firm were the sole agents for Macdonald's Tobacco in New Brunswick, Prince Edward Island and Quebec, and the local firm of J. C. Montgomery was the only representative in this Province. Under questioning he started to describe the manner in which business was conducted between his firm and Mr. Montgomery. Defense counsel, Mr. Allison Gillis, objected on the ground that if there were a contract between the two it should be produced. As the questioning continued, however, the witness stated that some orders received from here are turned over to Macdonald's for direct handling, some shipped from his firm's Montreal stock and the rest delivered from the consignment stock in Mr. Montgomery's warehouse. Regarding the sale of Exports in this of "flat fifties" he stated there were none shipped here prior to November as they had been in short supply all year. He had a record of all that came here and told the Court which wholesalers had been the consignees. He stated that no one else could get Exports as they only shipped to legitimate accounts, however under cross examination by Mr. Gillis he was not prepared to say it would be impossible to get Exports from some other company. On objection by Mr. Gillis to the "hearsay" nature of the records introduced the Court noted the objection. A number of witnesses holding positions as shipping clerks or other posts in wholesale business firms of the Province testified as to the number of Exports their employers has received. All shipments of flat fifties were received in November for the first time. They included David Murray, R. T. Holman Ltd.; Ft. Sgt. L. H. Kelsey, R.C.A.F.; Roy Johnson, Rogers and Arnet, all of Summerside; Patrick Read, DeBois Bros.; William Partridge, Atlantic Wholesalers. Miss Kathleen Morrison, Carvell Brothers, and Mr. Wallace Higgins R. E. Mutch, Ltd., also testified and when cross examined stated that their firms had been short on shipments arriving by Canadian National Railway. Fortier Co., Montreal, and asked the jury to put them on their minds all the evidence they had heard last week. First Witness The first witness called by the Crown was Mr. Joseph Legace, secretary treasurer of H. C. Fortier Co., who stated his firm were the sole agents for Macdonald's Tobacco in New Brunswick, Prince Edward Island and Quebec, and the local firm of J. C. Montgomery was the only representative in this Province. Under questioning he started to describe the manner in which business was conducted between his firm and Mr. Montgomery. Defense counsel, Mr. Allison Gillis, objected on the ground that if there were a contract between the two it should be produced. As the questioning continued, however, the witness stated that some orders received from here are turned over to Macdonald's for direct handling, some shipped from his firm's Montreal stock and the rest delivered from the consignment stock in Mr. Montgomery's warehouse. Regarding the sale of Exports in this of "flat fifties" he stated there were none shipped here prior to November as they had been in short supply all year. He had a record of all that came here and told the Court which wholesalers had been the consignees. He stated that no one else could get Exports as they only shipped to legitimate accounts, however under cross examination by Mr. Gillis he was not prepared to say it would be impossible to get Exports from some other company.
