A Rose By Any Other Name

The anonymous writer who shoots from ambush is a difficult target to hit and all the more so when they are two (2) of them, when No. 1 professes to believe that a farm organization using the "Union" tag would be more effective than a federation. Personally we are still inclined to believe that the value of any organization depends on the interest of the members and on the quality of the leadership available, changing the name from federation to union would not likely effect any marked improvement in either.

Basically a federation is a joining together of organizations while a union is a joining together of individuals. Thus the P.E.I. Federation of Agriculture is at once both a federation and a union. There may well be some difference of opinion as to whether the Federation has died off. We question that the North-Winsloe farmer believes the statement himself, if he does he must be one of those individuals who believes in beating dead horses.

The second writer signing himself farmer from St. Peter's asks why the annual meeting of all federation directors was not opened to the public. This matter has already been dealt with in previous news letters but we may further state that the constitution provides that only directors are eligible to vote at such a meeting. This provision would appear to indicate an intention on the part of those who framed the constitution to confine the meeting to directors elected by the members and member organizations. Further the Provincial Board decided that the meeting should be conducted in this manner in order to provide the elected directors a full share of the available time for the discussion of problems related to the organization.

In view of the fact that the federation held 12 general meetings throughout the Province in the 12 months previous to the annual meeting, meetings which were open to all members and attended by many who were not members we feel that farmers were provided with ample opportunity

to be heard. The closing paragraph of the letter in question states that in 1933 membership declined by 2000 in 1933. This statement is inaccurate by at least 700%.

We still maintain that in spite of a drop in individual membership in this Province that farm organizations in general are gaining ground all over the world and will continue to increase in prestige and influence as more and more farmers realize the possibilities in group action and the impossibility of the individual exerting any worth while influence upon the forces which operate far in the background, and affect the farmers way of life.

To the advocate of a farmer's union, we may say that we are not opposed to the aims and principles of these groups but we are concerned with the lack of results which will develop with two organizations competing for the farmers' support and each claiming to speak for the industry. "For If The Trumpet Give An Uncertain Sound, Who Shall Prepare Himself To The Battle?"

Manitoba Marketing

There is no disputing the fact that the Manitoba Federation of Agriculture and the farmers Union do not see eye to eye on the question of the Marketing Board for all livestock. The federation is committed to promoting a Hog Marketing Board and feels it has a mandate from its members, but does not at the moment have the support of a sufficient number of farmers for an all inclusive Livestock Board.

The Manitoba Federation realizes the importance of agreement on the part of a majority of farmers before such a Board is feasible and likely to be successful. The statement that the Federation is sabotaging the plan of the Union is at once unfair and untrue.

Potato Resolution

Following resolution originated in a farmers meeting in this Province, a meeting which was not called by the Federation. The resolution indicates considerable thought and an understanding of the numerous difficulties which beset the industry.

1. WHEREAS the potato producers of this Province and elsewhere have no say in setting a price for their product and must accept whatever is offered them.

2. And WHEREAS the production and marketing of potatoes here and elsewhere has always been more of a gamble than we think necessary, often resulting in severe losses to the producer.

3. And WHEREAS the producers of potatoes must pay what is asked for the materials and equipment used in the production of farm produce.

4. And WHEREAS the larger Dealer-Growers are steadily increasing their potato acreage and their ability to flood our markets by supplying individual farmers with fertilizer and other materials for the production of potatoes on a sub-par basis. This we feel, has a tendency to persuade the farmers to plant more potatoes than they otherwise would, thereby encouraging over-production to the detriment of the average farmer.

5. And WHEREAS the larger Dealer-Grower is now producing potatoes in both the southern States and in this province and supplying the market with their own grown potatoes in addition to their sub-contract here and on which they receive commissions and discounts on fertilizers, spray materials, containers, etc. used and supplied, thereby giving them an unfair advantage over the average farmer.

6. And WHEREAS the individual farmer will never know how many potatoes to produce in conjunction with other farmers to supply the market or be reasonably sure of receiving a profit for his labours, until a proper organization is formulated comprising all Producers in North America.

1. THEREFORE be it resolved that we commend the P.E. Island Farmers Federation for endeavouring to improve the average farmer's situation in this province by obtaining federal and provincial legislation for the operation of a Potato Pool, which has given us better than average prices for our potatoes, both here and in the United States during a year when a large surplus exists on both sides of the border.

2. THEREFORE be it further resolved that we commend the officials of the Potato Pool for obtaining a single freight zone in this province by their agreement with the Canadian National Railways.

3. THEREFORE be it further resolved that we suggest to the Farm Federation of this province that it endeavour to work out some solution to this pressing problem in conjunction with the Potato Pool, then solicit the support of the Federal Farm Federation, the federal and provincial governments of Canada, the American Farm Union and the federal and State governments of the U.S.A. in order that something concrete may be done to eliminate waste and confusion in this important phase of farming, and at the same time safeguard the producers and consumers, the taxpayers of both nations.

4. THEREFORE be it further resolved that we suggest the following as an example of what may be done: That a guaranteed price of \$1.50 per bushel be guaranteed to all producers who are farm owners or lessors in each State and province, by way of special tags, based on a percentage of his land at 200 saleable bushels to the acre. The percentage to be based on the average number of bushels sold in each State and province during the last ten year period. Provincial and State statistics to be used in determining the number of bushels disposed of.

As a further example, supposing this province sold potatoes produced on 14% of our clear land, then provide farmers with special tags, at 200 saleable bushels to the acre for say 10% of his clear land. Therefore, farmers with 100 acres clear land would receive special tags for 2,000 bushels, this would net him \$3,000 at \$1.50 per bushel. Any surplus produced could not be placed on the market until all special tagged potatoes were sold, and he would have to take his chance on price and of marketing them at all after special tagged potatoes were disposed of. By keeping the supply of special tagged potatoes well below the required amount to supply the market, it would leave the market very strong until disposed of, and no potatoes could be obtained from the Potato Pools unless it would net each farmer, in every State and province, \$1.50 per bushel.

Bank of Montreal First In Housing

Ottawa, March 31—(CP)—The Bank of Montreal made history in the last few days. It was the first chartered bank to make a loan under the bank in ment's new housing legislation. The bank's loan, involving some \$900,000, will be used to erect some 84 houses in the Pointe Claire area on the west side of Montreal island. The builders applied for the mortgage and Housing Corp. approved the loan three days after it was filed with the Pacific.

First Bank Housing Loan For Pointe Claire Project

\$900,000 Loan Goes to Builders Here Under New Federal Housing Legislation

First housing loan to be made by a chartered bank in Canada is to be devoted to the erection of 84 homes in the Pointe Claire district, to be built in three sections. It was announced today.

The chartered bank involved is the Bank of Montreal, which has made a loan of some \$900,000 under the terms of the Federal Government's new legislation.

Builders are Sunny View Development, Inc., of which the president is K. M. Lawler, and the architect is Y. Meer of New York.

The builders applied for the loan last week shortly after the new legislation had been proclaimed permitting banks to enter the mortgage-lending field for the first time. Local real estate brokers disclosed some weeks ago that widespread interest was being shown in the legislation by American interests.

Loan Approved Central Mortgage and Housing Corporation approved the loan three days after it was filed with the bank.
