CONVINCING EVIDENCE.

The story about Hon. Dr. Montague, though evidently absurd, was repeated, last evening, by the Patriot. It was reiterated in the telegraphic column under such headlines as "The knell of doom," "Told once more," "The campaign in Ontario really abandoned," etc. It was affirmed in the editorial with the remark that "the Tories here stood aghast at the intelligence," and the statement that "after a restless night spent in the hope that the Patriot's despatch would prove unfounded, the faithful awoke to find their worst fears realized by the confirmation of the Patriot's despatch in this morning's 'Guardian.'"

A FEW HARD FACTS.

The Canadian exports of agricultural products and of animals and their products were in 1878, \$32,027,000. In 1895 they were \$50,106,000. The farmers of Canada last year not only produced enough to feed nearly a million more people than were in the country in 1878, but there was sent abroad their output \$18,000,000 worth more. Their business is increasing. The exports of the products of the fisheries (home production) were in 1878 \$6,563,000. In 1895 they were \$10,692,000. The fishermen's business has grown. The exports of mineral products were in 1878 \$2,816,000. In 1895 they were \$6,983,000. The miners' business has grown. The exports of forest products were in 1878 \$19,511,000. In 1895 they were \$23,891,000. The lumberman's business has grown. The exports of manufactured articles, etc., were in 1878 under \$6,000,400. In 1895 they were nearly \$8,000,000. The market abroad for the product of Canadian workmen's industry has grown also. The number of tons of freight carried by Canadian railways has increased from 7,883,000 in 1878 to 21,521,000 in 1895, a growth of nearly 200 per cent. The number of passengers carried has grown from 6,443,000 to 13,987,000, a growth of over 100 per cent. The earnings have grown from \$20,520,000 to \$46,785,000, a growth of 130 per cent. In 1878 the measurement of vessels bound coastwise arriving at and departing from Canadian ports was 11,047,000 tons; in 1895 it was \$25,473,000 tons, an increase of over 100 per cent. We have compiled these figures from the Montreal Gazette, and they may be relied upon as exactly true.

THE RECORD OF THE BANKS.

Mr. WILLIAM WEIR, President of the Ville Marie Bank of Montreal, has addressed a letter to the electors of the County of Argenteuil, in the course of which he says that he found the Bank of Montreal stock quoted at 181 in 1874 and at 125 in 1879, a loss to the shareholders of \$57,200,000. He found the Ontario bank quoted at 105 in 1874, and left it at 53 in 1878, and the Montreal bank at 108 was brought down to 58. The Toronto bank paid for the country's experiment with the Liberals by a depreciation of 78 per cent. The Jacques Cartier Bank not merely found its stocks reduced from 104 to 27, but had to wipe out \$1,500,000 of its capital. The Merchants Bank wiped out \$3,000,000 of capital, and a further loss of \$2,395,000. The Eastern Townships Bank suffered a decline from 116 to 90. The Union bank was reduced from 101 to 49. The Bank of Commerce stock fell from 120 to 95. Nor were the banks alone in this disaster. Montreal Telegraph stock declined from 174 to 81. Dominion Telegraph fell from 100 to 60, and Montreal street railway declined from 174 to 75. The losses involved in this depreciation of stock, it is further stated, ran far into the millions, to say nothing of the actual wiping out of capital stock amounting in itself among the banks alone to nearly seven millions of dollars. We may rest assured that the bank losses were but a small portion of the losses to manufacturers, merchants, country storekeepers and the farming community. The directors of the Eastern Townships bank in their report for 1879 declared that since 1876 disaster had followed disaster until at length almost the only remaining profitable business was that of the official assignee. A revenue tariff in 1896 will lead to similar results, but the disaster will be greater as all the interests have been enlarged.

Mr. George Hague of the Merchants Bank writing to the Commercial Bulletin of New York in 1891 was able to say: "Since 1878 the value of our bank stocks has increased \$27,000,000. Bank and other savings deposits have increased \$110,000,000. Bank discounts have increased \$67,000,000. The facts and figures here quoted ought to convince everyone that the National Policy should be adhered to."

IT IS A CRY OF ALARM.

The Globe sticks to its yarn about the twelve million dollars appropriated by secret orders-in-Council for railway subsidy purposes, but intended really to be gobbled from the treasury and used in bribing the electorate. It is wonderful, says the Mail and Empire, how this story grows. The Globe commenced with ten millions, and then, regretting its moderation, raised the figure to twelve. Fearing that its character for mediocrity would suffer under the Globe's competition for the bet, the Montreal Witness promptly increased the sum by a million. "A laker's dozen of millions of dollars," it says, "is a big price, a great amount to gamble on." But—note the Christian faith exhibited by the organ of the Mercier thieves—"we are not much afraid of the effect of money in this election." The Patrie adds half a million to the amount. It finds that the sum to be stolen is \$13,500,000. As the invention journeys eastward it grows. Possibly, says our contemporary, by the time it gets down to Nova Scotia we shall find that Sir Charles Tupper has really got away with a hundred millions, and has deluged the country knee deep in boodle. It is such to be regretted, for the sake of the Liberal party, that Sir Charles Tupper has stamped the yarn as false. The boodle story, continues the Mail and Empire, is really a yell of alarm. As it trends the air the friends of a progressive Canada and of peace and good will among men take courage from it, and renew their efforts to achieve the success for which they are working.

THE REVENUE TARIFF FAD.

The Montreal Star remarks that "Revenue tariff, now getting by its original supporters, is commencing its death blow in the United States. The Democrats tried a 'revenue' tariff and almost bankrupted the nation, as every farmer, every mechanic, every merchant and every manufacturer in the Union sadly know. Is it at all likely that the people of Canada are willing to risk a season of 'revenue' tariff madness, even for a change of Government or for the chance of avenging many of the Government's sins? Sir Richard Cartwright, one of the ablest, and we are ready to grant, one of the sincerest, while one of the most stubborn politicians Canada ever produced, would, his friends admit, insist upon carrying out the 'revenue' tariff idea, though the country should go to the dogs. A few years of national poverty and panic afflicting the Canadian people, such as our American friends have been cursed with through their 'revenue' tariff, would set back the trade and commerce of the Dominion twenty years, would breed dissatisfaction with the colonial tie, because dissent trends to revolution, would breed discord, would discourage all kinds of business enterprise, and, in all probability, would disrupt the Dominion with consequences every true Canadian would deplore but which not all Canada could redress. A revenue tariff needs only to be analyzed impartially to show its utter absurdity."

WHY THEY CHANGED.

Mr. A. F. McINTYRE, Q. C., of Ottawa, formerly a member of the Liberal Association there, said recently: "It would be nothing short of a calamity if the people should endorse Mr. Laurier's trade policy. The mere suggestion of such a policy, in the event of a so-called Liberal success, is at the present time disturbing the trade of the country. How much more will it disturb and unsettle trade if, upon a Liberal victory, it should be put into operation. This is not a time, in my mind, for tariff experiments. If our people should be so stupid as to support a policy at the coming elections as would be absolutely an experimental one, they will see such a further drop in values as the country has never experienced."

Mr. F. H. Hale, formerly the Liberal M. P. for Carleton County, New Brunswick, now the Liberal-Conservative candidate there, said at a recent meeting: "He was elected before by the Liberal party, but he had not been long at Ottawa before he was convinced that they were not the best party for the interests of the country. Their greatest aim and object appeared to be to get themselves into office, regardless of what the consequence might be to the country. And he saw that he could not work conscientiously with that party he decided then to go out of politics. At the dissolution of that Parliament he put his decision into effect, and it was only now at the earnest solicitation of numerous voters that he had again consented to enter the field. This time he was working with a party with whose general trade policy he was in sympathy, as he believed it to be the best policy for the country."

Mr. Henry Carleton, Q. C., ex-President of the Reform Association of Hamilton, Ontario, said at a recent meeting: "In coming over to the Conservative party it had taken all the courage he could command, but it was with him a question of principle, and he had to do it. Those who knew him best knew he could not talk or advocate anything unless he believed in it himself, unless, perhaps, it was a losing fight. (Laughter.) He believed the Conservative party to be the party of progress and development in Canada—the Canadian party, the loyal party. He had felt this for years, and had only remained in the reform ranks because he had hoped to convert them to some settled and better principles. The Reformers want us to fold our hands and let our land be flooded with foreign-made goods. Our duty is to aid home industries. It is now the duty of every citizen of Canada from Halifax to Vancouver to take off his coat and vote for the National Policy. The greatest interests of the country are at stake, and we should work to promote it. There are good reasons. Can anyone show better?"

CAMPAIGN NOTES.

The wearing of "Tupper" and "Laurier" buttons will be illegal on and after nomination day. Advice from St. Louis state that the friends of the Reform candidate, Mr. McKimley, will undoubtedly be the Republican nominee for President. The people of the United States have had enough of tariff tinkering and its consequent disasters, and McKimley's election is a foregone conclusion. The Montreal Star says Mr. M. J. F. Quinn's candidature against the notorious Jimmy McShane in St. Ann's Division has been received with great enthusiasm by all classes, and adds: Mr. Quinn in the next few days will make St. Ann's division ring with an eloquence not heard from any other Irishman since the days of McGee and Devlin.

The Toronto Globe publishes a number of interviews, the effect of which is that if the Premier tries to speak in Toronto, his Ottawa experience will be by comparison a benediction to what he will receive from the Laurierites in the Queen City. The Montreal Gazette remarks that the Globe's friends must be deeply afraid of the effect of one old man's speech. The Winnipeg Tribune, Mr. Martin's chief paper, published a fac simile of a letter from Editor Willison, of the Toronto Globe, appealing to Winnipeggers to vote for Martin and national schools. The Conservative paper there than Mr. Willison for his patronizing condescension and tells him that any time he has another dose of the "big head" just to write another similar letter, as if he relieve him and won't let people up here in the least. One paper editorially asks if this Mr. Willison is not editor of the chief organ of the Mowat abolition, which resists every effort to abolish separate schools in Ontario.

The last issue of the Vancouver World comes across the continent containing a denial from Mr. Laurier that any combine was negotiated between the Patrons, McCarthys and Liberal-Conservative union against the Government. It reads somewhat curious in view of Grand Secretary Weloh's more recently printed expose. In the same column in which it printed Mr. Laurier's denial that a Liberal-Patrons-McCarthy combine existed, the Vancouver World published a warning to its readers to "beware of Tupperian falsehoods during the campaign." A real down-to-earth partisan newspaper contains many funny things during an election fight.

Mr. Laurier has been begging the people of Montreal to send Mr. Prefontaine to the House of Commons. It is of Mr. Prefontaine that the Liberal Montreal Witness lately said: "The man who ran the city council for the benefit of the monopolies. The city is poorer by his being in the council. A record which is a scandal to the city of Montreal. No voting record can begin to denote him or to measure the badness of his influence. Whoever has been on the people's side, he has never been. He has probably cost the city more than all men before him put together. It would be a criminal folly for Hochelaga, or any other ward, to return him again to the council. And the worst of it is, as the St. John's Witness is true, The Witness said worse of Mr. McShane, and he joined Mr. Laurier at a political meeting in favor of Mr. Prefontaine. Truly with Tarte, Pacaud, Cook, Cameron and such men, we have a happy Liberal combination. Better keep them in Opposition."

SUPREME COURT.

FRIDAY, JUNE 12. Alice D. Stewart, administratrix of D. Stewart, vs. John Lacey, an absent debtor. In this case the Judge non-suited the plaintiff, but granted a rule nisi, returnable first day of Trinity Term, to show cause why the judgment should not be set aside and a verdict entered for the plaintiff for the amount claimed. James McLeod and John A. Brace—Court makes same order. The Queen vs. William Banks—In this case the Judge reserved judgment. The Queen vs. John Perry—The prisoner was sentenced to two years in the penitentiary. The Queen vs. Wm. Lynch—Prisoner pleaded guilty to two charges. The Judge sentenced him to three weeks in the common jail, and directed him to enter into recognizance to come up for sentence in the other cases when called on, and addressed the prisoner and told him that if his future conduct rendered it necessary to call him up for sentence, he would receive the extreme punishment that could be given him. Court adjourned at 3 o'clock.

A copy of the sixtieth annual report of this company, presented to the annual general meeting of the proprietors, held at Liverpool on the 20th May last, has been sent to THE EXAMINER by the general agent. The fire premium income for the year 1895, after deducting the sums paid for reinsuring surplus risks, amounted to \$1,603,098 sterling, or \$7,801,743 60 currency. The losses, inclusive of full provision for all liabilities arising in respect of the globe of the year, amounted to \$278,251 sterling, or \$1,374,154 86 currency. The company had therefore a most successful year. After payment of the sums and charges due to the shareholders, the reserves were largely increased. The total assets of the company now amount to \$3,708,495 17s 1d sterling, or \$47,248,013 13 currency. The Canada branch of the company, as appears from the last report of the superintendent of insurance at Ottawa, are \$1,713,602 79.
