Weapons Museum Opens At Park
As part of the Centennial Historical exhibition a representative collection of British arms is open to the public in the Victoria Park museum. The collection includes arms from the time of George I to the time of Queen Victoria, starting from the flintlock period, on to the percussion, the snider, the cartridge and ending with the Martini Henry period.

Also included is a series of pistols from the flintlock to the cartridge period with a specimen from each type, and the Walker collection of small arms. The Col. Moore collection of uniforms includes spurs, full dress, levee dress and mess dress coats, a dressage officers dress case, and a service siffers dress case, and a service siffers. From Captain Allen B. Cosh are represented brass buttons from the various regiments of the British Army. The Hunter-Duvar collection includes a drum used in the Crimean War, a pillbox, pouch and bugle from the Imperial Army.

Visiting Here From South India
Mr. G. Raja Gopal, of South India, is visiting Charlottetown with the intention of staying here for about a year. He left India a year and a half ago, and has been travelling in the United States, lecturing up and down the Atlantic seaboard on Indian life and culture. Now he hopes to continue his lectures in Prince Edward Island, particularly to the children in the schools, to help increase understanding between East and West. Born and educated in the State of Travancore, South India, Mr. Gopal received his Bachelor of Science degree from the University of Travancore, and then went to the state of Mysore where he worked as a journalist and cartoonist. In Bombay he was a free-lance writer and travelled all over India for his information; he also worked on the editorial staffs of various Indian newspapers. Mr. Gopal is interested in the life and culture of a people rather than their politics, and intends to write a book when he has completed his travels. He has received personal training in psychology and education under the tutelage of Dr. Natarajan. After he leaves this country, Mr. Gopal will proceed to South America to continue his lecturing before leaving for home. He will endeavor to create an understanding of Western ways among his own people.
