### Seek New Plan To Keep Textile Plant Open

MILLTOWN, N. B. (CP)—Can the Textile Sales Ltd. plant here be saved from impending shutdown by the employees operating the factory as a co-operative venture?

The fate of this border town's sole industry depends upon the answer, expected to come at a meeting Thursday afternoon between union, management and leaders in the co-operative movement.

Rev. Howard Grace, minister of St. Stephen's church in neighborhood of St. Francis Xavier University, Antigonish, N.S., where he studied under the leaders in the co-operative field, will report there is only one feasible approach. That would be for the British Co-operative Textiles to take a hand in organizing and developing the plant as an overseas branch.

WORDS AWAITED  
Mr. Grace said Monday this possibility would be thoroughly explored at the meeting and word would be received as to whether BCT is interested in the proposal.

At an earlier union meeting the co-operative idea as conceived by John Whitehouse, Toronto, national education and publicity director for the Textile Workers Union of America (CCL-CIO), was presented. Mr. Grace pledged his support to the pioneering venture, which he claimed was sound and could be made to work in Milltown as it had elsewhere. In Scotland he said, co-operative textile mills have been operating efficiently and effectively for 50 years.

Mr. Grace was returned to St. Stephen from a four-day trip through Nova Scotia, during which he interviewed experts in the co-operative movement and arranged for their appearance at the coming meeting.

## Steel Union Head Critical

By JAMES F. TOMLINSON ATLANTIC CITY, N.J. (AP)—The United Steelworkers of America, during the past week, have criticized President Truman's economic program and called for a major new approach.

But president David McDonald stopped short of telling the biennial USW convention just how he stands on whether the giant union should get out of the CIO, as it has been reported the USW might do.

He held the 3,000 delegates from the United States and Canada that he would discuss later in the week the steelworkers' "relations in the organized labor movement."

However, McDonald said the 1,200,000-member union must seek a third course in the trade union movement from what he called the present two approaches.

"MUTUAL TRUSTESHIP" This course he termed "mutual trusteeship" in which the union and industry would work together. Both, he added, are trustees of the steelmaking industry and are responsible for mutually profitable production.

"I firmly believe that we must constantly change our approach to problems," the union chief said. "We never have and we never will accept the status quo."

To accept the status quo is to "fall by the wayside," he said.

McDonald criticized the trade union movement here and abroad as being "split down the middle into two distinct groups" and said neither of the two is suitable for the steelworkers.

"One of those groups has the Marxist approach," he said, without mentioning any names.

The other, he added, has a selfish "bread and butter" approach which says we will get all we can and the devil take the hindmost."

MIGHT QUIT CIO McDonald mentioned the CIO only once in his speech Monday, and that was only a passing reference.

The mention was in connection with the ouster of the International Union of Mine, Mill and Smelter Workers (Ind.) from the CIO in 1950 for alleged Communist domination.

McDonald said his union was making "some progress" in signing up Mine-Mill workers who want to leave the old union and warned the AFL to stop trying to do the same.

"It's our jurisdiction," he said.

## Jap Premier Facing Split In Own Party

TOKYO, (Reuters)—Prime Minister Shigeru Yoshida, accustomed to constant attempts by opposition parties to discredit and unseat him, Monday faced a new and unexpected threat from within his own Liberal party.

With less than a week left before Yoshida is due to set out on his long delayed overseas tour, veteran Liberal party founder Ichiro Hatoyama declared he would organize a new conservative party "under a new leader."

Hatoyama conferred Sunday night with Mamoru Shigemitsu, president of the right-wing opposition Progressive party.

Afterwards they issued a joint statement saying they planned to organize a committee to form a new conservative party on Oct. 1, after Yoshida's scheduled Sept. 25 departure on a tour of Canada, the United States and Europe.

## U. S. LIMITS MUNITIONS

SEOUL (Reuters) - A South Korean army leader charged Monday the United States has restricted his army's ammunition and fuel to a two-day supply to prevent any offensive against North Korea. Maj. Gen. Choi Duk Shin said the rationing "is the United States answer to the South Korean plea for unification of the country."

## Claim Americans Lose 5 Million In Fraudulent Canadian Oil Stocks

NEW YORK (AP) - Attorney-General Nathaniel Goldstein of New York said Monday four Canadian corporations and nine individuals "took the American public for over five million dollars" in fraudulent oil stock sales.

He announced that a temporary injunction had been issued restraining the defendants from securities dealings in New York City pending a hearing Oct. 28.

An aide of the Attorney-General called it "the largest fraud case in 15 years" handled by his office. Goldstein's remarks were contained in a statement issued to newspaper men at a press conference.

Goldstein said an estimated 10,000 persons bought the stock - about 8,000 New York state residents, 1,000 other Americans and 1,000 Canadians.

The attorney-general said the defendants are "charged with fraudulent practices in the sale and trading of the stock of Gaspe Oil Ventures Ltd., and Quebec Oil Development Ltd."

The promoters, said Goldstein, "lured a swelling stream of American dollars by fraudulently portraying a gushing picture of oil prospects in the Gaspe region."

This was done, he added, despite the fact "the Canadian government indicates that to date there has been no commercial production of oil in the Gaspe peninsula although drilling has gone on for almost 10 years."

He named one of the chief defendants as Paul Payette of Montreal, described in a prospectus of Gaspe Oil Ventures Ltd. as the firm's president, general manager and a director.

NAME EIGHT OTHERS Goldstein said Payette was also the chief officer of Quebec Oil

Development Ltd., Regal Investments Ltd., all of Montreal.

Other Canadians named were John Vanier, Miss Lucienne Demers, Armand G. Boisclair and Roland Demers, all of Montreal.

Also named in the injunction were Sidney D. Blue, Larchmont, N.Y.; Theodore J. Smutny and Milton Epstein, both of New York City; and Raymond G. Buser, Paterson, N.J.

Goldstein said financial statements of Gaspe Oil and Quebec Oil "falsely listed their operational losses as assets, thus misleading investors."

"Because of a flood of literature containing false and misleading statements and representations, the market price of Gaspe stock rose some 600 per cent and that of Quebec Oil over 200 per cent, despite the mounting losses," Goldstein said.

The defendants, he said, allegedly sold more than \$3,000,000 worth of Gaspe Oil and Quebec Oil stock between 1946 and 1951 at 60 cents a share for Gaspe and a dollar a share for Quebec Oil.

Other shares, said Goldstein, were sold over the counter in New York City and on the Montreal stock exchange at prices ranging from \$4.25 a share for Gaspe and \$3.25 for Quebec Oil.

He added: "The full extent of the manipulations may perhaps never be known because Payette under oath admitted he destroyed his personal cheques, statements and records and those of his two holding companies, the defendants Regal Investment Ltd., and Consolidated Holdings Ltd."

A 1945 prospectus of Gaspe Oil made available to newspaper men showed that drilling was planned some nine miles west of Gaspe village where the firms had half a dozen claims for gas and oil purposes.

## Women Up In Arms Over Two Wives

JAKARTA, Indonesia (Reuters) - Four women, representing angry women's organizations throughout Indonesia, called on President Achmed Soekarno Monday to ask him why he has taken a second wife.

As a Moslem the president is entitled to four wives - if his first wife gives him permission. But, the women claim, the first Mrs. Soekarno did not agree to him marrying Mrs. Soekarno No. 2 - a beautiful divorcee with five children.

The four women, headed by Mrs. Katowilono, a leading feminist who precipitated the row by calling on all women's organizations to discuss the matter, spent an hour with Soekarno. When they left his palace they all refused to comment.

Soekarno, 52, has four children by his first wife. His second marriage took place three months ago and plunged him into a political crisis which may threaten the existence of his government.
