Farmers Urged Not To Destroy Trees Along Line Fences

During the past summer, it is surprising the number of trees that have been cut along line fences, state officials of the forestry division, Provincial Department of Industry and Resources. It seems as if people were getting tired of seeing trees bordering their fields and decided to remedy the situation. That these same trees might serve some use, other than shade, never occurred to them. The sheltering effect of a single row of trees along the edge of a field has three-fold effect:

- (1) The trees prevent evaporation of soil moisture and thus make more of its available to the plants.
(2) The trees increase soil temperature at the critical period in the spring.
(3) The trees prevent mechanical injury to plants caused by continued wind agitation.

The slowing down of the wind starts a whole chain of favourable climatic influences, such as reduction of evaporation, moderation of temperature and increase in relative humidity. All of these influences result in increased yield of crops grown under the protection of sheltering trees.

It is surprising too that not more conifers are planted as windbreaks around homes and buildings, the officials state. "A single windbreak on the north of a building will save twenty-five per cent of the fuel requirements for the winter. When a windbreak protects both the north and west, a saving of thirty-four per cent can be expected. It has also been proven that cattle and horses when protected by windbreaks, require less feed and gain in weight more rapidly. Do not cut your windbreaks. The many advantages they have far outweigh any disadvantages they may seem to have."

A resident of Springton was fined \$10 and costs or 20 days for failing to report an accident as required under the Highway Traffic Act. Three residents of St. Amand's pleaded not guilty to charges of possession of "wash" and were remanded for one week with bail set at \$50 each.

May Take Numerous Workmen From P.E.I.

Applications for employment in construction work at Goose Bay, Labrador, are being completed daily at the National Employment Office. The company is not accepting many men at present, but will be taking on several thousand from all over the Maritimes starting in March. Those who are applying at the present time are being told that they will likely be needed in the spring. The men who recruited here last summer were carefully selected, and were not accepted unless they were well recommended by former employers. It is understood that the medical requirements are not so rigid now, although there has been no letdown in the company's insistence on character reference. The men who will leave the Island this spring will, for the most part, return here next winter. It is believed that at least five hundred men will make application for work at Goose Bay, during the winter and early spring. This will be quite a drain on the man power of this Province, and it might result in a scarcity of labourers and construction workers on the Island this year.

All of those who apply, of course, will not be accepted but even if two or three hundred men leave the Island, it will be quite noticeable, especially if any considerable number of them are tradesmen, such as carpenters, electricians and plumbers.

Well Known Priest Dies In Montreal

Word has been received here of the death in Montreal this week of Rev. William J. McCabe well known clergyman of this city where he had served for many years. A native of Iona, he had held several parishes in the Diocese and in recent years had been on the staff at St. Dunstan's Basilica until his illness of two years ago.

During the past World War Father McCabe had served as Roman Catholic chaplain with the Army and was beloved by all the troops with whom he came in contact. A forceful speaker, he was also a splendid raconteur and entertained friends on countless occasions with his reminiscing.

He is survived by his father, Mr. John McCabe, Iona, one sister, Mrs. James McGarry, Charlottetown, and four brothers. They are Maj. Pius McCabe, of Ottawa, and Stephen, Michael and Frank, all of Iona. The remains are being sent here for burial and pending their arrival funeral arrangements have not been announced.

MacDonald Estate In Chancery Court

A bill of complaint in the estates of Samuel Albert MacDonald, Charlottetown, who died Aug. 30, 1904, and his widow Mary MacDonald who died Nov. 24, 1946, came before the Court of Chancery for hearing yesterday. Vice-Chancellor George J. Tweedy presided. The complainants, executors and administrators of the estates, desire the sale of real estate on the corner of Hillsborough and King Streets to be administered by the Court.

The defendants, the heirs-at-law of the testator and residuary legatees of the widow for the most part represented by counsel and the case will probably be treated as an application for an accounting.

When the court adjourned until 2:30 p.m. on the 25th Mr. J. A. Bentley, K.C., was in the midst of a discussion of the laws of inheritance in this Province, maintaining that the word "heirs" when used here has a statutory meaning at variance with the common law, the class who take on an intestacy rather than heirs-at-law as generally understood. The testator devised one half of his residuary estate to his heirs and the other half to the heirs of his wife with power to sell during her lifetime.

Attended Meetings Street Cars Running Of Field Officials Again In Toronto

TORONTO, Jan. 23 (CP) - Street-cars began running again in Toronto today. One motorman got a kiss. That was the only recorded "ceremony" as service resumed after a strike that for 19 days kept the familiar red trolleys and buses of the Toronto Transportation Commission off the streets. It was bestowed by a woman upon the broad forehead of Claude Jackson soon after he pulled out of the car barn at 4:47 A.M.

The strike was over. The cost still was being reckoned. The strike of 4,768 operators ended last night with an agreement to arbitrate the men's chief demand—a wage increase of 15 cents an hour. They took the five cents offered by the commission, a publicly-owned corporation, and talk today among the city's labor leaders was that it was a "hard-peace."

Whether the men receive more than the five cents, which brings their wage to \$1.45 an hour, depends upon the decision of an arbitrator to be appointed by Labor Minister Daley of Ontario who helped to effect the settlement.

Notwithstanding the state of weather and the streets the attendance at the annual congregational meeting of Trinity United Church last night, was gratifyingly large.

The meeting was held in Heartz Memorial Hall, and opened with devotional exercises conducted by the senior minister, Rev. H. E. D. Ashford. Lt.-Col. G. E. Full was then called to the chair and Dr. Steel and Mr. E. E. Clawson were appointed joint secretaries. Instead of reading the minutes of last year's meeting at length, a committee, through Mr. C. H. Black, reported that they appeared to have been correctly recorded, and that there was no business arising therefrom that called for consideration.

For the Session, Dr. Steel reviewed generally the activities of the ministers, the additions to the membership of the church, the losses through death, and matters of religious instruction.

Mr. G. Hartley reported for the stewards, showing the generous financial support given by the congregation to the business affairs of the church. The amount of these contributions had increased by over \$13,000 since 1940. A detailed financial statement was presented by Mr. Alex McLeod, the treasurer.
