SERVICES AND SERMONS YESTERDAY.

PRINCE STREET METHODIST CHURCH.

"GIVE" AND "FORGIVE."—The Rev. J. Lathern, the popular and esteemed pastor of the Prince Street Methodist Church, preached two excellent sermons yesterday. His theme in the morning being "Give" and in the evening "Forgive." It was really a rich treat to sit and listen to the eloquent discourses referred to above. We would recommend their publication in pamphlet form, or a repetition of their delivery, a public announcement to be made of the time and place.

ST. DUNSTON'S CATHEDRAL.

His Lordship Bishop McIntyre celebrated High Mass in St. Dunstan's Cathedral yesterday at 10 o'clock. At the Gospel his Lordship ascended the pulpit and spoke at some length on the good work which had been done in the community by Father Glackmeyer's mission.

He also spoke on the parting requests of that gentleman, viz: To establish an Orphanage and Hospital and to take proper means to banish from our midst the monster Intemperance. On the latter he chiefly dwelt, and urged the congregation to organize, as it was the only means by which any good might be done. He stated that it was his intention to form a Diocesan Temperance Society, which would centre in Charlottetown and spread its branches throughout the different parishes of the Island. For this purpose he had held a meeting of the Island clergy and instructed them in the matter. He requested the co-operation of every member of the congregation.

A meeting was held last evening in connection with the St. Patrick's Society. A branch of the Diocesan Society was formed with about one hundred and fifty members. It will be organized at a meeting to be held this evening in St. Patrick's Hall. All friends of the movement are requested to attend.

SECOND METHODIST CHURCH.

ENGLISH MAIL.—The English mail from Liverpool, G. B., arrived at St. John Nfld. on Thursday. It will be delivered at the Post Office in this city this evening.

SMELT fishing is being very successfully engaged in at Bathurst. Some exporters are sending forward 1,000 lbs. per day to Boston and New York. The prices range from six to eight cents per lb.

STAMPSHIP "Prince Edward," to Peake Bros. Co., with full cargo of general merchandise from Glasgow and Liverpool, arrived here on the 25th inst.—16 days passage. Captain Fraser reports having experienced very heavy gales, with head winds, during the whole passage. Ralph B. Peake, Esq., was a passenger by the "Prince Edward."

The steamer Acadian sailed for Picton this forenoon in ballast. The Athlra due here on Thursday, from Montreal, has not yet arrived. The M. A. Starr is expected to arrive from Halifax to-morrow morning. The Island boat sailed for Picton this morning at 9 o'clock.

The Halifax Herald's article on finance and commerce says: "In the United States the markets for our exports are fair. The better grades of apples about hold their own at \$3.25 to \$3.50. Good brands of mackerel are wanted at high prices. Dry fish is in light supply, with a firm feeling. Labrador herring are quoted at \$5.75 to \$5.80. Provincial coals are marked in New York at \$5 per ton. Cod oil ranges from 53 to 55 cents for American, and 60 cents for best English. Potatoes hold the market well in hand, receipts not overruling the demand, and prices keeping well up to paying figures. Early Rose are quoted at \$1.50 to \$1.75; other grades from \$1.25 to \$1.50."

Local and Other Items.

SMALL POX.—There are fifteen cases of Small Pox in the Civic Hospital at Montreal. A banking clerk at that place contracted the disease by handling filthy bank notes.

The Allan steamers will no longer go to Portland, but will make Baltimore their winter port. The mails and whatever passengers or cargo offers for Canada will be landed at Halifax and forwarded over the Intercolonial Railway. The Dominion and Beaver lines will run in connection with the Grand Trunk Railway to Portland.

EXPRESS.—We learn from Mr. Theo. J. Chappelle, Agent of the Intercolonial Express Co. in this City, that the express business will be continued during the winter months by steamer Northern Light. This will be a great convenience, and the enterprise deserves every success. The business during the past season has been admirably managed, and gave universal satisfaction. Residents of the City have had their goods promptly delivered at their residences; and those residing along the line of railway and through the country have received their consignments without delay.

REFORM NEEDED.—Mr. Dutcher is needed in Richibucto. There are three Temperance Societies in existence in this small town, but only one holds meetings. The Beavers are completely done up; they go crawling about with their tails between their legs and their heads down, looking sad and dejected. The Sons of Temperance only exists in name. The old warriors of that renowned body, who in days gone by fought the good fight, have laid down their arms and retired from the field. The Kent Lodge of British Templars is on the verge of death; it is sinking rapidly, and will soon expire. The enemies of Temperance can now rejoice and be merry, for they have conquered.—Moncton Times.

A DRUNKEN MOTHER KILLS HER CHILD.—A child of Mrs. Jeffers, living on the Barrack Square, was killed by her intoxicated mother a few days since. Many reports as to the way in which the child met her death have been in circulation. Yesterday morning it was said that the child died from the effects of a blow received in the forehead by a bottle which had been thrown at the mother by Wm. Callaghan; but last evening the Chief of Police stated that the mother had sat on the child until life had become extinct. If the other rumors regarding the manner in which the child came to its death have any foundation in fact, immediate steps should be taken for an enquiry into the matter. There were no marks of violence to be observed on the body of the child at the time of its burial. Sergeant Hayes is endeavoring to ascertain the facts of the case.—St. John News.

ENCOURAGEMENT TO MANUFACTURES.—The Halifax Herald thinks the resolution passed by the City Council, of that city, on the subject of giving encouragement to new manufactures, is a move in the right direction. The remission of taxes and rates for a term of years is a small boon, but in very many cases it is the extra taxation that keeps some manufacturers from coming to the city. Some months ago the Herald made a proposal which would now fit into the subject of encouragement to small manufacturers. This was to erect double rows of workshops in some of the upper street blocks, to be run by power supplied from one steam engine, which could be so located as to be connected with belting and shafting. Wood turners, brass finishers, boot and shoe makers, nail and tack cutters, workers in wood and metals and various other light industries, could be furnished with motive power at low cost.

A DAY'S DOINGS IN YARMOUTH, N. S.—Friday, 16th inst., was fruitful of local "events." The steamer "Edgar Stuart" took fire in the oil room at 6 1/2 a. m. Bells rang an alarm, and the engines were started, but the fire was extinguished by a fire extinguisher on board without serious injury being done.—A colored lad, recently from the Penitentiary, broke into a store at Milton, was detected in the act, pursued, captured, tried and sentenced by the Stipendiary Magistrate to six months' of jail life with hard labor.—A colored man stabbed a Frenchman with a pocket knife, on Clements' Wharf, for which he was sentenced to three months in jail, and the Frenchman, in consideration of the provocation he gave, got a sharp and well-deserved reprimand from the Magistrate, and was mulcted in costs of trial.—Two professional gentlemen had a fracas in one of the public offices, resulting in a trial before the Stipendiary and a fine of \$20 imposed on one of them, with costs.—A young girl made an attempt to commit suicide, but without success; the matter has been kept quiet, and "mum" is the word.—There was a sudden death of a married lady, and there were two funerals.—Yarmouth Herald.

A FIERCE CONTEST.

Additional Levies.

GOURKA ACROSS THE BALKANS.

CONSTANTINOPLE, Nov. 25.

A proclamation has been issued calling out 150,000 civic guards to maintain order in the absence of the regular troops. Christians are summoned to participate in the levy.

A New York cable dispatch says: A Russian expedition consisting of fresh divisions of the Imperial Guards and all the regular cavalry and Cossacks of the Guard, under Gourka, crossed the Balkans into Roumelia.

A Pera dispatch of the 22nd says: "The views taken of Osman's position are wholly desponding; and some maintain that he has abundant provisions to hold out until Mehmet organizes an army of relief.

A Constantinople dispatch gives a doubtful rumor which was current on Saturday that Osman had forced the Russian lines.

LONDON, Nov. 23.

A dispatch from Bucharest says: "A great battle is proceeding at Tirnova."

LONDON, Nov. 23.

A dispatch from Vienna says that so far from being weakened, the Czarowitch's army now consists of eight infantry and four cavalry divisions, numbering from 80,000 to 90,000 men, and thought it must overline from the Danube to the vicinity of Tirnova. It will not be easy for the Turks to make much impression upon it, since the Russians, by forced marches, can concentrate three or four divisions on any given point in a single day.

A Cettinge dispatch says the wounded Montenegrins arriving report that on Sunday night divisions of Plienezak moving toward Scutari found the Turkish forces entrenched near Anomalite, behind three lines of breastworks extending from the hills to Boyana. Assault was made by 600 volunteers, who carried the first two lines; but on attacking the third found themselves opposed to a much superior force of Turks, and were beaten back with a loss of between 20 or 30 killed and 100 wounded, when the attack was abandoned. This affair shows that the statement that the right bank of the river was entirely in the possession of the Montenegrins is unfounded. The locality of the battle was about half way between Anpar and Scutari. Ali Saib previously reported from Scutari that 4,000 Montenegrins had attacked the position defending the road from Antivari to Scutari, and were repulsed, losing 300 men.

The Times correspondent says: "The movement appears most injudicious and useless. Since after the opportunity of taking Scutari by surprise has been lost, it was practically impregnable, and any aggressive movement in that direction was objectionable, while any Turkish movement for relief of Antivari with their present force could easily have been beaten.

The Prince has been reported at Vir, but no telegrams are permitted from the army. We are ignorant of his object in going there as the headquarters remain before Antivari. The "Ministerial Freudenblat" says: "Austria has no occasion to make such a declaration, since her interests are already known. Moreover there are no indications at St. Petersburg, Belgrade or Cettinge to ignore the declarations already made by Austria."
