

Youth Night Featured At Special Services

The emphasis was on youth at the Baptist Church last night as the special evangelistic services continued under the inspiring leadership of Rev. Lawrence Atkinson.

Assisted by a large choir of young people, song leader Rev. Geo. Bell introduced several new hymns. Mr. Bell was also heard in a feeling rendition of the solo, "Why Should He Love Me So?"

A male quartet consisting of Evangelist Atkinson and Messrs. Bell, Condon and Davison, expressively sang "Must Jesus Bear the Cross Alone." Assisting Rev. J. D. Davison in the service were Miss Florence Matheson and Mr. Harley Condon.

Mr. Atkinson's sermon was directed especially to youth, using as his text the words of Paul to Timothy: "I have fought a good fight, I have finished my course, I have kept the faith."

Mr. Atkinson lauded the youth of the Maritimes for their interest in the Christian Church. He stated that in many cases they put their elders to shame.

He pointed out that in these days it was not easy to live a consistent Christian life; in fact the youth of today deciding to follow Christ must be prepared to make sacrifices.

Some young people accused devout Christians of being "killjoys" but he pointed out that in Christian service one may be supremely happy.

He advised young people to "keep the course" and to look to Christ in whom there were no flaws.

At the close of the service several young people signified their desire to begin the Christian way of life.

The services continue tonight when each person is expected to bring a guest.

Field Marshal Kesselring Freed

BONN, Germany, Oct. 23 (CP) — Field Marshal Albert Kesselring, one of Hitler's top soldiers, was freed today after serving five years of his prison term for war crimes.

British authorities announced that Kesselring, 67, was freed as an act of clemency because of his health. He is ill with throat cancer.

Erich Von Manstein, the other field marshal held by the British at Werl Prison, is also ill and is expected to receive his full freedom soon.

Kesselring was sentenced in 1947 to be shot for responsibility for the Hitler-ordered Ardennes Caves massacre in Rome in which 333 Italians were shot in reprisal for a bomb attack that killed 33 German police. His sentence was commuted to 20 years in prison.

APPEAL ALLOWED — The appeal of George Reid, Charlottetown, was allowed yesterday in the Supreme Court and his conviction and sentence quashed. Mr. Justice G. J. Tweedy gave judgment quashing the sentence of 12 months in jail imposed under section 26(5) of the Temperance Act on a charge of possessing for sale by retail of a preparation (Ray Rum) containing alcohol by an unlicensed person. Except for evidence on the lack of a license, all the evidence was heard again by the appeal court. The uncontradicted evidence of the appellant and his witness Fred Dooley was that the premises were in the possession of Dooley and that the Ray Rum belonged to him. Mr. Justice Tweedy ruled that as evidence under oath, until shaken, is entitled to some weight and cannot be swept away simply by saying that the witnesses are disbelieved, the appellant was entitled to the benefit of the doubt. Counsel for the appellant was Mr. A. M. Gillis, Mr. J. P. Nicholson acted for the Crown.

370 Dead, Many Missing In Typhoon — MANILA, Friday, Oct. 24 (AP) — At least 370 persons were killed and hundreds injured or missing in a typhoon that tore through the Central Philippines Tuesday and Wednesday.

The great storm—whose winds of unknown velocity whipped tree trunks through the air like match sticks—destroyed at least two cities with a combined population of more than 113,000 on Southeast Luzon.

The storm now is bearing down on the eastern shores of Indonesia, which still had not recovered from a typhoon and tidal waves that killed hundreds earlier this week.

Government agencies and the Philippines Red Cross sped relief to the stricken area of splintered homes and buildings, flattened crops and flooded towns and villages.

The Red Cross made the preliminary tabulation of 370 killed, 2,000 missing and hundreds injured. Hardest hit were the once thriving port of Legaspi a city of 80,000 population 20 miles southeast of Manila, and Tabaco, a centre of 33,000 population 20 miles north of Legaspi.

Two Canadian Soldiers Convicted In German Riot

BERGEN, Germany, Oct. 23 (Reuters)—A court martial today convicted two Canadian soldiers of leading an attack on a German hotel which resulted in 6,000 marks (\$1,500) worth of damage.

The two soldiers were Tpr. Evan Ernest Bryson, 29, of Lindsay, Ont., and Clarence Henry Jobson, 29, of Elk Lake, Ont. They will be sentenced Saturday. Brysons pleaded innocent and Jobson, guilty.

Witnesses testified the two men were the ringleaders of a gang of about 27 Canadian soldiers who went to the Deutsches Haus Hotel in Bergen, Sept. 30, to rough up a group of young Germans.

The Germans had allegedly beaten up or threatened Canadian troops in the area.

Two other soldiers involved in the incident will soon go on trial. They are Tprs. J. R. Riendeau of Montreal and E. A. McPhee of Kirkland Lake, Ont.

The hotel owners, Willi Hogrefe, said the Canadians "threw chairs and tables around, smashed windows and turned everything upside down."

Nineteen other soldiers are under open arrest pending the outcome of the trial.

Hard Coal Mine Owners Balk At Wage Increase

WASHINGTON, Oct. 23 (AP) —Hard-coal mine owners balked today at giving John L. Lewis the best of the \$1.90 daily wage boost which the government already has partly shaved down in the soft-coal industry.

Lewis, United Mine Workers president, was reported trying to get the anthracite or hard coal industry to grant the same wage raise in order to test the government's Wage Stabilization Board again.

The wage board has ruled that 40 cents of the \$1.90 soft coal raise would be inflationary and cannot be paid. This has led to a walk-out of 350,000 soft-coal miners.

Hard-coal operators told Lewis that they probably would face a strike of the 65,000 Pennsylvania anthracite diggers no matter what happened. Refusing Lewis the \$1.90 would probably mean a strike.

Granting the demand probably would lead to another partial veto from the Wage Board, and thus a walkout too.

The prospect was that the soft-coal strike would continue for some time, perhaps until after the Nov. 4 election, and perhaps with the hard-coal miners joining the walkout before long.

SARNIA, Ont., Oct. 23 (CP) — Delegates to the annual convention of regular Baptist Churches of Ontario and Quebec unanimously approved today the principle of amalgamation with the Fellowship of Independent Baptist Churches of Canada.

Rev. W. H. MacBain, pastor of Temple Baptist Church and president of the Union, presented the report of the Union liaison committee and put forward the resolution.

Delegates were asked to approve a motion that they recognize the desirability of coming together with the Fellowship provided basic Baptist principles embodied in the constitution of the Union be preserved.
