THE QUICKEST PASSAGE ON RECORD.

As will be seen by the following paragraph taken from the Cork [Ireland] Herald, of the 5th inst., that Capt. Jeremiah Crowley, with the Brigantine C. H. Trumbull, owned by John A. McDonald Esq., has made the passage from Malpeque [not Charlottetown, as stated by the Herald] in the unprecedented time of thirteen days and a half! Capt. Crowley is an Islander, a native of Princeton, and is a live man, and a very good specimen of our seafaring men. Long may he continue to make quick and prosperous voyages.

QUICK PASSAGE.—At a time when public interest is absorbed in the great ocean yacht race, which has been decided recently, and when the speed of these craft are the theme of newspaper writers, it may not be uninteresting to notice the achievement of a small vessel of far less pretensions than the Henrietta or sister yachts. On Saturday last, a brigantine called the C. H. Trumbull, 178, Capt. Crowley, arrived from Charlottetown, Prince Edward Island, with a cargo of oats. She left on the evening of the 12th instant, and allowing for difference of time, made the passage to this port in thirteen-and-a-half days. The C. H. Trumbull experienced some rough weather, but, generally speaking, the wind was favorable.

Capt. Crowley, in a letter dated Queenstown, Jan. 4th, 1867, to the editor of the Progress says:—"The Brig Talba, Capt. Campbell, was towed from here to-day for Liverpool. She was dismantled on the Grand Bank and came here with the jury-masts [that is, made two-thirds of the passage] in twenty-six days from Charlottetown. Great credit is due to the master for bringing her into port; but, you know he is one of our Island boys, and will not give up easily."

Capt. Crowley says he was ordered to London, and would sail on the next day, Oats dull, and selling at 3s. 2d. sterling.—Freights for large vessels dull, but small vessels in demand.—S. Progr.

LONDON, 28th.
J. Gordon Bennett offered the yacht Henrietta as a present to Prince Alfred. The Prince replied as follows:—"Clarance House, 22nd Jan. 1867.—Dear Mr. Bennett, I find it difficult to express how gratefully I appreciate the kindly feeling which dictated your letter of 31st ult., as well as the splendid present which you offer to my acceptance. But most of all I appreciate the feeling which you seek to diminish personal obligation, under which you would lay me by giving to your generous offer an international character, it is indeed this last consideration only

which led me to hesitate in replying to your letter, for personally it would be impossible for me to accept so easily a present, but I felt bound fully to consider a question in light which you were good enough to place it, and if on full consideration, I feel compelled to decline your generous offer, I trust that neither you nor your gallant competitors or your countrymen at large will believe that yachtmen of England less appreciate or less reciprocate the feeling of good fellowship which prompted the offer."

B., Jan. 30th, 1867.—A Despatch from Ottawa at New York says, official information has been received that Confederation on conditions agreed to at Quebec, is sanctioned by Imperial Government; also, that Prince Alfred will be the first Governor of the Confederated Provinces. Gold, 135. New Brunswick legislature prorogued to 28th February.—Boats arrived at Cape Tormentine at 2.30.—"Africa" arrived at Halifax at 9 a.m.

LONDON, 30th.—The members of British British Cabinet freely express the hope that the peace of Europe will be preserved in spite of threatening appearance of affairs in the East. Search of baggage of foreign Travellers in England and France hereafter will be merely nominal.

PARIS, 30th.—It is thought that the mission of Kalorges to the United States is an intrigue of the Russians to involve the American Government in the Eastern question.—Gold 135 5-8.—Boats crossing both ways; left at 8 o'clock.

St. JOHN, Feb. 2, p.m.—London, 31.—It is reported that Derby's Administration will fall to the ground if the forthcoming Queen's Speech at the opening of Parliament should not recommend reform. It is said that recent reforms granted by Napoleon, should be interpreted in the liberal sense that the authority hitherto exercised of suspending newspapers would be abandoned.—Gold 134 5-8.

To the Electors of the First Electoral District of King's County.

GENTLEMEN:—THE Twenty-second General Assembly of Prince Edward Island being about to expire, I beg to tender you my most grateful acknowledgments for the distinguished honor which, twelve months ago, you conferred upon me in selecting me to fill the vacancy in the Parliamentary representation of the District, occasioned by the death of my lamented friend, the late Hon. Donald Beaton. And, it being my intention to offer myself again a candidate for your suffrages, should you honor me with a repetition of your favor, you may rest assured that nothing shall be wanting which my humble efforts can accomplish to promote the prosperity and happiness of this my native District.

Although I have not been able, during the brief period of my Legislative connection with you, to perform such an amount of public good as under a more extended term of office, I might reasonably hope to accomplish; yet, I flatter myself that my endeavors to advance the interests of my constituents have not been exerted altogether in vain.

I should have addressed you at an earlier date on the subject of the approaching General Election, but impressed with the great cardinal maxim that "Union is strength," I have deferred the matter until the present moment, in hopes that our Charlottetown sages would present us with some plan of operation for the approaching campaign, in which we might all co-operate—some common platform on which the friends of progress and order "might all pull together." As it is most likely that the Land Question and Education, the Fisheries and Confederation, will occupy a prominent place in the deliberations of our next Colonial Parliament, it may not, perhaps, be premature on my part to declare even now, what my own peculiar views on these several questions are.

It being now almost unanimously admitted that the "Land Purchase Act," together with the "Act to assist Leaseholders in purchasing the fee simple of their farms," constitute the most effectual means yet devised for converting our leasehold tenures into freehold, I shall be ready at all times to give the most ample effect to the provisions of those statutes.

I have long indulged the opinion—and am still of the same belief—that the laws relating to Education should be so amended as, among other improvements, to enable the District Teachers to draw the entire amount of their salaries from the public purse. Such an alteration as I have here indicated would have been effected during the late Session had not Messrs. Laird and Howatt distinctly declared that their constituents would not submit to any change in the Educational system of the Colony which would involve the imposition of a single penny's additional taxation. Hence it was deemed advisable—the General Election being so near at hand—to defer the further consideration of the subject until the people should have an opportunity of expressing an opinion thereon at the hustings.

The uncommon natural facilities possessed by our Island fishermen being rendered almost nugatory by the abrogation of the Reciprocity Treaty, I will assist in any measure which may enable our people to compete successfully with the fishermen of the neighboring Republic.

I am still decidedly opposed to Confederation; and although I always respect the conscientious opinions of other men, howsoever widely those sentiments, political or otherwise, may differ from my own; nevertheless, I deny the right, in any case, of "a small minority of the people" to make laws for, or rule the majority. I shall, therefore, oppose any party, Liberal or Conservative, who will attempt to join this Island in a Federal Union with Canada. Who would deprive us of the inestimable privilege of making the laws that govern us, and surrender ourselves to the "tender mercies" of a people whose inordinate selfishness and extravagance have already brought their own magnificent country to the very brink of bankruptcy, and whose sectional animosities are fully as malignant as were those which provoked the late calamitous war in the United States, and drenched that once prosperous country in the blood of a million of its own subjects.

If time and other circumstances permit, I will call upon you severally before the election comes off, when we can enter more fully into any of the public questions of the day, than it is possible to do through a newspaper communication. In the meantime, I beg to subscribe myself
