OUR DAIRYMEN'S DISPUTE.

The dispute as to whether Mr. Dewar or Mr. Irving supplied the greater number of lbs. of milk to their respective factories in the past season is interesting; and it will be valuable if it should set on fire the emulation of the farmers as well as the two gentlemen named, and result in a much larger volume of milk and greater product of cheese and butter. Certainly, both Messrs. Dewar and Irving deserve great credit in any case. One of our correspondents—whose letter we cannot publish in full—remarks that, apart from the discussion, "something the dairymen of the Province would take a lively interest in is, a statement of the breeding, feeding and general management of those herds, including a statement of the average amount of milk produced per cow for a year, (say 1899)." We agree with our correspondent that this "would probably do more good than a score of lectures by imported professors, that do not fully understand our conditions."

KEEP UP THE STANDARD

The quality of our exports to the British market must maintain the highest standard if we are to capture that market at all and maintain our place in it. Dishonesty is as poor commerce as it is ethics. The dishonest or careless shipper is only preparing the way for his own ultimate loss. The whole of the people will not be fooled all the time; and, therefore, the shipper who thinks that because there is no inspection on this side he is going to gull the British public more than once is not wise. They have inspection on the other side and the British public is thus protected. The honest shipper is only too anxious to submit to inspection. The dishonest one ought to be caught and punished in a severer way even than in making a loss on his bad stock. But if no more severe punishment be inflicted, this latter will cure him.

OBITUARY.

It is with deep regret we chronicle today the death of Bernard Murray, which sad event occurred at his home, Emyvale, Lot 30, on Wednesday morning, the 14th inst. Deceased was an honest and industrious man, and by his indomitable energy and perseverance earned for himself an enviable position as a successful, independent farmer. Nor were these the only commendable traits of his character. Of a generous and obliging disposition he was always ready to assist a neighbor in his necessities and sympathize with him in his afflictions. Sober, truthful, honest and upright he was an exemplary member of the community in which he lived and was deservedly respected and esteemed by all who knew him. His death was a painful shock to his numerous relatives and friends, and will be deeply regretted by all who had the pleasure of his acquaintance. But, after all, it is in the home, where he was known and loved best, that that kind husband and affectionate father will be most sadly missed. Fortified by the last rites of the church by the pastor, Rev. D. B. Reid, his soul quitted this "vale of tears" in the full confidence of a glorious immortality. On Friday morning, 16th inst., his mortal remains, followed by a large concourse of people, were conveyed to St. Ann's church and interred in the adjoining cemetery. He leaves a sorrowing widow, five sons and four daughters to mourn their loss. Deceased was 60 years of age.

HONORED IN DEATH

Chaplain Thompson Buried With Full Military Honors

In a manner befitting his rank as a soldier, John R. Thompson, chaplain of the First Washington Volunteers, was laid at rest in this city, says the Morning Olympian, of Washington. With solemn music and muffled drum, adds the Olympian, the beloved spiritual director of our boys in the Philippines was followed to his last resting place by many mourning friends. The church in which for fourteen years he had been pastor was crowded to the doors on the occasion of the funeral ceremonies. At 9.30 o'clock in the forenoon detachments from Companies A and E, N G W., from Tacoma, arrived in Olympia on the steamer Norwood. The militia was under command of Major DeHuff, with Captain Dege in immediate command. Besides these officers there were present Colonel Joab, Captain Driscoll of Company A; Lieutenant Walker, Company A; Captain Brown, surgeon of the First Washingtons; Lieutenant Bothwell, of Company C, of the First Washingtons. The soldiers marched from the wharf shortly before 11 o'clock to Debbins' undertaking parlors, from where the remains of the chaplain were escorted to the First Presbyterian Church, to the solemn music of funeral dirges by the Capital City military band. T M Reid, Robert Frost, L G Abbott, Aaron Hartsock, Robert Marr and N S Porter, the Masonic pall-bearers, marched by the side of the hearse and bore the remains into the chancel of the church.

The funeral services of the Presbyterian church were then read, and a most eloquent sermon by the pastor, Dr. R. M. Hayes, was delivered. Rev. John M Pamment and Rev. M B Williams, Presbyterian ministers from Tacoma, were present and assisted in the services. Rev. Pamment read the scriptures and Rev. Williams offered prayer. Rev. Hayes' text was from 2d Timothy, 4: 7, "I have fought a good fight; I have finished my course; I have kept the faith." At the conclusion of the services the casket was again carried to the hearse and the funeral cortege started for Masonic cemetery. Besides the services at the cemetery a squad of the militia fired the usual military volley over the grave. The Rev. Mr. Thompson above referred to is a native of Suffolk, in this province.

Milk Supply.

Sir,—In the last issue of THE WEEKLY EXAMINER a correspondent signed "Truth" endeavored to meet my challenge laid down in a former issue of the same paper. This writer commences with a misrepresentation. I did not state "that Mr. Dewar supplied the largest amount of milk." I simply quoted figures that were no doubt authorized by the officials of Hazelbrook Dairying Company, and in order to settle who was the largest patron I asked others to produce their figures. Though "Truth" has been unable to prove that Mr. D. P. Irving has produced more milk than Mr. Dewar, an attempt is made to break the force of the eloquent

figures quoted by me by stating that this result was the work of two farmers instead of one.

Let me gravely inform your veracious correspondent that the Dewar herd of cattle always was, and is yet one distinct herd, that the farm on which they were fed always was and is yet under one distinct management, and that the business manager is Mr. A. E Dewar.

I don't attempt to deny that in the production of this large amount of milk, which netted \$1000, that Mr. Dewar, like Mr. Irving, had the able assistance of other members of the family. It will thus appear that Hazelbrook Company has not only the distinction of having the largest patron but also of paying the largest amount per hundred pounds of any factory in the Province, a result which is largely due to M. Dewar's business ability as President of the Company.

I have no desire whatever to belittle Mr Irving's efforts. As one of the pioneers of co-operative dairying he has not only rendered good service to the community in which he lives but also to the Province in general, and his great success as a dairyman will be a lasting credit to him.

It is only fair to Mr. Dewar to say that he has not the remotest knowledge of my personality. My only object in writing is to lay the facts before the public. I trust I have made myself clear.

In the meantime my challenge remains open.
