Champion male in the Hereford class was owned by Max Thompson and Sons, Victoria, and the champion female was shown by Miller Sanderson, North River. Reserve male champion in this class was owned by Fulton Sanderson and Sons, North River, who also showed the female reserve champion.

In the Angus judging, the champion male was shown by Harry Loane, Jr., Kilmuir, while Irving MacDonald, York, exhibited the champion female. Reserve champion male was owned by Lorne Watts, New Wiltshire, and the female reserve championship went to Irving MacDonald.

## Two Companies Reported Interested In Georgetown

A large American company is interested in acquiring an industrial site in Georgetown, it was learned yesterday.

Mayor Howard S. MacLean said he is expecting a team of surveyors from the firm within the next week.

The mayor is confident that as a result of the visit a plant will be set up in the town to employ a further 80 local residents.

One site under consideration is bounded on the south side by Water Street and on the east by the Canadian National Railway line, affording excellent access for materials arriving by sea at the adjacent government wharf or by direct road and rail connections.

The other site under consideration is to the north of the Bathurst Marine Ltd. plant and east of East Street.

The mayor said preliminary surveys indicate Georgetown is a very suitable location for this manufacturing industry. He did not identify the firm, but said it is one of the leading manufacturers in the world in its field and has been looking for a location in Eastern Canada for some time.

### Hearing Moves On Quiet Plane

WASHINGTON (AP) — In calm contrast to two days of stormy sessions, the House of Representatives committee on un-American activities moved Thursday toward a close of its questioning of anti-Viet Nam war witnesses.

It extended for three months the subpoenas of two witnesses who said they wish to have counsel, but whose lawyers withdrew Wednesday.

Thursday there was none of the electric atmosphere that characterized the first two days, nor a single commotion.

## Roman Catholic Priest Dies Following Three-Year Illness

A well-known and beloved Roman Catholic priest, Rev. George MacDonald, 63, died last night at the Sacred Heart Home in Charlottetown. He had been in failing health for three years. Father MacDonald was born at Blooming Point Feb. 2, 1903, son of the late John N. MacDonald and his wife, Catherine MacDonald.

He was educated in his home school and at St. Dunstan's University where he graduated in 1926. He studied theology at Holy Heart Seminary, Halifax, where he was ordained to the holy priesthood on June 24, 1930 by Archbishop O'Donnell.

Following his ordination he was curate at St. Dunstan's Basilica, Charlottetown 1930-31 and at Sturgeon 1931-32; he was administrator for Tracadie and Iona Parishes 1932-33.

He served as pastor for The Bree and Lot 11 parishes 1933-35 and as pastor for the Lot 11 parish alone 1935-37.

He became pastor of St. Margaret's Parish in 1937 where he remained until 1956 when he was transferred as pastor of St. Peter's Bay.

While at St. Peter's Bay he was forced to retire because of ill health on Oct. 14, 1963.

Surviving are a brother, Alphonse MacDonald, Charlottetown and a sister, Mrs. Joseph MacPherson, New Rochelle, New York.

Funeral arrangements had not been completed last night.

## 3 Killed En Route To Island

AMHERST (CP) Thomas Coffin, 17, of Halifax, remains in serious condition in hospital here following a car accident Wednesday which killed three Halifax teenagers.

The injured boy, believed to have been the driver of the car, is the son of Justice Thomas H. Coffin of the Nova Scotia Supreme Court.

Killed in the highway mishap were Alfred Fleming Wilson, 17, Cecil Patrick Lafferty, 18, and Garron Edward Whiting, 18, all of Halifax.

RCMP said the four boys were driving to Prince Edward Island when the car missed a curve on the left side of highway 66 at Lower Linden, about 27 miles east of Amherst.

The car went out of control, plunged down a 12-foot embankment and struck a rock, police said. At least two of the dead youths carried no identification, which hampered police efforts to trace next-of-kin.

Funeral services for the accident victims will be held Saturday.

### Speck Seems Indifferent In Court

CHICAGO (AP) — Richard Speck sat silent and indifferent Thursday while the circuit court subpoenaed two witnesses to determine his mental state on the night he is accused of killing eight student nurses.

Speck's lawyer, Gerald W. Getty, also requested that the experts ascertain the defendant's capacity to stand trial on murder charges.

Speck, 24, appeared thinner and more alert than when he was arraigned Aug. 1, but displayed little interest in the proceedings.

William J. Martin, assistant state's attorney, asked for time to study all the motions. Judge Herbert C. Paschen of the criminal branch of the circuit court adjourned the case to Sept. 1.

## Jury Urges Arms Owners Responsible

SAINT JOHN, N.B. (CP) — A coroner's jury Thursday night recommended that owners of loaded firearms involved in fatal shootings be held responsible.

The jury deliberated 40 minutes before returning a verdict of accidental death in the shooting July 25 of Mary Brenda Lee Smith, three-year-old daughter of Mr. and Mrs. Charles Edward Smith of Lancaster.

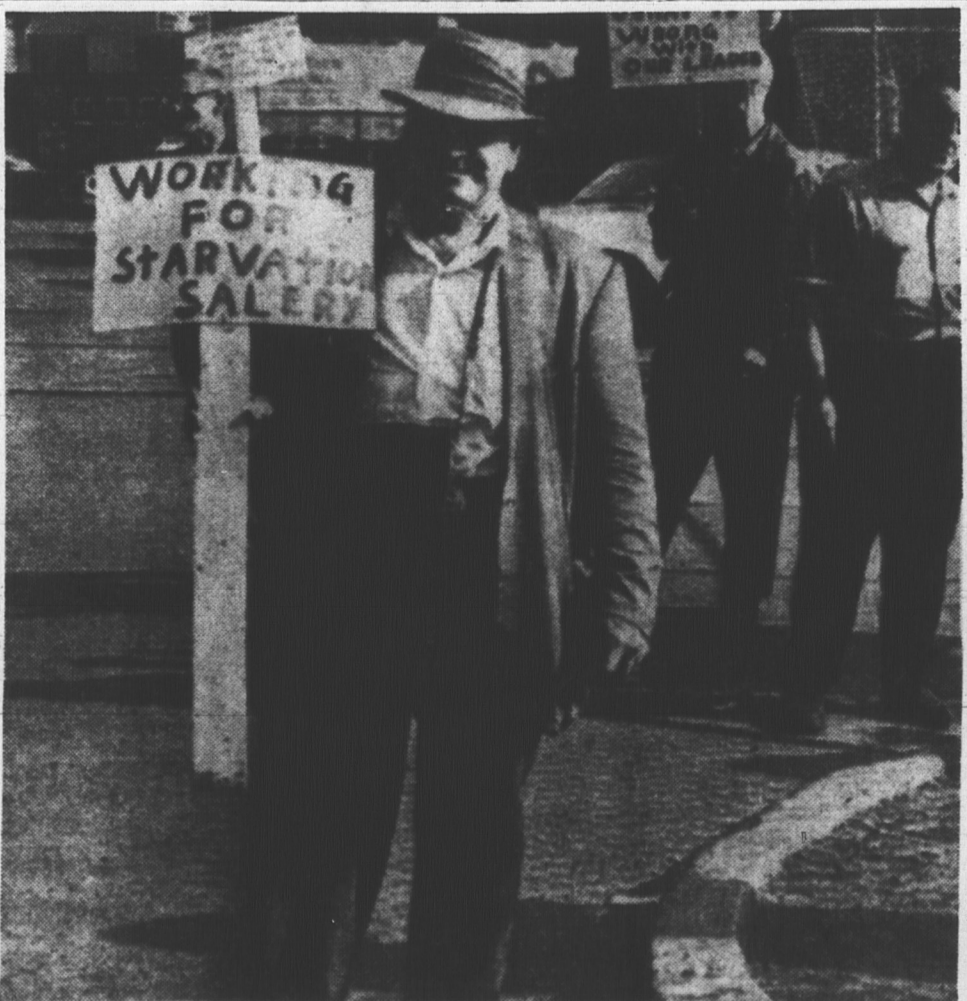
The girl died after being shot in the chest when a .22 calibre revolver held by a seven-year-old playmate accidentally discharged.

## Papp Returns From France

MONTREAL (CP) — Joseph Papp, who claimed to have crossed the Atlantic in a "submarine" built by himself, arrived in Montreal from Paris Thursday night by plane.

Mr. Papp looked tired and somewhat shaky as he disembarked at Montreal International Airport. He was greeted by his wife, 50 reporters and a group of policemen.

The officers—members of the RCMP, Quebec Provincial Police and the Montreal force—took Mr. Papp to a room for some questioning.

## 2,020 Jump Gun In Rail Walkout

MONTREAL (CP) — About 2,020 non-operating railway employees were off the job in the Montreal yards and one Ontario depot Thursday but CNR and CPR officials said no break in service would be caused.

At CNR's 3,000-man Pointe St. Charles yards—which service and repair passenger trains—1,800 men were on a wildcat strike.

The figure jumped by 800 from the noon figure after pickets yelling "scab" persuaded all but 200 of the 1,000-man night shift from entering the yards.

Some 100 electricians at the CPR's Angus repair depot walked out Thursday and 120 CNR employees at Windsor, Ont., were off the job.

A CNR spokesman said many of the 200 men who crossed the picket lines for the night shift at Pointe St. Charles are key workers, who, with the help of supervisory personnel, will be able to keep all trains running indefinitely.

**STAY ON JOB**  
The 1,800 off the job were mainly warehousemen, truckers, repairmen, laborers and clerks. Diesel mechanics, boiler-makers and electricians responsible for the day-to-day running of the trains remained at work.

Some of the 1,800 went to the CNR Bonaventure freight centre to picket but did not persuade the freight handlers to walk off. The centre has 800 workers on day and night shifts.

The pickets stopped about half the trucks serving the centre from entering Thursday, a CNR spokesman said.

Meanwhile in Windsor, Ont., some 120 members of the Canadian Brotherhood of Railway, Transport and General Workers on strike since midnight Wednesday, voted in a closed meeting to stay off the job.

Supervisory personnel have been called in to handle ticket sales but no trains have been halted and freight and passenger services are continuing as usual through the station.

All the men on the strike Thursday in Montreal were

members either of the CBRT or of seven unions affiliated with the shop-craft bargaining unit of Canada's 98,000 non-operating railway employees.

**OFFICIAL BOOED**  
CBRT spokesman J. A. Pelletier, who has called all the walkouts "wildcat strikes carried out against the wishes of their union leaders," was booed out of the Pointe St. Charles yard early Thursday when he turned up to urge the men to return to work. He escaped under police escort.

"I am not going back there," he said later. "These men are acting foolishly and I'd be wasting my time trying to reason with them."

The strike which has been growing almost hourly, began Wednesday when 90 members of the CBRT walked out at the Pointe St. Charles yard to protest against the slowness of wage negotiations with the CNR.

They jumped the gun on union leaders who are meeting in Montreal Monday to set a date for a nation-wide railway strike following tabulation of the results of a mailed strike vote of the membership.

Leaders representing three different bargaining groups of railway workers, who are responsible for jobs not connected with the actual running of trains, expected to choose either Aug. 29 or Sept. 6 as their strike date during Monday's joint sessions.

**MET UNION CHIEFS**  
Meanwhile, Prime Minister Pearson met with five union chiefs in Ottawa Wednesday for what he described as an informal briefing on labor's view of the threatened strike.

The prime minister told reporters the cabinet is preparing for "various contingencies" and would begin a special study of the situation Thursday.

The CBRT workers who left their jobs Wednesday night did so at the precise moment when a strike by their 22,000-member union became legal—seven days following rejection of a conciliation board report which was tabled in the Commons by Jus. (Continued on page 3, col. 4)

## Strike Date Reported Likely Aug. 29 Or 31

OTTAWA (CP) — A special cabinet committee met for another three hours Thursday to discuss latest developments in the threatening nation-wide railway strike, which could come in 10 days.

It was a follow-up to separate informal talks held Wednesday night between Prime Minister Pearson and railway union leaders and Transport Minister Pickersgill and railway heads.

There were reports in labor circles here that the unions are aiming for a joint strike deadline either Monday, Aug. 29, or Wednesday night, Aug. 31, after railway workers collect their end-of-month pay cheques.

Nobody in an official position would confirm or deny the reports.

Earlier it had been expected the strike would be called around Labor Day weekend but a scattered series of unauthorized walkouts prompted proposals for an earlier deadline.

The unions plan a formal announcement of the strike date Monday.

The cabinet committee apparently decided that no immediate crisis is likely before Monday.

Labor Minister Nicholson was scheduled to fly to Vancouver late Thursday for a weekend speaking engagement and a visit to his home area.

His office said he did not plan to return in the capital until Monday unless something unexpected developed on the railway situation.

Mr. Pickersgill's office said the transport minister planned to spend the weekend in Newfoundland but arrangements had been made to fly him back on short notice, if necessary.

The prime minister, who heads the eight-member strike committee of cabinet, leaves late Saturday for a Sunday meeting with President Johnson on Campobello Island, N.B.

## Toronto Broker Expelled From Stock Exchange Seat

TORONTO (CP) — The Toronto Stock Exchange announced Thursday it has expelled one of its members—the second time it has taken this action in its 32-year history.

The exchange said the expulsion of seat-holder R. A. Goodfellow means the firm Barrett, Goodfellow and Co. Ltd. no longer can use the exchange's trading facilities.

W. L. Somerville, executive vice-president of the exchange, said the action was taken following hearings concerning the firm's trading in shares of Analogue Controls Inc. during 1964 and 1965.

The board of governors of the exchange ruled that Mr. Goodfellow had "been a party to or

assisted in creating an abnormal market condition in respect to the shares of Analogue."

A statement issued by the exchange said "that in respect to certain information provided the exchange, the member attempted to mislead the board of governors."

The investigation by the exchange also decided that Barrett, Goodfellow had arranged fictitious transactions in regard to the registration of shares of Commodore Business Machines Ltd.

"As a result of the hearings, the board found that the method of business was unbecoming and inconsistent with just and equitable principles of trade."
