A Peruvian Novelty.

THE FIRST UNSUCCESSFUL ATTEMPT AT A REVOLUTION.

The following details have been received, regarding Caceres' raid on Lima, August 26. On August 24, Caceres sent a picked force of 1,300 men to make a flank attack on Callao. Part of the force was defeated on the 25th by government troops, and Caceres, finding his retreat threatened and being driven to bay, resolved to attack Lima. After his defeat, Caceres escaped to the interior with 80 horsemen.

Nearly 600 persons were made prisoners, including seventy officers, some of high grade, only a few of the Government soldiers being killed or wounded. Gen. Iglesias was shot in the leg which has been amputated. The people made no move in favor of Caceres, although he was supposed to be their favorite. The superintendent of the Apico and Orava Railroad has been arrested on a charge of favoring Caceres. The prior of St. Augustine has also been imprisoned and his community mulcted for concealing Cacerists. A large quantity of ammunition and arms fell into the hands of the government. This is the first revolution in Peru which has proved unsuccessful.
