THE MARKET.—Attendance and business at the market to-day was good. The supply except hay and potatoes was fair, with a slight change in prices outside. Inside, eggs sold at from 10 to 12 cents per dozen; butter (fresh) at from 17 to 19 cents per pound; but (tub) at from 15 to 18 cents per pound; fowl at from 55 to 60 cents per pair, and chickens at from 45 to 50 cents per pair. Outside, hay sold at from 65 to 70 cents per cwt; potatoes at 20 cents per bushel; oats at from 42 to 44 cents per bushel, and cod at from 3 to 6 cents each.

STEAMERS MOVEMENTS.—The Jacques Cartier arrived here from Pictou last evening about six o'clock, with a general cargo and some thirty passengers.

The St. Lawrence did not reach Summerside from Point du Chene until about seven o'clock last evening, and the foreign mail did not arrive in the city until about half-past nine.

The Folino will be due here to-morrow morning to load for St. John's.

The Nitadale will arrive here from Summerside to-morrow and will load for the old country.

Supreme Court.

The Supreme Court opened this forenoon, their Lordships the Chief Justice, the Master of the Rolls and the Vice-Chancellor presiding. The Grand Jury is made up of the following gentlemen, who were duly sworn: Thomas Morris, city, (foreman); Henry Hyde, West River; Jas Simpson, Bay View; Henry A. Holl, city; Robt Dixon, Lot 67; Philip Hughes, Mill Cove; Daniel Mullins, Ten Mile House; Richard C Goff, city; Lemuel E Prowse, city; George Mason, jr, Lot 48; Geo Matheson, Portage; Henry McLeod, St Peter's Road; A E Douglass, Hunter River; William Miller, St Peter's Road; John A Macdonald, Pictou; John McQuaid, do; Geo Forbes, Vernon River; Charles Strickland, city; Francis McQuaid, jr, Pictou; Wm McGrath, Mill Cove; Stephen Brown, Little York; D O'M Reddin, jr, city.

After the formal reading of the Queen's proclamation against violation of the Lord's Day by drunkenness, immorality, vice and debauchery, the Chief Justice delivered his charge to the Grand Jury. He said that there were three important criminal charges to be considered. The first was against a man named Larter for administering drugs to a girl named McEachern, causing her death. The crime in this case was either murder or manslaughter, or an attempt to procure a miscarriage. All these are serious charges. Death has been caused; life has been taken. Murder is an act done with premeditation, resulting in the death of a person, whether the death was intended or not. Manslaughter is an incautious, unpremeditated act resulting in death. Abortion is one of the highest crimes known to the law. In this case the evidence seems to be very strong so far as the depositions go.

The other serious charges are one against a girl named Luby for perjury, and a boy named Pearson for house-breaking. These would demand the attention of the Grand Jury.

The following cases were tried before Mr. Justice Hodgson, without a jury: Alex McKinnon vs Donald Beaton—Action on account. Judgment for plaintiff for \$77.07. W S Stewart for plaintiff.

Duncan Darrach vs John G McPhail—Action for damages for the seduction by the defendant of the plaintiff's daughter. Mr Justice Hodgson gave judgment for the plaintiff for \$350 damages. Mr Stewart for plaintiff; Mr Warburton for defendant.

When giving judgment in this case, Mr. Justice Hodgson said that the law did not permit, and very properly did not recognize, that an action should lie by a woman against a man for having seduced her. Proceedings might be taken by her under the Seduction Act, but they were strictly bastardy proceedings for the support of the child. But the father of the woman had a right of action if the woman lived with him; and it is just as well that young men should know and understand that if they led a girl astray, and they were forced to pay \$150 or \$200 awarded under the Seduction Act, the girl's character had nothing to do with the matter at all. It is the father who is the injured one. If the defendant were a man of property he would give much heavier damages than he intended to do.

But as he was a young man without property, living with his father, only moderate damages, which there might be a probability of collecting, would be awarded. He would give judgment for \$350. Of course this was quite independent of any proceeding which the girl might choose to take.

Stephen Brown vs Albert Essory.—Action for damages sustained by plaintiff resulting from a collision on the highway between the carriages of plaintiff and defendant, now before the court. Mr. Stewart for plaintiff; Mr. Good and Mr. McLean for defendant.

Re application of Albert Ernest Ings for admission as an attorney of the Supreme Court.

The court on motion of Mr. Morson granted an order for the examination of applicant.

There were three important criminal charges to be considered. The first was against a man named Larter for administering drugs to a girl named McEachern, causing her death.

The crime in this case was either murder or manslaughter, or an attempt to procure a miscarriage. All these are serious charges.

Death has been caused; life has been taken. Murder is an act done with premeditation, resulting in the death of a person, whether the death was intended or not.

Manslaughter is an incautious, unpremeditated act resulting in death. Abortion is one of the highest crimes known to the law.
