Assault Case Is Adjourned On Evidence Completion

Yesterday afternoon's session of the Queens County Magistrate's Court, saw the completion of evidence in the case of Daniel Tweel, Charlottetown, who is charged with assaulting Archibald Murchison of Point Prim by striking him in the face with his fist. At the conclusion Magistrate James B. Johnston adjourned the case until Friday, Dec. 11th for judgement.

At one time during the session and while the accused was on the stand an objection raised by defence counsel J. O. C. Campbell, resulted in the complainant being ejected from the court. The objection was against remarks being made by Murchison while the accused was giving evidence.

Defence witness James Leal, RCN, on the staff of HMCS Queen Charlotte, said he had been in the Tweel Restaurant on the evening of the incident, sitting in a back booth.

At one time during the evening he said he had seen the accused go over to one of the front booths and speak to the occupants and then return to the counter, to serve some customers.

SAW SWING Tweel, he said, went to the booth a second time and again spoke to the occupants following which he saw the complainant get up. He then saw Murchison place his glasses on the counter and square off at the accused at whom he took a swing which Tweel managed to duck.

The witness said he then saw Tweel swing at the complainant hitting him between the eyes and knocking him to the floor. He said that Murchison then got up and that the accused pushed him down again. The next thing he saw was the city police arriving.

Under cross-examination by Gerald Foster the crown prosecutor, the witness said that the accused leaned over the table when he went to the booth, but he did not see the accused shake Murchison.

DUCKED BLOW He estimated that when the complainant swung at the accused he was two or three feet from Tweel, and the latter avoided the blow by ducking. Murchison made no move toward the accused when the latter was taking off his glasses, he said.

In reply to a question the witness denied that he had said that Tweel had pushed Murchison down a second time, during the giving of direct evidence. Asked if Murchison was intoxicated at the time, the witness said he could not say how intoxicated the man was, but he would consider that due to liquor he was "not feeling any pain."

ACCUSED ON STAND Taking the stand in his own defence, Tweel said that Murchison in company with a Mr. Con-

nolly came into the restaurant at about 5 p.m., they were both seated at their feet and appeared to have been drinking. Being a rush period he said he had decided not to ask them to leave and gave them their orders in the hope that they would finish and leave of their own accord.

Later he said that a young man went and sat in the booth with the two men and when he got up and left, Murchison got up from his seat and went over to the counter where the witness sold him some cigarettes.

Tweel said that while he was up at that end of the counter he observed that the table at which Murchison and Connolly had sat was covered with a mess of food and coffee.

After seeing the mess, the accused said that he then went over to the two men and asked them to pay their bill and leave. Murchison, he said had replied that he would pay the bill but would not leave until he was ready to do so.

Tweel then stated that he went back to the counter to serve some other customers and then returned to Murchison's booth and repeated his request that they get out.

Neither man made a move, he said so he grabbed Murchison by the coat sleeve and pulled him out of his seat at which time the complainant started cursing the accused in a loud voice.

Tweel stated he took Murchison by the lapel of his coat, and shook him, following which the older man took off his glasses and laid them on the counter. The accused said that he then took off his own glasses which he just had time to do before he had to duck the swing that Murchison made at him.

STRUCK FOOTREST Not sure as to whether or not the complainant would again swing at him, the accused said he took no chances and swung, striking Murchison between the eyes. When the latter fell, the accused said that he had struck his face on the footrest running along the front of the counter.

While Murchison was on the floor, Tweel said he noticed Connolly preparing to swing at him, so he grabbed the latter by the shoulder and threw him to the floor.

Following the arrival of the police, the accused stated that he had told them he did not want to make any trouble for Murchison and asked the police to take the latter home.

In reply to a question by Mr. Campbell, the accused said he did not notice Mr. Murchison being taken away by the police and did not know if he was placed in the back or front of the patrol vehicle.

At this point Mr. Campbell interjected, that usually most drunks were picked up and thrown into the back of the patrol, but there were some who were placed on a pedestal and later brought into the courts as a complainant.
