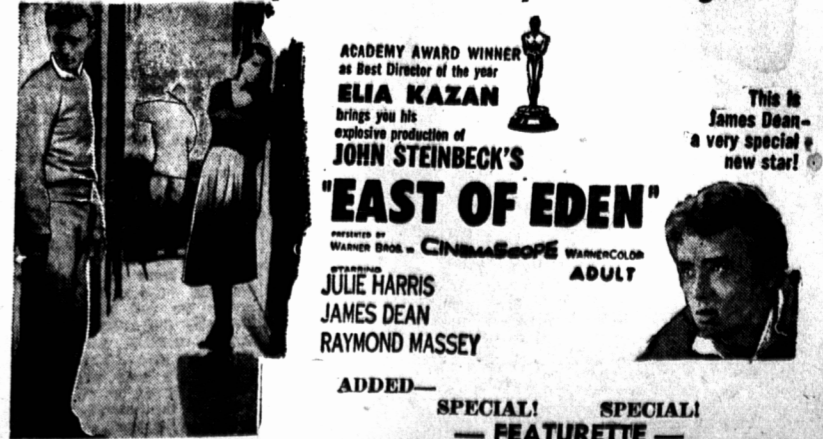

U. S. Dentist Shocks Moscow Tourist Office

MOSCOW, (AP) - Dr. Berthold Schulz, a Chicago dentist, blithely parked his British jeep outside the Kremlin walls Tuesday, strolled into the National hotel and flabbergasted Soviet tourist officials.

He told them he wanted to drive the jeep through the Soviet Union and come out by way of Iran or Czechoslovakia.

Schulz had driven to Moscow from Helsinki, Finland—first foreign tourist since the 1917 revolution to do so—apparently unaware of the stir he was causing.

The tourist officials just didn't know what to do when presented with the request. "They seemed puzzled," Schulz reported.

This failed to surprise foreigners who live in Moscow. They are not accustomed to jumping into an auto and driving around the Soviet Union at will. The majority are unable even to obtain Soviet driving licenses.

The greying, 48-year-old dentist got a 30-day Soviet visa in Washington and went to Britain, where he bought the cream-colored Land Rover jeep.

When he arrived at the Finnish-Soviet frontier, the Finnish guards scurried for an interpreter, who asked him "do you really want to go to Russia?" Schulz replied he did.

The Finns shrugged their shoulders, but they raised the border barrier and let him go. A lone Russian sentry was on duty 30 feet away. He fired his rifle twice into the air and a corporal of the guard came running up.

TORONTO (CP)—Pickets at the strike-bound General Motors Corporation of Canada plant in Oshawa were criticized by their union leader Monday for turning back 300 office workers when they tried to enter the plant.

At that time, it was agreed of pickets workers and all other authorized personnel would be allowed through the picket lines without trouble.

Mr. Burt said the pickets' action in barricading the gates Monday may adversely affect talks aimed at settling the strike of 17,000 workers in GM's five Ontario plants, which started eight days ago.

The other plants are at Toronto, London, St. Catharines and Windsor.
