FATHER BURKE'S REJOINER.

SIR.—Let me say at the outset that, although so designated by you, the allusions I made to the press in my last were not "unnecessary," but, on the contrary, quite necessary to a proper understanding of the history and merits of the case at issue.

It will appear to every honest mind as a queer application of the doctrine of equal rights, that newspapers must be permitted to invade the sacred precincts of an Archbishop's jurisdiction and drag out before the public and misrepresent a mandate to his priests and by them to the faithful to be clearly explained, without running the risk of being called to account or even tenderly criticised for their action. To say that such papers cater to a "mixed community," and are anxious for the "maintenance of harmony" is certainly naive after offending one-half the community by the publication of an unjust attack upon one of its bishops and inflaming the other with anything but kindly feeling for the first. This style of justifying yourself and reproaching us is certainly disingenuous.

And upon the real question at issue you have shifted ground completely. This is not edifying. In your attack upon Archbishop Cleary you asserted, without qualification, that he had declared the marriages of non-Catholics "adulterous concubinage." This was the whole form and front of his offending. To such language, if used in the sense in which you understood it, you had every right to object; with the Archbishop's regulations for his people you have no right to meddle. Now, upon the proof furnished, you admit that you were wrong in ascribing to the Archbishop the sentiment held up to public execration. It were far better, then, to make an honest apology and allow the matter to rest than to raise a question altogether outside that in debate, and one, the discussion of which is not calculated to increase that harmony upon which you lavish such well deserved praise.

Because the marriage of baptized Protestants is a sacrament, and as such accepted by the Church, it does not at all follow that Catholics should be allowed to assist at such a marriage as a religious service for, in truth, it is not its being contracted in a Protestant church or before a minister that makes such marriage a sacrament; it would be equally sacramental wherever or before whomsoever contracted. The contracting parties are the ministers of the sacrament and the contract and sacrament are inseparable. But all the sacraments were conferred to the Church by her founder, Jesus Christ, and are only licitly received when she administers them. To permit her children to participate in the religious rites of the sects, as such, would be to recognize those sects and compromise the whole deposits of the faith. The universal law of the Church then is: No Catholic can communicate in sacred things—in Sacris—with outsiders; and hence, no demand of friendship, courtesy or patriotism can excuse a Catholic for disobeying this general law, such gross disobedience and attendance at formal non-Catholic religious services and ceremonies could be easily construed into a denial of the claim of the Catholic Church to profess the only faith and worship authorized by Jesus Christ—"He that loveth father and mother more than Me is not worthy of Me."

There can, therefore, be no religious exchange between Catholics and Protestants, even servants and reporters and others present at non-Catholic services in the discharge of duty must be there only as spectators, not as participants. In some places the attendance of Catholics at non-Catholic weddings and funerals seems to be tolerated by the Church, those functions being regarded as merely social ones; but just as soon as the bishop concerned speaks, as in Mgr. Cleary's case, those Catholics have nothing to do but obey. Indifferentism in religion is, therefore, none of the Catholic's creed. Still knowing just how far Catholics can go in those matters, and respecting their belief that there is but one true church and what necessarily follows from it, I cannot see why we should despair of true fraternity in our midst, or fail to give practical evidence of it.

The many friends of Mr. Samuel Hyde, of West River, will hear with regret that he was taken suddenly ill yesterday morning. Mr. Hyde was in town on Friday and Saturday, apparently in his usual health. He is about seventy years of age. It is hoped that his health will soon be fully restored.

It is stated that since Rev. B. Fay Mills, the well known evangelist, was affiliated in Boston with the Unitarian Church, in October, he has received no fewer than three thousand invitations to preach or deliver lectures in various parts of the United States and Canada. Dr. Edward Everett Hale, who presided at the Boston ceremonies, declared that Mr. Mills was today the most wonderful preacher in America, perhaps in the world; and another distinguished minister said he combined the genius of Beecher and the flamboyance of Talmage. Rev. Mr. Mills is forty years of age.

Senator T. R. McInnes, who has been appointed Lieutenant-Governor of British Columbia, was born at Lake Ainsley, Nova Scotia, Nov. 5, 1840. He attended Harvard University, subsequently taking his degree from Rush and Bennett Medical Colleges. He first practiced his profession in the County of Kent, Ont., but in 1874 went to New Westminster, British Columbia, since which time he has been a resident of that Province. He was twice elected Mayor of New Westminster, and in 1878 was elected to represent the city in the Federal Parliament. In 1882 he was appointed to the Senate.

In its page on "people talked about," the last issue of Leslie's Weekly presents a fine portrait and the following sketch of James Jeffrey Roche: "James Jeffrey Roche, the editor of the Pilot, is an American poet, fifty years of age, a native of Ireland and a citizen of Boston. He was reared on Prince Edward Island, and educated at St. Dunstan's college in that Canadian province. He went to Boston in 1866, made a reputation as a clever and versatile, literateur, and in 1883 joined his friend, John Boyle O'Reilly, on the staff of the Pilot, that stalwart pillar of Irish-American Catholicism. O'Reilly and Roche had much in common, being both of handsome, genial and convivial personality, and genuine poets. Roche's poetry is the lighter, but the more graceful and finished; and figures in all modern collections of vers de societe. His volume, Songs and Satires, was published in 1887. In 1890, upon the death of Mr. O'Reilly, Mr. Roche succeeded to the chief editorship of the Pilot, and also to the presidency of the Papyrus Club of Boston."

GOOD WORK.—The Schr. Mary P., Capt. Jas. Bevoit, from Barbadoes discharged her cargo here last Saturday after a good passage of 13 days from the West Indies. The captain reports that the market for P.E. Island produce was very low when he left. The schr. Mary P. has been trading between the West Indies and Charlottetown, carrying oats and horses for the last three years. During that time she carried 171 horses all of which the Mary P. safely landed. Her record for careful handling of freight is excellent, leaving here on the 7th September with a cargo of oats and horses and returning to Charlottetown from Barbado on the 19th inst. being absent from this port about six weeks.
