UNITED STATES.

LONG BRANCH, Sept. 14.

Official bulletin, 9 a. m.—At the examination of the President at 8.30, the temperature was 98.4, pulse 100, respiration 19. He passed the night comfortably, sleeping sufficiently. He is bright and cheerful, and has taken fruits and his first meal for the day with relief.

LONG BRANCH, Sept. 14.

The following was sent to-night:—

To Mr. Lowell, Minister, London:

There is an increase this evening in the President's temperature, pulse and respiration, but so light as not necessarily to indicate the condition of the blood producing any new complications. The trouble in the right lung is not increasing and is causing him less annoyance. He has taken adequate nourishment and sleep has been natural and refreshing, so if he has gained nothing, he has probably lost nothing during the day.

BOSTON, Sept. 14.

The indications are that the \$10,000 stallion race at Beacon Park, to-morrow, will attract an immense crowd of visitors. Probably only five horses will start—Piedmont, Santa Clara, Hannis, Voltaire and Wedgewood. Piedmont is a warm favorite in the pools to-night.

KANSAS CITY, Mo., Sept. 14.

A fire to-day destroyed the fair buildings and other property of the fair association. Loss, \$50,000.

CHICAGO, Sept. 14.

The total amount raised in Chicago for the sufferers by Michigan forest fires is \$7,000.

CINCINNATI, Sept. 14.

The Chamber of Commerce Committee has forwarded \$2,000 for the Michigan sufferers.

GREAT BRITAIN AND IRELAND.

LONDON, Sept. 14.

A meeting of the Committee of the Farmers' Alliances in London passed a resolution condemning the reciprocity and fair trade movement, and decided that if protection is restored agriculture will be the first to suffer.

A large meeting at Coventry passed resolutions in accordance with the views of the fair trade league.

The Secretary of the Manchester Cotton Spinners' Association states that nearly seven-eighths of the firms use American cotton have expressed a determination to stop the looms for one week.

A railway collision occurred at Patrick's Well, County Limerick, and fifty persons were injured.

DUBLIN, Sept. 14.

The subscriptions to the exhibition of Irish manufactures have reached £14,000.

EUROPE AND THE EAST.

LONDON, Sept. 14.

Advices have been received that a fearful typhoon has occurred at Shanghai, driving over 200 vessels of all nationalities on shore, uprooting trees and levelling whole lines of houses. During the storm, which lasted barely an hour, over ten inches of rain fell. Hundreds of native sampans sank with their occupants. About £600,000 worth of tea, stored for shipment, was washed away; and the best portion of the Saitors' Hons was blown away.

The Times says the British Commissioners go to Paris in a few days to resume negotiations for a treaty of commerce. We understand France will now concede to the point in regard to the prolongation of the existing treaty which was the immediate occasion of the suspension of negotiations.

LONDON, Sept. 14.

The race for the St. Leger stakes at Doncaster September meeting to-day was won by Iroquois, Geologist second, Lucy Glitters third. The latest betting in the race was 9 to 4 against Iroquois, 9 to 2 against St. Louis, 5 to 1 against Ishmael, 10 to 1 Scobell, and 10 to 1 against Limestone.

TUNIS, Sept. 14.

The Arabs have partially destroyed the aqueduct between Tunis and Zoghovan. The quantity of water now entering the town is decreasing at every moment, and it is probable the supply has been entirely cut off.

LONDON, Sept. 14.

A great sensation has been caused at Bristol by the discovery that a cargo of 300 tons of human bones is being discharged there to the order of a local firm engaged in manufacturing manure.

LONDON, Sept. 14.

Russian journals publish terrible details of ravages of diphtheria in Russia.

LONDON, Sept. 14.

Advices from the West Coast of Africa state that the King of Dahomey, with an army of Anazonas, had raided and destroyed the towns of Igano and Okepe, northwest of Abokonta. They had populations of many thousands, all of whom, unable to escape, were brought to Obomey, the capital of Dahomey, for sacrifice at the great annual custom.

SOPIA, Sept. 14.

In the celebration of his fete, Prince Alexander of Bulgaria signed decrees proclaiming full amnesty for all political crimes and offences committed before and after the 9th of May, the date of the Prince's famous proclamation.

LONDON, Sept. 14.

The Post understands that three hundred Russian nobles have organized themselves under the name of the Sacred Legion as a counter association to the Nihilist attempts on the life of the Czar.

Weather Bulletin.

Probabilities for the next 24 hours for the Maritime Provinces.

TORONTO, September 16—10 a. m.

Fresh to brisk easterly to north-easterly winds, fair weather.

Advices from Hong Kong state that typhoons have occurred in the China seas, and that many ships have suffered grievous damage and loss of life.

Geneva advices state that if the proposed revolutionary congress at Bern is conducted with moderation the local authorities will not interfere. The Federal Government has no jurisdiction in the matter.

A Horrible Story.

TOLD BY THE MAN WHO WAS SHOT ON THE YARMOUTH SHIP "MINNIE BURRILL."

(From the St. John Globe.)

The preliminary examination into the charge made by John Bateman, an articled seaman on the ship "Minnie Burrill," against Edwin L. Larkins and Charles L. Baker, the first and second mates of the same vessel, of shooting him with intent to kill and murder, was commenced in the Marine Hospital this afternoon, Bateman lying in bed while giving his testimony. The prisoners were present. Mr. Pugsley appeared for the Crown, and Mr. John Kerr for the prisoners. Bateman testified that while the barque was at Sydney, men were painting, and witness was lifting a ladder over her stern. It was heavy, and witness hurt his ribs. He stood it all day like that and till next morning. Witness was in bed next morning when the second mate came forward and called out "turn to." Witness was sick and could not "turn to," and laid in bed two and a half days. On the Saturday afternoon following he got up and the master came forward and asked him how he was getting on. Witness said,

"MY SIDE IS VERY SORE, SIR."

The mate went aft and brought some stuff up in a bottle and rubbed him on the side. About half an hour afterwards witness heard the captain had come on board, and then heard the first mate come forward and he said to witness "Captain wants you aft."

Witness asked "Did the doctor come on board?" He said "No; go aft in the room." Witness stopped a little in the fore-castle, and then the mate came again and said "Ain't you aft yet?" Soon afterwards he went aft, and the captain said "What is the matter with you?" Witness told him he was very sore in his side. Captain said

"TAKE YOUR CLOTHES AND GO INTO THE HOSPITAL ROOM."

and he said "you have got your days, I'm going to have mine. As soon as he heard this he went forward and was scared to go aft, not knowing what he was going to do with him. Witness remained forward, and after a while the mate and second mate came forward. Witness was inside the fore-castle sitting down. The mate said, "Did you come aft yet?" Witness said "No, sir," and got up at the same time. The man put his hands inside the fore-castle and got hold of the collar of witness's shirt and tore it down, at the same time trying to pull him outside of the fore-castle door. Witness cleared himself and got back and stood in the fore-castle. The mate put his hand in his pocket and pulled a pistol out. He pulled the trigger three times, but it didn't go off. The second mate was standing by and said

"SHALL I FIRE, SIR?"

As soon as witness heard that he walked to the other side of the fore-castle, looking all the time towards the door, and going away from them. The second mate put one foot inside the fore-castle door. He raised his arm and pointed a revolver, fired at him, aiming at his breast. Witness was about two yards from the second mate when the latter shot him. When the second mate asked "Will I shoot?" the first mate replied "Yes, shoot." Witness had nothing in his hand at the time, and only had his coat over his shoulder. The ball entered his breast and the blood came. The witness next described how the captain tried to choke him, how he was put in irons, and otherwise ill-treated. I saw blood coming out. I walked against the fore-castle door and the second mate continued to stand there and point the pistol. I told him "Don't you not fire," and I went on deck to go aft. The captain got hold of me and took me aft, feeling of my breast. I fell down on the deck. I was weak from blood coming out. I got up again, went aft and went inside the cabin. The captain shoved me inside the little room. I was singing out:—

"HELP ME SOMEBODY."

Nobody came and I knocked at the door. Somebody came to the door and said "What do you want?" I do not know who it was, I said: "Please let me out, don't let me die like this." I kept on knocking and the captain came to the door. He said: "If you don't shut up I will put you in irons." I asked him: "Will you be kind enough to help me if you please." The captain said "Die." I told him to let me die like this is a shame. I was singing out for help and continued to bleed all the while. The blood was coming out and they could see it. My shirt was down. I sang out help a good many times. The captain caught hold of my neck and choked me. I told him

"DON'T KILL ME LIKE THIS."

He ordered the mate to get the irons and put me in irons. They could not find a pair of irons big enough for me; two pairs were got; the last was big enough. The mate put them on and shoved me inside the room. After I went inside I sang out a couple of times for help. Nobody came to the door. I was sitting down still bleeding. I fell off asleep. None of them offered to dress my wound before this. I do not know how long I slept—about one hour or so. By-and-by I heard some one open the door. The mate told me to get up. I said "I can't get up." They helped me up and I walked inside the cabin. The doctor examined me and saw where I was shot. After a while he put me on the floor and dressed my wound. Since I came here Dr. Botsford has been attending me. I am still suffering from the wound; I am in awful pain and can't move. I asked the doctor and he said the ball had not been removed. I think it is there yet.

A Berne despatch says a land slip has occurred near the village of Elmin, canton of Glarus. Two hundred persons were killed and thirty houses destroyed.
