Business Men's Views.

A hardware dealer sententiously says:—"Men must pay and renewals must cease, or we shall never be right; renewals on renewals will ruin a Rothschild."
"Wait on us, wait a week, hold our note till the 1st of the month, and we will collect from the slow-paying farmers." ESTHER COX TO BE EXHIBITED.—After passing through an extraordinary career of mystery, Esther Cox is to be exhibited as a scientific phenomenon. Surely if her "visitations" have been an affliction, as it was affirmed, this last indignity ought not to be added. It is sufficient humiliation for humanity to endure the rhapsodies which are uttered as an assumed explanation of this girl's condition without pointing to her in public as being distinct from the rest of human kind. Besides, there are peculiarities in her case, if we hear the truth, which cannot be explained in a mixed audience. THE Anglicans of Toronto diocese find it no easy matter to elect a Bishop. A large majority of the clergy favor the High Church candidate, but it would seem that a decided majority of the laity have Low Church proclivities. The Blake brothers, both distinguished men, are casting the whole weight of their influence in behalf of the Low Church candidate. Twenty-three ballots have been taken without any definite result. The Montreal Herald expresses the opinion, as the result of the contest over the election of a Bishop in Toronto, that there will be a great schism, or the laity will have control of Church affairs.

THE Emperor of Germany made a great feast last week, at Berlin, in honor of Lord Dufferin, on his way to St. Petersburg as British Ambassador. Our gifted ex-Governor General may not be as fluent in German as he is in English, French, Latin and Greek, and may not have responded to toasts in his honor in the speech of the Fatherland. But the Emperor and most of his paladins understand English, and possibly Lord Dufferin gave the distinguished convivalists a specimen of his after-dinner oratory in his native language.

MR. DALTON MCCARTHY'S bill to make better provision for the trial of controverted elections, provides that such cases in New Brunswick, Nova Scotia and P. E. Island shall be tried by two Judges of the Supreme Court in each Province. The acceptance of an office of emolument under the Crown, or resignation, shall not stop proceedings, nor a prorogation nor a dissolution. Right of appeal to the Supreme Court is given.

Musical!

To the Editor of the Examiner:

DEAR SIR,—In yesterday's issue of the Patriot I observed a communication in answer to my letter, signed "Ginx,"—he should have added the word "Baby" to it. He goes on to say that my remarks were neither fair, dignified, nor calculated to do any good. Very likely they were too dignified for him. He will find that in the future my suggestions will be acted upon. My friend Mr. Fraser will look after that; he will not allow would-be musicians to perform trumpery little Galops that are been played to the sound of the tamborine and bones, in this city, by minstrels. A good Galop, brillante, is always well received at almost any concert; but the kind I alluded to I consider an insult to any audience, more especially to the members of the Zion Church, because they have a host of talent among their members. The part singing, as I said before, was all good; and most if not all the solos were well sung. It was the accompaniments and the instrumental music generally that I wrote so hard upon, and also the arrangement of the programme. I say it was revolting to my feelings to listen to it, especially the cornet leading the trebles in the choruses; there was no need of it where there were so many fine voices to sing them. He also says I will find very few who were present to agree with me. I can say that if all the people who were in that room that evening were to express their opinion, he would find all of them in favor of mine. Even the leader acknowledged that it was a fair criticism, indeed. This was candid. I admire him for it. I may state that "Ginx" had better practise the style of music in vogue at present. Had his ability been equal to his ignorance, the concert would have been a success. He also says my remarks of the use of the cornet and organ displayed a vast amount of real or pretended ignorance. I said no such thing. What I did say was that, if the leader, with an organ or piano accompaniment, could not keep a number of voices together, without a cornet, the sooner we give up part singing the better. If "Ginx" will refer to back numbers of some papers of a few days' date he will find that the advertisement reads "the best musical talent in the city have been engaged." At a concert called the concert of the season, readings should not have been on the programme, although the writer enjoyed them immensely, and hopes to hear them again at some entertainment. "Ginx" ought to admire and encourage those who strive to perform that class of music which he says only the best of professionals can hope to attain to any degree of excellence in. When "Ginx" went to school may I ask him how he would like to be kept in his A, B, C's for ever? Would he not like to go on a little further and keep pace with the rising generation? I am surprised at his ignorance. He also says that I dinned, with faint praise, everything the programme contained. I did no such thing. I gave a truthful account, and spoke well of most of the pieces on the programme. He says I was actuated by feelings of jealousy and envy. I cannot see it, especially when nearly all the ladies and gentlemen who took part that evening, I have the most unbounded respect for. Those penny whistle and tin trumpet men I ought to feel jealous of, because their well-known brilliant musical powers cannot, for one moment, be questioned.

In conclusion, Mr. Editor, he says my remarks will create a feeling of contempt. Not at all. My remarks have been approved of by every right-thinking person. Mr. Earle's Concerts in this city have always been well criticised, for the simple reason that they were well worth criticising. As the writer then stated, "Growler" considered the one alluded to worth criticising. He did it for the best of motives, and hopes to see an improvement next time. The Fishery Award.

THE Mail's Ottawa editor telegraphs that it is not likely that any satisfactory basis of settlement could be arrived at for a division of the fishery award between the provinces, and therefore it is unlikely that any such division will be made. Whatever else may be done for the provinces in consequence of the award, a division of the money is the least likely thing that will happen. It may not be amiss to suggest that as the Americans seem in some quarters determined to abrogate the treaty by notice at proper time, the interest of the whole sum may be required to put in force laws against encroachments, and to establish an efficient force for the protection of the fishing grounds. In view of that fact, the demands from the Maritime Provinces, if any are made, may be withdrawn, as their interests are deeply involved in the efficient protection of the fisheries in the absence of any treaty.
