**Miscellaneous Debates.**  
Mr. Moxon said the inhabitants of George-  
town had subscribed liberally towards paying  
the expense of extending the telegraph to that  
place, for they were told that if they would  
subscribe a certain amount towards it, the  
Government would carry out the work for  
them. All the people in that town subscribed  
something, and if the subscription was sent to  
proper authorities and let it only be paid  
not help it; but if the list were found be-  
lieved they would pay the amount subscribed  
in good faith. Some of the people paid the  
amounts subscribed by them although the list  
was not presented to them for payment, and  
others would not pay what they had prom-  
ised. He hoped that members would not  
think the amount voted was for Georgetown  
alone for many other parts of the country  
derive benefits from that telegraph. When  
the Supreme Court was held there this season,  
it was found very convenient to have tele-  
graphic communication between that place  
and Charlottetown, and that the Supreme  
Court could not have been brought to a sat-  
isfactory conclusion without it. If the list  
could be found, and the money paid, it could  
be refunded into the Treasury.  
Hon. Mr. HOWLAND said that there had been  
an arrangement with the London, New York  
and New England Telegraph Company, some  
time ago, in reference to telegraph lines to  
be set up on this Island. The Company  
agreed that if the Government would find the  
posts for any line they wished to construct  
on this Island, they (the Company) would find  
the wires. (Hon. Mr. H.) was sorry that the  
list for money for sending a message to  
Georgetown was so high. He thought the  
interests of the Company, who had a mono-  
poly of the business, demanded that the  
tariff should be lowered. The charge for  
messages to the Dominion is far too high.  
There is no reason why we should have to  
pay twenty-five cents for sending a message  
to a place on this Island, there is some-  
thing higher for sending a message across  
the Straits, because the laying of a cable costs  
much higher than running a line upon the  
land. He had been hoping that the Com-  
pany would, or this, have reduced the tariff  
for messages on this Island. When talking  
this matter over with some of its members,  
they stated that the great expense which  
had been incurred in laying and under-run-  
ning our cables across the Straits, compared  
them to put on an extra tariff, for messag-  
es to the continent; but (Hon. Mr. H.)  
thought that if the tariff were lessened, they  
would have greater results. Our telegraph  
lines require extending to Souris and Mon-  
tagne, and he would be willing to support the  
construction of a line upon the place, in the  
case of our Government obtained assist-  
ance from the Government in carrying the  
line to that place; that is, by the people's  
paying one-half the expense in procuring  
and setting down the posts. If the people  
of any part of the Island would pay one-half  
the expense, he would agree to support a  
line to complete the work for them. He  
thought by completing the work for them  
the Government would be saving a great deal  
of money, and would be able to give them  
a more satisfactory reply. The officers  
and men went to considerable expense  
in providing uniforms, and last much time  
at drill. And he could assure hon. mem-  
bers there was much dissatisfaction among  
the men respecting the use made of the  
money guaranteed for the service, but which  
was not distributed among the men. There  
was also an equal amount of dissatisfaction  
with regard to the time when they were  
called out to drill. If they had an oppor-  
tunity to learn anything probably the men  
would not be dissatisfied; but arranging  
them in a line, calling over their names,  
and then dismissing them, had so much of  
a farce about it, that men were beginning  
to look upon the whole affair as a sham.  
He hoped, however, if they were called out  
again, that it would be in a season of the  
year which might not so seriously interfere  
with the interests of the people, as had been  
the case hitherto.

**Volunteers.**  
Hon. B. DAVIS begged to say that several  
gentlemen connected with the Volunteer  
Service complained that while they were  
entitled to twenty shillings a year by statu-  
te for their services, they had not received  
anything. He understood that according  
to the regulations laid down for the service  
there were so many particular days named  
which they were required to attend drill,  
and no matter how many more days drill  
than the prescribed number they attend;  
yet, if they failed to be present on any of  
the days named, they received no pay.  
Some of these men were mechanics, and found  
it at times impossible to leave their ordinary  
employment, and regarded it as a great  
hardship to be so strictly dealt with. They  
also desired to receive their pay directly  
through the Government rather than their  
officers.  
Mr. Moxon was aware that money had  
been voted by the Legislature to the Volun-  
teer Service, but never knew of any being  
distributed among them. He knew his  
constituent might enquire what became of  
the money and would like to be able to  
give them a satisfactory reply. The offi-  
cers and men went to considerable expense  
in providing uniforms, and last much time  
at drill. And he could assure hon. mem-  
bers there was much dissatisfaction among  
the men respecting the use made of the  
money guaranteed for the service, but which  
was not distributed among the men. There  
was also an equal amount of dissatisfaction  
with regard to the time when they were  
called out to drill. If they had an oppor-  
tunity to learn anything probably the men  
would not be dissatisfied; but arranging  
them in a line, calling over their names,  
and then dismissing them, had so much of  
a farce about it, that men were beginning  
to look upon the whole affair as a sham.  
He hoped, however, if they were called out  
again, that it would be in a season of the  
year which might not so seriously interfere  
with the interests of the people, as had been  
the case hitherto.

**Mr. BIER thought if the Government**  
could not afford to grant more for the  
Service it would be better to let the whole  
affair be broken up. Any one who thought  
that a Colonel, four Majors, and nine Com-  
panies, consisting all to be of 450 men,  
could be offered and clothed. That the  
Militia could also be enrolled while the  
Volunteer was to receive twenty shillings  
each out of £1000 had given satisfaction  
to the matter. Why, the expense of the  
regiments of Militia, and the expense of  
equipping them, was considerable. Hon.  
members, nor the Government could not  
expect that the duties attending so exten-  
sive a Service could be met for the amount  
named. The Volunteers, men, clothed by  
the Government and that which they re-  
ceived, did well enough for warm weather,  
but was not sufficiently warm for winter.  
Each of them should be provided with an  
over coat. The Volunteers were required  
by the regulations of the Service, to attend  
sixteen drills on six consecutive days;  
and if they missed attending on any one of  
those days, they were not allowed the  
twenty shillings voted to each of them by  
the Legislature. This they complained of.  
Many causes over which a man had no con-  
trol might prevent his attendance on some  
particular occasion. As a general rule, the  
Volunteers attended thirty drills in the  
year, and thought such strictness towards  
such a service, was unfair, and unreason-  
able. He understood £116 had been re-  
tained to purchase new clothing for the  
Companies. The Volunteers saw no necessity  
for that, as the uniforms they had worn for  
two or three years yet; they would pre-  
fer that the money should be paid to them.  
The fact was if Volunteers were thus to be  
dealt with, they would to a man resign.

**Hon. LEADER OF THE GOVERNMENT**  
admitted the amount granted was £300 less  
than that of last year. It was thought not  
much benefit accrued to the country from  
the service. In looking, however, over the  
warrant was called in three weeks or so  
he got it, of which he was not aware for  
several months, and of course lost the in-  
terest.  
Hon. D. DAVIS approved of the prin-  
ciple of the Bill, said it would be inapprop-  
riate to name on the face of the warrant  
when it would be called in, but did not see  
thereof was always given in the Royal Ga-  
zette. The present treasurer was a good fit-  
tancer, and called in the warrants as speedily  
as possible, which was better than allow-
